

## Upcoming Northern Jefferson County Road Projects

### April 2008-Winter 2008

**Route 61/67 and Richardson:** Construct a second left and right turn lane on Richardson.

### Spring 2009

**I-55 at Route M Interchange:** Reconstruct interchange.

### May 2009

**Route 21 bridge over the Meramec River:** Asphalt bridge deck.

**Route 30 bridge over Saline Creek:** Eastbound and westbound bridge deck repairs and resurfacing.

### November 2009

**Route 30 bridge over Heads Creek:** Deck rehab on westbound lanes of bridge.

### To Be Determined

**I-55 from Lindbergh to south of Richardson Road:** Diamond grinding.

**Route 30 from Route PP to Route B:** Asphalt surfacing.

**Route MM Safety Improvements from Buckeye Valley to east of Geerdes:** Improve alignment, shoulders, turn lane, additions, guardrail, drainage, and sign installation.

**Route MM from Geerdes to Route 30 overlay:** Pavement treatment.

## Sen. McKenna's Legislation

### Sponsored Legislation

SB 771 - Would have created an income tax credit for contributions made to provide military personnel with armored protection.

SB 772 - Would have established a tax credit for recycling construction waste and directed the Department of Natural Resources to establish and administer construction and demolition waste reduction grants.

SB 940 - Would have modified laws affecting limited liability companies, limited partnerships, and nonprofit companies.

SB 1042 - Would have modified provisions relating to teacher and school employee retirement systems.

SB 1138 - (amended to House Bill 1549) Requires Occupational Safety and Health Administration training for employees on public works projects.

SJR 40 - Would have created, upon voter approval, a state-wide sales and use tax to fund the Missouri Highway Patrol.

### Co-Sponsored Legislation

SB 782 - (passed as a part of HB 2041) Reinstated federal standards for overtime wages.

SB 935 - (passed in companion bill HB 2224) Creates the "Deputy Sheriff Salary Supplementation Fund," consisting of money generated by an added \$10 fee collected for serving civil summons and subpoena.

SB 946 - Would have created the Tobacco Use Prevention, Cessation and Enforcement fund to supplement a comprehensive tobacco control program.

SB 1019 - Would have prohibited discrimination based upon a person's sexual orientation.

SB 1062 - Would have modified requirements for corporate filings.

SB 1091 - Would have required railroads to provide counseling services or other critical incident stress debriefing services to railroad employees involved in serious accidents.

SB 1217 - Would have submitted to the voters a one-cent sales tax proposal to assist in the reconstruction, rebuilding, and conversion of Interstate 70 and Interstate 44 into an eight-lane interstate system.

SB 1277 - Would have allowed electric and gas corporations to recover expenses for approved energy efficiency investments.

SJR 48 - Would have, upon voter approval, instituted a 1 percent sales and use tax for the purpose of converting Interstate 70 and Interstate 44 into an eight-lane interstate system.

### House Legislation Handled in Senate

HB 1784 - Requires any American or Missouri flag flown on state property to be manufactured in the United States.

HB 1450 - Extends the expiration date for the Joint Committee on Terrorism, Bioterrorism, and Homeland Security and the provisions regarding the Open Records and Meetings Law.

This session, the General Assembly passed a \$22.4 billion spending plan that includes specific appropriations for Northern Jefferson County.


