AN ACT

To repeal section 178.550, RSMo, and to enact in lieu thereof two new sections relating to career and technical education.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 178.550, RSMo, is repealed and two new sections

- 2 enacted in lieu thereof, to be known as sections 170.029 and 178.550, to read as
- 3 follows:

170.029. 1. The state board of education, in consultation with the

- 2 career and technical education advisory council as established in
- 3 section 178.550, shall establish minimum requirements for a career and
- 4 technical education (CTE) certificate that a student can earn in
- 5 addition to his or her high school graduation diploma. Students
- 6 entering high school in school year 2017-2018 and thereafter shall be
- 7 eligible to earn a CTE certificate.
- 8 2. The state board of education shall establish CTE requirements
- 9 intended to provide students with the necessary technical
- 10 employability skills to be prepared for an entry-level career in a
- 11 technical field or additional training in a technical field. The
- 12 provisions of this section shall not be considered a means for tracking
- 13 students in order to impel students to particular vocational, career, or
- 14 college paths. The state board of education shall work with local school
- 15 districts to ensure that tracking does not occur. For purposes of this

section, "tracking" means separating pupils by academic ability into 17 groups for all subjects or certain classes and curriculum.

- 3. Each local school district shall determine the curriculum, programs of study, and course offerings based on the needs and interests of the students in the district. As required by Missouri's state plan for career education and the Missouri school improvement program, the state board of education shall work in cooperation with individual school districts to stipulate the minimum number of CTE offerings. Each local school district shall strive to offer programs of study that are economically feasible for students in the district. In establishing CTE offerings, the district may rely on standards, technical coursework, and skills assessments developed for industry-recognized certificates or credentials.
- 4. No later than January 1, 2017, the department of elementary and secondary education shall develop a process for recognition of a school district's career and technical education program that offers a 32 career and technical education certificate.
- 33 5. The department of elementary and secondary education shall promulgate all necessary rules and regulations for the administration 34 of this section. Any rule or portion of a rule, as that term is defined in 35 section 536.010, that is created under the authority delegated in this 36 section shall become effective only if it complies with and is subject to 38 all of the provisions of chapter 536 and, if applicable, section 536.028. 39 This section and chapter 536 are nonseverable, and if any of the powers 40 vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are 41 subsequently held unconstitutional, then the grant of rulemaking 42authority and any rule proposed or adopted after August 28, 2016, shall be invalid and void.
 - 178.550. 1. This section shall be known and may be cited as the "Career and Technical Education Student Protection Act". There is hereby established the "Career and Technical Education Advisory Council" within the department of elementary and secondary education.
- 5 2. The advisory council shall be composed of [eleven] **fifteen** members who shall be Missouri residents [, appointed by the governor with the advice and consent of the senate]. The commissioner of education shall appoint the following members:

- 9 (1) A director or administrator of a career and technical education center;
- 10 (2) An individual from the business community with a background in
- 11 commerce;
- 12 (3) A representative from State Technical College of Missouri;
- 13 (4) Three current or retired career and technical education teachers who
- 14 also serve or served as an advisor to any of the nationally recognized career and
- 15 technical education student organizations of:
- 16 (a) DECA;
- 17 (b) Future Business Leaders of America (FBLA);
- 18 (c) FFA;
- 19 (d) Family, Career and Community Leaders of America (FCCLA);
- 20 (e) Health Occupations Students of America (HOSA);
- 21 (f) SkillsUSA; or
- 22 (g) Technology Student Association (TSA);
- 23 (5) A representative from a business organization, association of
- 24 businesses, or a business coalition;
- 25 (6) A representative from a Missouri community college;
- 26 (7) A representative from Southeast Missouri State University or the
- 27 University of Central Missouri;
- 28 (8) An individual participating in an apprenticeship recognized by the
- 29 department of labor and industrial relations or approved by the United States
- 30 Department of Labor's Office of Apprenticeship;
- 31 (9) A school administrator or school superintendent of a school that offers
- 32 career and technical education.
- 33 3. Members shall serve a term of five years except for the initial
- 34 appointments, which shall be for the following lengths:
- 35 (1) One member shall be appointed for a term of one year;
- 36 (2) Two members shall be appointed for a term of two years;
- 37 (3) Two members shall be appointed for a term of three years;
- 38 (4) Three members shall be appointed for a term of four years;
- 39 (5) Three members shall be appointed for a term of five years.
- 40 4. Four members shall be from the general assembly. The
- 41 president pro tempore of the senate shall appoint two members of the
- 42 senate of whom not more than one shall be of the same party. The
- 43 speaker of the house of representatives shall appoint two members of
- 44 the house of representatives of whom not more than one shall be of the

- 45 same party. The legislative members shall serve on the advisory council until such time as they resign, are no longer members of the 46 47 general assembly, or are replaced by new appointments.
 - **5.** The advisory council shall have three nonvoting ex officio members:
- (1) A director of guidance and counseling services at the department of 49 elementary and secondary education, or a similar position if such position ceases 50 51 to exist;
- 52 (2) The director of the division of workforce development; and
- 53 (3) A member of the coordinating board for higher education, as selected by the coordinating board. 54
- [5.] 6. The assistant commissioner for the office of college and career 55 readiness of the department of elementary and secondary education shall provide 57 staff assistance to the advisory council.
- [6.] 7. The advisory council shall meet at least four times annually. The advisory council may make all rules it deems necessary to enable it to conduct its 59 meetings, elect its officers, and set the terms and duties of its officers. The advisory council shall elect from among its members a chairperson, vice 62 chairperson, a secretary-reporter, and such other officers as it deems necessary. Members of the advisory council shall serve without compensation but 63 may be reimbursed for actual expenses necessary to the performance of their official duties for the advisory council.
- [7.] 8. Any business to come before the advisory council shall be available on the advisory council's internet website at least seven business days prior to the start of each meeting. All records of any decisions, votes, exhibits, or outcomes shall be available on the advisory council's internet website within forty-eight 70 hours following the conclusion of every meeting. Any materials prepared for the members shall be delivered to the members at least five days before the meeting, 72and to the extent such materials are public records as defined in section 610.010 and are not permitted to be closed under section 610.021, shall be made available on the advisory council's internet website at least five business days in advance of the meeting.
- 76 [8.] 9. The advisory council shall make an annual written report to the state board of education and the commissioner of education regarding the 77 development, implementation, and administration of the state budget for career 78 79 and technical education.
- 80 [9.] **10.** The advisory council shall annually submit written

- 81 recommendations to the state board of education and the commissioner of 82 education regarding the oversight and procedures for the handling of funds for 83 student career and technical education organizations.
 - [10.] **11.** The advisory council shall:
- 85 (1) Develop a comprehensive statewide short- and long-range strategic 86 plan for career and technical education;
- 87 (2) Identify service gaps and provide advice on methods to close such gaps 88 as they relate to youth and adult employees, workforce development, and 89 employers on training needs;
- 90 (3) Confer with public and private entities for the purpose of promoting 91 and improving career and technical education;
- 92 (4) Identify legislative recommendations to improve career and technical 93 education;
- 94 (5) Promote coordination of existing career and technical education 95 programs;
- 96 (6) Adopt, alter, or repeal by its own bylaws, rules and regulations 97 governing the manner in which its business may be transacted.
- 98 [11.] **12.** For purposes of this section, the department of elementary and 99 secondary education shall provide such documentation and information as to 100 allow the advisory council to be effective.
- 101 [12.] 13. For purposes of this section, "advisory council" shall mean the 102 career and technical education advisory council.
