Amend SA to SS/Senate Bill No. 575, Page 4, Section 1, Line 23,

2 by inserting after all of said line the following:

3 "7. (1) Not later than five hundred forty days after the
 4 effective date of this section, the labor and industrial
 5 relations commission shall prepare and submit to the general
 6 assembly a report assessing:

7 (a) The presence of asbestos in residential, commercial,
 8 industrial, public, and school buildings; and

9 (b) The extent of exposure and risk to human health
 10 associated with the asbestos present in those buildings from all
 11 commercial, industrial, and consumer activities that may result
 12 in asbestos exposure.

13 (2) The report required under this subsection shall
 14 additionally:

15 (a) Be based on the best available information, and
 16 information that can feasibly be obtained through surveys or
 17 other means; and

18 (b) Provide the following:

19 a. An estimate of the number of residential, commercial,
 20 industrial, public, and school buildings in Missouri where
 21 asbestos is present;

1 b. An estimate of the quantity of asbestos in those
2 buildings and the portion of that asbestos that is friable;

3 c. A description of the types of building components and
4 systems containing asbestos in those buildings and the categories
5 of mixtures and articles containing asbestos that are present,
6 such as thermal insulation, roofing materials, asbestos cement
7 pipe, and asbestos cement sheet;

8 d. For each category of building, an estimate of the number
9 of people potentially exposed to asbestos, the conditions and
10 activities with the greatest potential for exposure, and
11 estimates of the levels of exposure;

12 e. A description of the role of handling, maintenance, and
13 construction practices in creating exposure to asbestos and the
14 impact of building aging on the potential for asbestos exposure;

15 f. An estimate of the quantity of asbestos waste generated
16 from building renovation, repair, and demolition for each of the
17 five calendar years preceding the date of submission of the
18 report, and the procedures that are used for the handling,
19 transport, and disposal of that waste;

20 g. An assessment of the sufficiency of existing statutes,
21 regulations, policies, and programs implemented by state agencies
22 in protecting against exposures to legacy asbestos; and

23 h. Recommendations for modifications or additions to those
24 statutes, regulations, policies, and programs as necessary to
25 reduce or eliminate risks to human health, including: the
26 inspection of buildings to determine the presence and condition
27 of asbestos; inventorying the presence and condition of asbestos
28 in buildings; the abatement or removal of asbestos from
29 buildings; handling asbestos during building maintenance, repair,

1 demolition, and other commercial and industrial activities with
2 the potential for asbestos exposure; and disposal of
3 asbestos-containing waste and debris."; and

4 Further renumber the remaining subsection accordingly.
