566.067	359	Reinserts a provision prohibiting probation, parole, or conditional release for those found guilty of first degree child molestation.	
566.125	366-369	Removes date limitations in a provision providing enhanced sentences for repeat sex offenders and keeps the reference to "sexual abuse when classified as a class B felony" rather than sexual abuse in the first degree.	Want to ensure that crimes count toward the repeat offender enhancement even though the names of the crimes have changed.

568.030	388	Does not lower the penalty of first degree abandonment of a child to a class C felony. Makes it a class A felony if the child dies.
