- 1. The rule is required by section 558.041, RSMo, which was amended last year. The rule will be amended to be consistent with the statute.
- 2. The rule is required by section 536.023.3, RSMo. The rule needs to be updated to reflect the current organization of the division of adult institutions.
- 3. The rule is not obsolete, but the department does not engage in the discretionary practice described by the rule. The department is considering whether the rule should be rescinded.
- 4. On August 28, 2018, House Bill 1355 will amend statutes governing the probation and parole function of the Department of Corrections. The Board of Probation and Parole will be renamed as the parole board, and a new division known as the Division of Probation and Parole will be established. All the rules in division 80 of title 14 will need to be amended after August 28, 2018 to reflect these organizational changes.
- 5. For all negative responses in this column, "No" means that the rule does not incorporate any material by reference.
- 6. According to the agency designee who was identified in the *Missouri Register* (July 3, 2017), the department did not receive any comments during the 60-day public comment period.
