The Department of Elementary and Secondary Education (department) received sixteen (16) comments from eleven (11) teachers: Meredith Wisniewski, Crystal Koenig, Nancy Kowalczyk, Tamara MacLean, Ruthie Caplinger, Ginger Beaird, Beth Winton, Maureen Hoeft, Holly Graves, Victoria Vandeveer-Lehr, Carolyn Holmes, from four (4) Teachers/Parents 1-4, and one (1) from Parent 1 recommending that the regulation be changed to add a section on professional development for all teachers addressing the nature and needs of gifted students and designing curriculum and instruction to meet those needs.

RESPONSE:

Thank you for your comments regarding the Office of Quality School's (OQS's) regulation 5 CSR 20-100.110. Missouri School Improvement Program 5 (MSIP 5) standard TL-1 states, "[p]rofessional learning drives and supports instructional practices in the district and leads to improved student learning." As we transition to Missouri School Improvement Program 6 (MSIP 6), TL8 states, "[p]rofessional learning activities support effective instructional practices in the school system." Indicator A focuses on all instructional staff participating in scheduled, ongoing, job-embedded, and content-appropriate professional learning and Indicator B states that the school system will provide time and resources for the professional learning of each staff member. Furthermore, TL7 states, "[t]he school system provides a comprehensive multi-tiered system of support that address the academic, emotional, behavioral, social, and physical needs of each student." Educators will be participating in professional learning, which will address the nature and needs of gifted students. The Department of Elementary and Secondary Education (department) does not plan to make any changes to this rule based on this comment.

COMMENT #2

5 CSR 20-100.110 - Programs for Gifted Children.

The department received sixteen (16) comments from eleven (11) teachers: Meredith Wisniewski, Crystal Koenig, Nancy Kowalczyk, Tamara MacLean, Ruthie Caplinger, Ginger Beaird, Beth Winton, Maureen Hoeft, Holly Graves, Victoria Vandeveer-Lehr, Carolyn Holmes, from four (4) Teachers/Parents 1-4, and one (1) from Parent 1 recommending that the regulation be changed to add a section on professional development for gifted certified teachers so that inservice gifted education specialists remain up-to-date on trends and research in the field of gifted education.

RESPONSE:

Thank you for your comments regarding OQS's regulation 5 CSR 20-100.110. MSIP-5 standard TL-1 states, "Professional learning drives and supports instructional practices in the district and leads to improved student learning." As we transition to MSIP-6, TL8 states, "[p]rofessional learning activities support effective instructional practices in the school system." Indicator A focuses on all instructional staff participating in scheduled, ongoing, job-embedded, and content-

appropriate professional learning and Indicator B states that the school system will provide time and resources for the professional learning of each staff member. Furthermore, TL7 states, "[t]he school system provides a comprehensive multi-tiered system of support that address the academic, emotional, behavioral, social, and physical needs of each student." Gifted education specialists will be participating in professional learning to remain up-to-date on evidence-based practices. The department does not plan to make any changes to this rule based on this comment.

COMMENT #3

5 CSR 20-100.110 - Programs for Gifted Children.

The department received one (1) comment from Bettina Groh, "[a]ll personnel that are part of a district's gifted education program should have certification in this field."

RESPONSE:

Thank you for your comment regarding OQS's regulation 5 CSR 20-100.110. The current rule states in section (5), "[i]nstructional personnel in the program for gifted students shall possess the appropriate certification for the gifted program service they are providing."

Therefore, the department does not plan to make any changes to this rule based on this comment.

COMMENT #4

5 CSR 20-100.110 – Programs for Gifted Children.

The department received one (1) comment from Bettina Groh "[a]ll programs should have guidelines to adequately determine which child qualifies as gifted that minimize cultural and poverty biases."

RESPONSE:

Thank you for your comment regarding OQS's regulation 5 CSR 20-100.110. Your suggestion for new gifted qualification guidelines that minimize cultural and racial biases is appreciated and will be taken into consideration for any future amendments.

COMMENT #5

5 CSR 20-100.110 – Programs for Gifted Children.

The department received one (1) comment from Tina Sudkamp, teacher. Ms. Sudkamp's comment supported evidence based, state approved gifted programs and said that the programs provide both academic and social-emotional support. The comment said, "[s]chools need to both have these essential classes for students and provide professional development for the teachers."

RESPONSE:

Thank you for your comment regarding OQS's regulation 5 CSR 20-100.110. We appreciate your support of evidence-based, state approved gifted programs.

COMMENT #6

5 CSR 20-100.110 – Programs for Gifted Children.

The department received one (1) comment from Amanda Sauerwein, a teacher, who recommended adding subsection (D) to section (4) "gifted programs should provide general classroom differentiation or support/collaboration with the general faculty to provide for gifted students' needs."

RESPONSE:

Thank you for your comment regarding OQS's regulation 5 CSR 20-100.110. The MSIP 5 standard on Instruction states, "I-1—Instructional staff routinely provide effective instruction

designed to meet the needs of all learners" and Indicator 2 states, "[i]nstruction is routinely differentiated to address the needs of all students." MSIP 6 Teaching and Learning standard 7 states, "[t]he school system provides a comprehensive multi-tiered system of support that addresses the academic, emotional, behavioral, social, and physical needs of each student." Furthermore, teacher collaboration is addressed in MSIP 5 and MSIP 6. MSIP 5 TL-2 Indicator 6 states, "[s]chool-based collaborative teams are in place and focus on data informed decision-making." In MSIP 6, Collaborative Teams are described as part of Data-Based Decision Making. Because the MSIP standards support classroom differentiation and collaboration, the department does not plan to make any changes to the rule based on this comment.

COMMENT #7

5 CSR 20-100.120 - Advanced Placement and International Baccalaureate Fee Payment Programs (Rescinded June 30, 2019)

Amanda Sauerwein, a teacher, commented that the rule should be de-rescinded to support low SES [socioeconomic status] students and to support equity. The commenter asserts that keeping this rule may support the acquisition of funding from other sources.

RESPONSE:

Thank you for your comment regarding OQS's regulation 5 CSR 20-100.120. The rule enabled administration of state-funded programs. The state has not funded these fees for four (4) years. If a rule is needed for the administration of similar federal funding sources, one will be proposed. The department respectfully declines to re-promulgate this rule.

COMMENT #8

5 CSR 20-100.125 - Missouri School Improvement Program 6

The department received one (1) comment from Phyllis Pasley, Executive Director of the Missouri Alliance for Arts Education, for Standard TL1, Indicator D, that some students are not adequately prepared for collegiate and workplace success in the arts. Missouri Alliance for Arts Education recognizes that the collaborative leadership model supported by the department (TL2.6) would allow fine arts teachers to provide assistance to guidance counselors and others responsible for implementing the development of Individual Career Academic Plans (ICAP). With collaborative involvement of the fine arts educator the Missouri Alliance for Arts Education suggests that the students who are our future fine arts teachers and creative workers would be better prepared for the next level of training required for workplace success.

RESPONSE:

Thank you for your comment regarding OQS's regulation 5 CSR 20-100.125, Standard TL1, Indicator D. The department does not plan to make any changes to the rule based on this comment.

COMMENT #9

5 CSR 20-100.125 - Missouri School Improvement Program 6

The department received one (1) comment from the Missouri Alliance for Arts Education for Standard TL1, Indicator E, indicating that participation in fine arts classes and activities allow middle school students ongoing opportunities to demonstrate collaboration, leadership, and communication skills. Fine arts instruction is at the intersection of curricular, co-curricular, extra-curricular, and community-based activities, including service learning.

RESPONSE:

Thank you for your comment regarding OQS's regulation 5 CSR 20-100.125, Standard TL1, Indicator E. The department does not plan to make any changes to the rule based on this comment.

COMMENT #10

5 CSR 20-100.125 - Missouri School Improvement Program 6

The department received one (1) comment for Standard TL1, Indicator H, from Phyllis Pasley, Executive Director of the Missouri Alliance for Arts Education, that Indicator H be modified to include other criteria-based seals in the measurement of this standard.

RESPONSE:

MSIP 6 Standard TL12 does not indicate the number of minutes of instruction that are required for any content area.

COMMENT #21

The department received one (1) comment from Phyllis Pasley, Executive Director of the Missouri Alliance for Arts Education, who commented in support of retaining instruction in the arts at the middle school level and for an increase in the recommended number of minutes.

RESPONSE:

Thank you for your comment regarding OQS's regulation 5 CSR 20-100.255. The department will retain the recommendation for instruction in the arts in middle school. The department respectfully declines to make a change to the recommended number of minutes in this rule.

COMMENT #22

5 CSR 20-400.330 - Clinical Experience Requirements for Candidates in Professional Education Programs

The department received one (1) comment from Phyllis Pasley, Executive Director of the Missouri Alliance for Arts Education, who stated that high-quality arts education experiences require significant pedagogical training and teaching strategies learned through collegiate level music education methods courses. The presence of the phrase "closely allied field of the desired certificate" is a cause for concern. Arts educators receive specific training and teaching strategies to afford them success in the classroom. Bypassing this essential training means that these teachers may not have the skills necessary to successfully implement the Missouri Learning Standards in Fine Arts.

Thank you for your comment regarding the Office of Educator Quality's (OEQ's) regulation 5 CSR 20-400.330. The text (above) does not appear in 5 CSR 20-400.330; instead, it was contained in 5 CSR 20-400.320, which was rescinded by State Board of Education, effective October 30, 2020.

COMMENT #23

5 CSR 20-400.500 Application for Certificate of License to Teach

The department received one (1) comment from Phyllis Pasley, Executive Director of the Missouri Alliance for Arts Education, who stated that the Missouri Alliance for Arts Education is committed to promoting high quality arts education. This requires essential training often not provided in the pursuit of other degrees. High-quality arts education experiences require the effective implementation of distinctive pedagogical strategies learned through collegiate-level music education methods courses. Teaching methods for the general classroom teacher may not be adequate for teaching fine arts and implementation of the Missouri Learning Standards in Fine Arts.

RESPONSE:

Thank you for your comment regarding OEQ's regulation 5 CSR 20-400.500. The department has determined that the requirements stated in the rule above are adequate, appropriate, and consistent with other certification subject areas. The department does not plan to make any changes to this rule based on this comment.

COMMENT #24

5 CSR 20-400.550 Certification Requirements for Teacher of K-12 Education

The department received one (1) comment from Phyllis Pasley, Executive Director of the Missouri Alliance for Arts Education, who stated that her organization believes the department should consider expanding the areas of certification in Missouri to include "PreK" instead of merely "K" in defining the grade/age groups for certification for music and other fine arts. The organization further suggests that the department consider certification areas of **PreK-12 Vocal**,

PreK-12 Instrumental, PreK-12 Music (incorporating both vocal and instrumental music), and PreK-8 General Music.

Thank you for your comment regarding OEQ's regulation 5 CSR 20-400.550. The department has determined that the requirements stated in the rule above are adequate, appropriate, and consistent with other certification subject areas. The department does not plan to make any changes to the rule based on this comment.

COMMENT #25

5 CSR 100-200.010 General Organization

The department received one (1) comment from Parent 2 that an "[o]versight committee should be established to practice regular reviews of Deaf children attending Public Schools and whether the practices of these schools are fair and equal treatment of the Deaf and Hard of Hearing." Parent 2 believes that "Form G [Special Education Distanced Learning Plan form] has provided the schools with special needs to violate current IEP compliance standards and allowed a blame to fall on DESE." Parent 2 states, "[v]irtual Learning will NOT be provided nor communicated to the participants of these kiddos in reference to Speech and Language allotted minutes if the Speech or Language Teacher elects to not participate in the Virtual Learning."

RESPONSE: Thank you for your comment regarding the Missouri Commission for the Deaf and Hard of Hearing's regulation 5 CSR 100-200.010. The comment does not address any of the administrative rules for the Missouri Commission for the Deaf and Hard of Hearing, Board for Certification of Interpreters.
