\$37 Million in Improvements to Bollinger, Cape Girardeau, Madison, Mississippi, Perry and Scott counties

SIKESTON – Senator Jason Crowell today announced approved projects that will bring more than \$37 million worth of improvements to roads in Bollinger, Cape Girardeau, Madison, Mississippi, Perry and Scott counties. The Apex Paving Company of Cape Girardeau was awarded more than \$3.6 million in contracts for resurfacing projects in the area.

"The total amount of improvement to Southeast Missouri is \$65 million, which is significant to the many from the area that commute to work each day."

The projects are a direct result of additional money from the recent passage of Amendment 3, which passed overwhelmingly and last Falls election.
