AN ACT

To repeal section 169.560, RSMo, and to enact in lieu thereof one new section relating to employment of retirees of the public school retirement system.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 169.560, RSMo, is repealed and one new section
2 enacted in lieu thereof, to be known as section 169.560, to read as follows:

169.560. 1. Any person retired and currently receiving a retirement
2 allowance pursuant to sections 169.010 to 169.141, other than for disability, may
3 be employed in any capacity in a district included in the retirement system
4 created by those sections on either a part-time or temporary-substitute basis not
5 to exceed a total of five hundred fifty hours in any one school year, and through
6 such employment may earn up to fifty percent of the annual compensation
7 payable under the employing district's salary schedule for the position or
8 positions filled by the retiree, given such person's level of experience and
9 education, without a discontinuance of the person's retirement allowance. If the
10 employing school district does not utilize a salary schedule, or if the position in
11 question is not subject to the employing district's salary schedule, a retiree
12 employed in accordance with the provisions of this [section] **subsection** may
13 earn up to fifty percent of the annual compensation paid to the person or persons
14 who last held such position or positions. If the position or positions did not
15 previously exist, the compensation limit shall be determined in accordance with
16 rules duly adopted by the board of trustees of the retirement system; provided
17 that, it shall not exceed fifty percent of the annual compensation payable for the
18 position in the employing school district that is most comparable to the position
19 filled by the retiree. In any case where a retiree fills more than one position

20 during the school year, the fifty-percent limit on permitted earning shall be based
21 solely on the annual compensation of the highest paid position occupied by the
22 retiree for at least one-fifth of the total hours worked during the year. Such a
23 person shall not contribute to the retirement system or to the public education
24 employee retirement system established by sections 169.600 to 169.715 because
25 of earnings during such period of employment. If such a person is employed in
26 any capacity by such a district on a regular, full-time basis, the person shall not
27 be eligible to receive the person's retirement allowance for any month during
28 which the person is so employed and shall contribute to the retirement system.

29 **2. Any person retired and currently receiving a retirement**
30 **allowance pursuant to sections 169.010 to 169.141, other than for**
31 **disability, may be employed in a district included in the retirement**
32 **system created by those sections in a certified staff position paid on the**
33 **regular teachers' salary schedule on either a part-time or temporary-**
34 **substitute basis for more than five hundred fifty hours but not to**
35 **exceed a total of eight hundred hours in any one school year, and**
36 **through such employment may earn up to seventy-five percent of the**
37 **annual compensation payable under the employing district's salary**
38 **schedule for the position or positions filled by the retiree, given such**
39 **person's level of experience and education, without a discontinuance**
40 **of the person's retirement allowance. If the position or positions did**
41 **not previously exist, the compensation limit shall be determined in**
42 **accordance with rules duly adopted by the board of trustees of the**
43 **retirement system; provided that, it shall not exceed seventy-five**
44 **percent of the annual compensation payable for the position in the**
45 **employing school district that is most comparable to the position filled**
46 **by the retiree. In any case where a retiree fills more than one position**
47 **during the school year, the seventy-five-percent limit on permitted**
48 **earning shall be based solely on the annual compensation of the highest**
49 **paid position occupied by the retiree for at least one-fifth of the total**
50 **hours worked during the year. Such a person shall not contribute to**
51 **the retirement system because of earnings during such period of**
52 **employment, and the district shall contribute to the retirement system**
53 **on the basis of such earnings at the percentage rate established**
54 **pursuant to this chapter for full-time employees of the retirement**
55 **system. Such a person shall not accrue service credit upon the basis of**
56 **employment authorized pursuant to this subsection. If such a person**

57 is employed in any capacity by such a district on a regular, full-time
58 basis, the person shall not be eligible to receive the person's retirement
59 allowance for any month during which the person is so employed and
60 shall contribute to the retirement system.
