AN ACT

To repeal section 170.015, RSMo, and to enact in lieu thereof one new section relating to the teaching of sex education in the public schools.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 170.015, RSMo, is repealed and one new section 2 enacted in lieu thereof, to be known as section 170.015, to read as follows:

170.015. 1. Any course materials and instruction relating to human 2 sexuality and sexually transmitted diseases shall be medically and factually 3 accurate and shall:

- 4 (1) Present abstinence from sexual activity as the preferred choice of 5 behavior in relation to all sexual activity for unmarried pupils because it is the
- 6 only method that is one hundred percent effective in preventing pregnancy,
- 7 sexually transmitted diseases and the emotional trauma associated with
- 8 adolescent sexual activity, and advise students that teenage sexual activity places
- 9 them at a higher risk of dropping out of school because of the consequences of
- 10 sexually transmitted diseases and unplanned pregnancy;
- 11 (2) Stress that sexually transmitted diseases are serious, possible, health
- 12 hazards of sexual activity. Pupils shall be provided with the latest medical
- 13 information regarding exposure to human immunodeficiency virus, acquired
- 14 immune deficiency syndrome (AIDS), human papilloma virus, hepatitis and other
- 15 sexually transmitted diseases;
- 16 (3) [Present] Inform students [with the latest] that medically
- 17 [factual] and personally relevant information regarding [both the possible
- 18 side effects and health benefits of all forms of contraception, including the success

and failure rates for the prevention of pregnancy and sexually transmitted diseases] contraception, abortion, and pregnancy may be available from their previously designated family practitioner under section 167.611,

- (4) Include a discussion of the possible emotional and psychological consequences of preadolescent and adolescent sexual activity and the consequences of adolescent pregnancy, as well as the advantages of adoption, including the adoption of special needs children, and the processes involved in making an adoption plan;
- 28 (5) Teach skills of conflict management, personal responsibility and 29 positive self-esteem through discussion and role-playing at appropriate grade levels to emphasize that the pupil has the power to control personal 30 behavior. Pupils shall be encouraged to base their actions on reasoning, 31 self-discipline, sense of responsibility, self-control, and ethical considerations, 32 such as respect for one's self and others. Pupils shall be taught not to make 33 unwanted physical and verbal sexual advances or otherwise exploit another 3435 person. Pupils shall be taught to resist unwanted sexual advances and other 36 negative peer pressure;
 - (6) Advise pupils of the laws pertaining to their financial responsibility to children born in and out of wedlock and advise pupils of the provisions of chapter 566, RSMo, pertaining to statutory rape.
- 2. Policies concerning referrals and parental notification regarding contraception shall be determined by local school boards or charter schools, consistent with the provisions of section 167.611, RSMo.
 - 3. A school district **or charter school** which provides human sexuality instruction may separate students according to gender for instructional purposes.
- 4. The board of a school district **or charter school** shall determine the specific content of the district's **or school's** instruction in human sexuality, in accordance with subsections 1 to 3 of this section, and shall ensure that all instruction in human sexuality is appropriate to the age of the students receiving such instruction.
 - 5. A school district **or charter school** shall notify the parent or legal guardian of each student enrolled in the district **or school** of:
- 52 (1) The basic content of the district's **or school's** human sexuality 53 instruction to be provided to the student; and
- 54 (2) The parent's right to remove the student from any part of the district's

or school's human sexuality instruction. 55

- 56 6. A school district or charter school shall make all curriculum materials used in the district's or school's human sexuality instruction available 57 for public inspection pursuant to chapter 610, RSMo, as well as provide the 58 names of the instructors and the instructors' affiliations to any entities 59 60 involved with human sexuality instruction, at least one week prior to the use of such materials in actual instruction or presentations by such 61 62 instructors.
- 63 7. No school district or charter school shall permit a person or entity to offer, sponsor, or furnish in any manner any course materials 64or instruction relating to human sexuality or sexually transmitted diseases to its students if such person or entity is a provider of abortion services.
 - 8. As used in this section, the term "abortion services" means:
- 69 (1) Performing, inducing, or assisting in the performing or 70 inducing of an abortion;
- (2) Encouraging a patient to have an abortion or referring a 71 patient for an abortion; or
 - (3) Developing or dispensing drugs, chemicals, or devices intended to be used to induce an abortion, which is not necessary to save the life of the mother, and the term "abortion" means the same as defined in section 188.015, RSMo.
