AN ACT

To authorize the conveyance of certain state properties, with an emergency clause.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section 1. 1. The governor is hereby authorized and empowered
2 to sell, transfer, grant, convey, remise, release and forever quitclaim all
3 interest of the state of Missouri in real property known as Midtown
4 State Office Building, St. Louis, Missouri, more particularly described
5 as follows:

6 "PARCEL No. 1" IN CITY BLOCK 1059
7 ST. LOUIS, MISSOURI

8 A parcel of ground in Block 1059, of the City of St. Louis,
9 Missouri, including all of Lots A, B & C, and part of Lots 8,
10 7, 6, 5 & 4; said parcel being more particularly described
11 as follows:

12 COMMENCING at the point of intersection of the south line
13 of Olive Street, 60 feet wide, with the east line of Grand
14 Boulevard, 80 feet wide; Thence South 60 degrees 30
15 minutes West 160.00 feet, along the south line of said Olive
16 Street, to the west line of said Lot C, and being the point

17 of BEGINNING of the parcel herein described; Thence
18 South 60 degrees 30 minutes East 159.84 feet, along the
19 south line of said Olive Street, to an angle point therein;
20 Thence South 60 degrees 38 minutes 07 seconds East 221.23
21 feet, along the south line of said Olive Street, to a line
22 distant 18.00 feet east of and parallel with the west line of
23 said Lot 4; Thence South 29 degrees 21 minutes 53 seconds
24 West 88.25 feet, along said line parallel with the west line
25 of said Lot 4, to the centerline of the former Alley, 10 feet
26 wide, in said Block, Vacated by Ordinance 64807; Thence
27 North 68 degrees 12 minutes 09 seconds West 86.98 feet,
28 along the centerline of said former Alley; Thence South 16
29 degrees 14 minutes 50 seconds West 57.10 feet, to the north
30 line of Lindell Boulevard, 100 feet wide; Thence North 75
31 degrees 00 minutes 25 seconds West 56.21 feet, along the
32 north line of said Lindell Boulevard, to an angle point
33 therein; Thence North 76 degrees 17 minutes 40 seconds
34 West 233.92 feet, along the north line of said Lindell
35 Boulevard, to a point distant South 76 degrees 17 minutes
36 40 seconds East 186.17 feet, from its intersection with the
37 east line of said Grand Boulevard; Thence North 14 degrees
38 59 minutes 20 seconds East 72.53 feet, to the south line of
39 the former Alley, 15 feet wide, in said Block, Vacated by
40 Ordinance 58135; Thence North 5 degrees 00 minutes 21
41 seconds West 18.20 feet, to the point of intersection of the
42 north line the last said Vacated Alley, with the west line of
43 the aforesaid Lot C; Thence North 29 degrees 25 minutes 40
44 seconds East 147.50 feet, along the west line of said Lot, C
45 to the south line of said Olive Street and the point of
46 beginning and containing 65,683 Square Feet or 1.5079
47 Acres.

48 "PARCEL No. 2" IN CITY BLOCK 1060

49 ST. LOUIS, MISSOURI

50 A parcel of ground in Block 1060, of the City of St. Louis,
51 Missouri, being all of Lots 1 through 7 inclusive; said
52 parcel being more particularly described as follows:
53 BEGINNING at the point of Intersection of the north line

54 of Olive Street, 60 feet wide, with the west line of Theresa
55 Avenue, 60 feet wide; Thence North 60 degrees 38 minutes
56 07 seconds West 396.39 feet, along the north line of said
57 Olive Street, to the west line of said Lot 7; Thence North 29
58 degrees 19 minutes East 156.76 feet, along the west line of
59 said Lot 7, to the south line of an Alley, 15 feet wide, in

72 of conveyance.

Section 2. 1. The governor is hereby authorized and empowered
2 to sell, transfer, grant, convey, remise, release, and forever quitclaim
3 all interest of the state of Missouri in real property located in Park
4 Hills, St. Francois County, more particularly described as follows:

5 All of that part of Block 4 of Doe Run Lead Company's
6 Subdivision of the Town of Flat River, in St. Francois
7 County, Missouri, as recorded in Book 5 at Pages 6 and
8 7. Begin at the Southeast corner of Lot 13, Block 4 of said
9 Subdivision; thence South 52 degrees 58 minutes West, 135
10 feet on the North line of Coffman Street to the point of
11 beginning of the tract herein described; thence continue
12 South 52 degrees 58 minutes West, 125 feet on the North
13 line of Coffman Street; thence North 37 degrees 2 minutes
14 West, 140 feet; thence North 52 degrees 58 minutes East,
15 125 feet; thence South 37 degrees 2 minutes East, 140 feet
16 to the point of beginning. The above described tract
17 includes a part of Lots 14, 15 and 16 of Block 4 of said

2 to sell, transfer, grant, convey, remise, release and forever quitclaim all
3 interest of the state of Missouri in real property located in Cabool,
4 Texas County, more particularly described as follows:

5 All of that part of a Tract of land located in the Southeast
6 Quarter of the Southeast Quarter of Section 12, Township
7 28 North, Range 11 West, Texas County, Missouri, more
8 particularly described as follows:

9 COMMENCING at an existing 5/8" Iron Pin at the
10 Southwest corner of the Southeast Quarter of the
11 Southeast Quarter of Section 12, Township 28 North, Range
12 11 West, Texas County, Missouri; thence North 00 Degrees
13 24 Minutes 28 Seconds East along the West line of said
14 Quarter Quarter, a distance of 1325.38 feet to the
15 Northwest corner thereof; thence South 88 Degrees 48

35 Seconds East, a distance of 34.27 feet to a point; thence
36 North 88 Degrees 52 minutes 30 Seconds West, a distance

39 2. The commissioner of administration shall set the terms and
40 conditions for the conveyance as the commissioner deems

43 3. The attorney general shall approve as to form the instrument
44 of conveyance.

Section 4. 1. The governor is hereby authorized and empowered
2 to sell, transfer, grant, convey, remise, release and forever quitclaim all
3 interest of the state of Missouri in real property located in Joplin,
4 Newton County, more particularly described as follows:

6 Commencing at a found monument at the Northwest corner
7 of the Northeast Quarter of Section 21, Township 27 North,
8 Range 33 West in the City of Joplin, Newton County,
9 Missouri; Thence S01°42'35"W along the West line of said
10 Quarter Section a distance of 50.01 feet to the South Line
11 of 32nd Street; Thence S89°36'28"E along said line parallel
12 with the North Line of said Section 21, a distance of 534.01
13 feet to the Northwest Corner of the Additional 100 foot
14 wide Missouri National Guard Armory Tract and the point
15 of beginning. Thence S89°36'28"E along the South Line of
16 32nd Street 50.00 Feet; Thence on a deed bearing of
17 S00°41'30"W 500.00 feet; Thence N89°36'28"W 50.00 Feet to
18 the Southwest Corner of the additional 100 foot wide
19 Missouri National Guard Armory tract; Thence along the
20 West line of Said tract on a Deed bearing of N00°41'30"E

22 portion lying within any additional road right-of-way for

25 2. The commissioner of administration shall set the terms and
26 conditions for the conveyance as the commissioner deems
27 reasonable. Such terms and conditions may include, but are not limited
28 to, the time, place, and terms of the conveyance.

29 3. The attorney general shall approve as to form the instrument
30 of conveyance.

Section 5. 1. The governor is hereby authorized and empowered
2 to sell, transfer, grant, convey, remise, release and forever quitclaim all
3 interest of the state of Missouri in real property located in Springfield,
4 Greene County, more particularly described as follows:

5 Beginning on the South side of St. Louis Street at a point
6 fifty (50) feet west of the Northwest corner of a lot known
7 at one time as the W. J. McDaniel Lot, which point is now
8 the Northwest corner of the Simmons Lot (formerly the A.
9 J. Clements lot), thence West along the South side of St.
10 Louis Street fifty (50) feet to Bryan's Northeast corner,
11 thence South to South alley now McDaniel Street, thence
12 East fifty (50) feet to the Southwest corner of the lot
13 formerly belonging to said Clements, thence North to the

24 of conveyance.

Section 6. 1. The governor is hereby authorized and empowered
2 to sell, transfer, grant, convey, remise, release and forever quitclaim to
3 the City of Chillicothe all interest of the state of Missouri in real
4 property located in Chillicothe, Livingston County, more particularly
5 described as follows:

6 DESCRIPTION OF TRACT #1

7 **A tract of land being part of the East 770 feet of Lot 1 of**
8 **Weston Heights Addition to Chillicothe and part of Block**
9 **3 of Bruce's Subdivision to the City of Chillicothe, all being**
10 **in the Southeast Quarter of Section 35, Township 58 North,**
11 **Range 24 West of the fifth principal meridian, Livingston**
12 **County, Missouri, being more particularly described as**
13 **follows:**

14 **Commencing at an iron pin marking the Southeast corner**

100 feet for a distance of 242.48 feet (chord bearing S89°56'35"E
101 - 242.17') to the POINT OF BEGINNING, containing 1.45
102 acres, more or less.

103 2. The commissioner of administration shall set the terms and
104 conditions for the conveyance as the commissioner deems
105 reasonable. Such terms and conditions may include, but are not limited
106 to, the time, place, and terms of the conveyance.

107 3. The attorney general shall approve as to form the instrument
108 of conveyance.

Section 7. 1. The governor is hereby authorized to remit, release,
2 and forever quitclaim any and all interest in property owned by the
3 state in Pettis County to the Girl Scouts - Heart of Missouri Council,
4 Inc. The property to be conveyed is more particularly described as
5 follows:

6 The North Half of the Northwest Quarter of the Northeast
7 Quarter of Section Number Nineteen (19), also that part of
8 the Northeast Quarter of the Northeast Quarter of Section
9 Number Nineteen (19) lying North and West of the Sedalia

10 **and Warsaw Public Road, all in Township Number Forty**
11 **Five (45) North of Range Number Twenty One (21) West of**
12 **the Fifth Principal Meridian, containing twelve and eight**
13 **tenths acres of land more or less.**

14 **2. The commissioner of administration shall set the terms and**
15 **conditions for the sale as the commissioner deems reasonable. Such**
16 **terms and conditions may include, but not be limited to, the number of**
17 **appraisals required, the time, place, and terms of the sale.**

18 **3. The attorney general shall approve the form of the instrument**
19 **of conveyance.**

 Section A. Because immediate action is necessary to continue economic
2 development efforts, sections 1 to 6 of this act are deemed necessary for the
3 immediate preservation of the public health, welfare, peace, and safety, and are
4 hereby declared to be an emergency act within the meaning of the constitution,
5 and sections 1 to 6 of this act shall be in full force and effect upon its passage and
6 approval.

 Section B. Because immediate action is necessary to permit the Girl
2 Scouts to obtain financing for improvements on the property to be conveyed,
3 section 7 of this act is deemed necessary for the immediate preservation of the
4 public health, welfare, peace, and safety, and is hereby declared to be an
5 emergency act within the meaning of the constitution, and section 7 of this act
6 shall be in full force and effect upon its passage and approval.
