### **State Senator Jeff Smith Calls Attention to Homeowner Assistance Resources**

State Senator Jeff Smith wants to alert citizens to the many local and federal resources available to help people who are finding it challenging to hold onto their homes during these difficult financial times.

“The widespread and near total collapse of the housing sector has affected people nationwide, including families in my district,” Sen. Smith said. “They need help understanding the options available and possible solutions to their housing and mortgage dilemmas. Fortunately, there are numerous resources and agencies that can assist or refer families and seniors in the city of St. Louis to the appropriate assistance which could prove to be a lifesaver to many households.”

Senator Smith also called attention to two state-managed property tax relief programs that were recently expanded. The Senior Citizen Property Tax Credit and the Homestead Preservation Tax Credit programs allow eligible senior citizens and disabled homeowners to receive a credit on their real estate property taxes.

The Senior Citizen Property Tax Credit allows eligible homeowners to receive a \$1,100 tax credit, including individuals with incomes up to \$30,000 and married couples with incomes up to \$34,000. The Homestead Preservation Tax Credit allows eligible homeowners to receive a tax credit if their property taxes increased by a set percentage. Eligible homeowners can receive only one of the tax credits. Deadline to file for the Homestead Preservation Tax Credit is Oct. 15.

“Resources are available for people who are struggling with housing and homeowner issues, and I want to encourage citizens to look at the many options available close to home to see which ones best serve their needs,” Sen. Smith said.
