Education Issues

JEFFERSON CITY – We spent more time this week debating a school voucher bill that just won't seem to die. The legislation creates the Missouri Special Needs Scholarship Tax Credit Program, which sounds like a worthy program until you look at the fine print. This bill will divert scarce public resources from our public schools to private schools. If we allow this to happen and state funding falls off or has to be cut, many districts will be forced to ask for more resources locally. We should stand firm behind our public system to ensure they have the resources to meet our needs.

This week I also read an editorial in the St. Louis Post Dispatch from a Marshfield banker and 13-year member of the MOHELA Board of Directors regarding the dire financial situation of the student loan agency. John Greer says that he and many others spoke against the governor's plan to sell off most of MOHELA's assets to pay for new buildings on college campuses. Greer told lawmakers last year the asset sale would cripple MOHELA's ability to provide low-cost loans to Missouri students, which is why lawmakers created the agency. He also said MOHELA probably would not be able to make its quarterly payments to the state. Sadly, his predictions are coming true. More ominously, Greer says the student loan agency may not survive until the fall. I made similar arguments during the debate on MOHELA last year. It does not make any sense to build new buildings on college campuses if students can't afford to go to school.
