Flood Recovery & the Fourth of July

JEFFERSON CITY – I hope folks in eastern Missouri who've been dealing with flooding for the last few weeks had a chance to take a break and enjoy their local Independence Day celebrations. In a lot of our small towns, the Fourth of July is still a community event, with parades and pie-eating contests and a big fireworks display when the sun sets. Earlier this week I was invited by Senator Claire McCaskill (D-MO) to testify before the U.S. Senate Special Committee on Aging, which held a field hearing in St. Louis to discuss Medicare Advantage insurance plans. Some folks have bought these private insurance plans thinking they were buying Medigap supplement plans. I just want to make sure folks don't buy a pig in a poke. Make sure your health care provider has contracted with the Medicare Advantage plan before signing up because it doesn't do any good to have health insurance if you cannot get healthcare services.

Finally, the governor recently signed House Bill 2224 into law, which will increase the salaries of our deputy sheriffs, many of whom qualify for public assistance. We've been working on this problem for some time and I'm glad we were finally able to provide some relief to our hard-working deputy sheriffs. HB 2224 will increase deputy sheriff salaries statewide by increasing the fees sheriffs collect whenever they serve civil case summons or other court orders to the public to \$10. Those fees will be administered by the Missouri Sheriff Methamphetamine Relief Task Force, which will use a formula to ensure the money will go to rural communities where it is needed most.
