Work Continues On the \$22.6 Billion State Operating Budget

Approving funding to run critical functions of state government with an emphasis on improving education, the Missouri Senate recently advanced thirteen budget bills totaling \$22.6 billion for the 2009 fiscal year, beginning July 1, 2008.

In my 2008 mid-session report, I outlined the governor's recommended operating budget for Fiscal Year 2009. This year, the Legislature has already considered a budget that includes an increased investment to improve math and science education, expanded access to scholarships for students in our state, help for working Missourians to purchase quality health insurance, and a tax cut for our veterans. The governor's recommendations were only preliminary numbers, and as the General Assembly continues to work on the budget, these numbers will fluctuate to reflect the changes by both Senate and House members.

Here is the breakdown of the Senate's plan for Missouri's major operating budget for fiscal year 2009:

Differences in the budget between the Senate and House will be debated by conference committees. The negotiated versions of the budget must be approved by the House before returning to the Senate and then advancing to the governor. According to our state's constitution, the final budget must be passed by 6 p.m. on Friday, May 9, 2008.
