AN ACT

To amend chapter 445, RSMo, by adding thereto seventy-six new sections relating to the uniform planned community act.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 445, RSMo, is amended by adding thereto seventy-six

- 2 new sections, to be known as sections 445.151, 445.152, 445.153, 445.154, 445.155,
- 3 445.156, 445.157, 445.158, 445.159, 445.160, 445.161, 445.162, 445.163, 445.164,
- 4 445.201, 445.202, 445.203, 445.204, 445.205, 445.206, 445.207, 445.208, 445.209,
- 5 445.210, 445.211, 445.212, 445.213, 445.214, 445.215, 445.216, 445.217, 445.218,
- $6\ 445.219,\ 445.220,\ 445.221,\ 445.222,\ 445.223,\ 445.301,\ 445.302,\ 445.303,\ 445.304,$
- 7 445.305, 445.306, 445.307, 445.308, 445.309, 445.310, 445.311, 445.312, 445.313,
- $8\ 445.314,\ 445.315,\ 445.316,\ 445.317,\ 445.318,\ 445.319,\ 445.401,\ 445.402,\ 445.403,$
- 9 445.404, 445.405, 445.406, 445.407, 445.408, 445.409, 445.410, 445.411, 445.412,
- $10\ \ 445.413,445.414,445.415,445.416,445.417,445.418,445.419\ and\ 445.420, to\ read$
- 11 as follows:

445.151. Sections 445.151 to 445.420 shall be known and may be

- 2 cited as the "Uniform Planned Community Act".
- 445.152. 1. Sections 445.151 to 445.420 apply to all planned
- 2 communities created within this state after August 28, 2008; unless such
- 3 a planned community contains no more than twelve units, and is not
- 4 subject to any development rights.
- 5 2. Except as provided in subsection 3 of this section, sections
- 6 445.155, 445.156, 445.157, 445.203, 445.204, 445.221, subdivisions (1) to (6)
- 7 and (11) to (15) of subsection 1 of section 445.302, sections 445.311,
- 8 445.316, 445.318, 445.409 and 445.417, and section 445.153, to the extent
- 9 necessary in construing any of those sections, apply to all planned

10 communities created in this state before August 28, 2008; but those 11 sections apply only with respect to events and circumstances occurring 12 after August 28, 2008, and do not invalidate existing provisions of the 13 declaration, bylaws or plats of those planned communities.

- 3. If a planned community created within this state before August 28, 2008, contains no more than twelve units and is not subject to any development rights, it is subject only to sections 445.155, 445.156 and 445.157 unless the declaration is amended in conformity with applicable law and with the procedures and requirements of the declaration to take advantage of the provisions of subsection 4 of this section, in which case all the sections enumerated in subsection 2 of this section apply to that planned community.
- 4. In the case of amendments to the declaration, bylaws and plats of any planned community created before August 28, 2008:
- 24 (1) If the result accomplished by the amendment was permitted 25 by law prior to the adoption of sections 445.151 to 445.420, the 26 amendment may be made either in accordance with that law, in which 27 case that law applies to that amendment, or may be made under sections 28 445.151 to 445.420;
- (2) If the result accomplished by the amendment is permitted by sections 445.151 to 445.420, and was not permitted by law prior to sections 445.151 to 445.420, the amendment may be made under sections 445.151 to 445.420. An amendment to the declaration, bylaws or plats authorized by this subsection to be made under sections 445.151 to 445.420 must be adopted in conformity with applicable law and with the procedures and requirements specified by that amendment. If any such amendment grants to any person any rights, powers or privileges permitted by sections 445.151 to 445.420, all correlative obligations, liabilities and restrictions in sections 445.151 to 445.420 also apply to 39 that person.
- 5. Sections 445.151 to 445.420 do not apply to a planned tommunity in which all units are restricted exclusively to nonresidential use unless the declaration provides that the chapter does apply to that planned community. Sections 445.151 to 445.420 apply to a planned community containing both units which are restricted exclusively to nonresidential use, and other units which are not so restricted, only if the declaration so provides or if the real estate

47 comprising the units which may be used for residential purposes would 48 be a planned community in the absence of the units which may not be 49 used for residential purposes.

6. Sections 445.151 to 445.420 do not apply to planned communities or units located outside this state, but sections 445.402 to 445.408 apply to all contracts for the disposition thereof signed in this state by any party.

445.153. In the declaration and bylaws, unless specifically provided otherwise or the context otherwise requires, and in sections 3 445.151 to 445.420, the following terms shall mean:

(1) "Affiliate of a declarant", any person who controls, is 4 5 controlled by, or is under common control with a declarant. A person 6 "controls" a declarant if the person (a) is a general partner, officer, 7 director, or employer of the declarant, (b) directly or indirectly or 8 acting in concert with one or more other persons, or through one or 9 more subsidiaries, owns, controls, holds with power to vote, or holds 10 proxies representing, more than twenty percent of the voting interest 11 in the declarant, (c) controls in any manner the election of a majority 12 of the directors of the declarant, or (d) has contributed more than 13 twenty percent of the capital of the declarant. A person "is controlled 14 by" a declarant if the declarant (a) is a general partner, officer, director, 15 or employer of the person, (b) directly or indirectly or acting in concert 16 with one or more other persons, or through one or more subsidiaries, 17 owns, controls, holds with power to vote, or holds proxies representing, 18 more than twenty percent of the voting interest in the person, (c) 19 controls in any manner the election of a majority of the directors of the 20 person, or (d) has contributed more than twenty percent of the capital 21 of the person. Control does not exist if the powers described in this 22 paragraph are held solely as security for an obligation and are not 23 exercised;

- 24 (2) "Allocated interests", the common expense liability and votes 25 in the association allocated to each unit;
- 26 (3) "Association" or "unit owners association", the unit owners 27 association organized under section 445.301;
- 28 (4) "Common elements", any real estate within a planned 29 community owned or leased by the association, other than a unit;
- 30 (5) "Common expense liability", the liability for common expenses

31 allocated to each unit under section 445.207;

- 32 (6) "Common expenses", expenditures made by or financial 33 liabilities of the association, together with any allocations to reserves;
- 34 (7) "Condominium", real estate, portions of which are designated 35 for separate ownership and the remainder of which is designated for
- 36 common ownership solely by the owners of those portions. Real estate
- 37 is not a condominium unless the undivided interests in the common
- 38 elements are vested in the unit owners:
- 39 (8) "Conversion building", a building that at any time before
- 40 creation of the planned community was occupied wholly or partially by
- 41 persons other than purchasers and persons who occupy with the
- 42 consent of purchasers;
- 43 (9) "Cooperative", real estate owned by a corporation, trust,
- 44 trustee, partnership or unincorporated association, where the governing
- 45 instruments of that organization provide that each of the organization's
- 46 members, partners, stockholders or beneficiaries is entitled to exclusive
- 47 occupancy of a designated portion of that real estate;
- 48 (10) "Dealer", a person in the business of selling units for such
- 49 person's own account;
- 50 (11) "Declarant", any person or group of persons acting in concert
- 51 who (a) as part of a common promotional plan, offers to dispose of such
- 52 person's interest in a unit not previously disposed of or (b) reserves or
- 53 succeeds to any special declarant right;
- 54 (12) "Declaration", any instruments, however denominated, that
- 55 create a planned community, and any amendments to those instruments;
- 56 (13) "Development rights", any right or combination of rights
- 57 reserved by a declarant in the declaration (a) to add real estate to a
- 58 planned community; (b) to create units, common elements or limited
- 59 common elements within a planned community; (c) to subdivide units or
- 60 convert units into common elements; or (d) to withdraw real estate from
- 61 a planned community;
- 62 (14) "Dispose" or "disposition", a voluntary transfer to a purchaser
- 63 of any legal or equitable interest in a unit, but does not include the
- 64 transfer or release of a security interest;
- 65 (15) "Executive board", the body, regardless of name, designated
- 66 in the declaration to act on behalf of the association;
- 67 (16) "Identifying number", a symbol or address that identifies only

68 one unit in a planned community;

- 69 (17) "Leasehold planned community", a planned community in 70 which all or a portion of the real estate is subject to a lease the 71 expiration or termination of which will terminate the planned 72 community or reduce its size;
- 73 (18) "Limited common element", a portion of the common elements 74 allocated by the declaration or by operation of subsection 2 or 4 of 75 section 445.202 for the exclusive use of one or more but fewer than all 76 of the units;
- 77 (19) "Master association", an organization described in section 78 445.220, whether or not it is also an association described in section 79 445.301;
- (20) "Offering", any advertisement, inducement, solicitation or attempt to encourage any person to acquire any interest in a unit, other than as security for an obligation. An advertisement in a newspaper or other periodical of general circulation, or in any broadcast medium to the general public, of a planned community not located in this state, is not an offering if the advertisement states that an offering may be made only in compliance with the law of the jurisdiction in which the planned community is located;
- 88 (21) "Person", a natural person, corporation, business trust, estate, 89 trust, partnership, association, joint venture, government, governmental 90 subdivision or agency, or other legal or commercial entity. In the case 91 of a land trust, however, person means the beneficiary of the trust 92 rather than the trust or the trustee;
- 93 (22) "Planned community", real estate with respect to which any
 94 person, by virtue of such person's ownership of a unit, is obligated to
 95 pay for real property taxes, insurance, premiums, maintenance or
 96 improvement of other real estate described in a declaration. For
 97 purposes of sections 445.151 to 445.420, neither a cooperative nor a
 98 condominium is a planned community, but real estate comprising a
 99 condominium or cooperative may be part of a planned
 100 community. "Ownership of a unit" does not include holding a leasehold
 101 interest of less than twenty years in a unit, including renewal options;
- 102 (23) "Purchaser", any person, other than a declarant or a dealer, 103 who by means of a voluntary transfer acquires a legal or equitable 104 interest in a unit, other than (a) a leasehold interest, including renewal

105 options, of less than twenty years, or (b) as security for an obligation;

- (24) "Real estate", any leasehold or other estate or interest in, 107 over or under land, including structures, fixtures and other 108 improvements and interests which by custom, usage or law pass with a 109 conveyance of land though not described in the contract of sale or 110 instrument of conveyance. Real estate includes parcels with or without 111 upper or lower boundaries, and spaces that may be filled with air or 112 water;
- 113 (25) "Residential purposes", use for dwelling or recreational 114 purposes, or both;
- 115 (26) "Security interest", an interest in real estate or personal 116 property, created by contract or conveyance, which secures payment or 117 performance of an obligation. The term includes a lien created by a 118 mortgage, deed of trust, trust deed, security deed, contract for deed, 119 land sales contract, lease intended as security, assignment of lease or 120 rents intended as security, pledge of an ownership interest in an 121 association and any other consensual lien or title retention contract 122 intended as security for an obligation;
- (27) "Special declarant rights", rights reserved for the benefit of a declarant (a) to complete improvements indicated on plats and plans filed with the declaration; (b) to exercise any development right; (c) to maintain sales offices, management offices, signs advertising the planned community, and models; (d) to use easements through the common elements for the purpose of making improvements within the planned community or within real estate which may be added to the planned community; (e) to make the planned community part of a larger planned community or group of planned communities; (f) to make the planned community subject to a master association; or (g) to appoint or remove any officer or executive board member of the association or any master association during any period of declarant control. Special declarant rights are interests in real estate for all purposes;
- 136 (28) "Time share", a right to occupy a unit or any of several units 137 during five or more separated time periods over a period of at least five 138 years, including renewal options, whether or not coupled with an estate 139 or interest in a planned community or a specified portion thereof;
- 140 (29) "Unit", a physical portion of the planned community 141 designated for separate ownership or occupancy, the boundaries of

142 which are described under subdivision (5) of subsection 1 of section 143 445.205;

(30) "Unit owner", a declarant or other person who owns a unit, or a lessee of a unit in a leasehold planned community whose lease expires simultaneously with any lease the expiration or termination of which will remove the unit from the planned community, but does not include a person having an interest in a unit solely as security for an obligation.

445.154. Except as expressly provided in sections 445.151 to 2 445.420, provisions of sections 445.151 to 445.420 may not be varied by 3 agreement, and rights conferred by sections 445.151 to 445.420 may not 4 be waived. A declarant may not act under a power of attorney, or use 5 any other device, to evade the limitations or prohibitions of sections 6 445.151 to 445.420 or the declaration.

445.155. 1. If there is any unit owner other than a declarant, each 2 unit that has been created, together with its interest in the common 3 elements, constitutes for all purposes a separate parcel of real estate.

2. If there is any unit owner other than a declarant, each unit must be separately taxed and assessed, and no separate tax or assessment may be rendered against any common elements for which a declarant has reserved no development rights.

3. Any portion of the common elements for which the declarant has reserved any development rights must be separately taxed and assessed against the declarant, and the declarant alone is liable for payment of those taxes.

4. If there is no unit owner other than a declarant, the real estate comprising the planned community may be taxed and assessed in any manner provided by law.

445.156. 1. Except as provided in subsection 2 of this section, no 2 building code may impose any requirement upon any structure in a 3 planned community which it would not impose upon a physically 4 identical structure under a different form of ownership. Otherwise, no 5 provision of sections 445.151 to 445.420 invalidates or modifies any 6 provision of any building code.

2. Subsection 1 of this section shall not apply to any ordinance, 8 rule, regulation, charter provision or contract provision relating to the 9 financing of housing construction, rehabilitation or purchases provided

10 by or through a housing finance program established and operated 11 under state or federal law by a state or local agency or local unit of 12 government or to any ordinance which has as its purpose the 13 application or enforcement of minimum housing standards.

445.157. 1. If a unit is acquired by eminent domain, or if part of 2 a unit is acquired by eminent domain leaving the unit owner with a 3 remnant which may not practically or lawfully be used for any purpose 4 permitted by the declaration, the award must compensate the unit 5 owner for said unit owner's unit and its interest in the common 6 elements, whether or not any common elements are acquired. Upon 7 acquisition, unless the decree otherwise provides, that unit's allocated 8 interests are automatically reallocated to the remaining units in 9 proportion to the respective allocated interests of those units before the 10 taking, and the association shall promptly prepare, execute and record 11 an amendment to the declaration reflecting the reallocations. Any 12 remnant of a unit remaining after part of a unit is taken under this 13 subsection is thereafter a common element.

- 2. Except as provided in subsection 1 of this section, if part of a unit is acquired by eminent domain, the award must compensate the unit owner for the reduction in value of the unit and its interest in the common elements, whether or not any common elements are acquired. Upon acquisition, unless the decree otherwise provides:
- 19 (1) That units allocated interests are reduced in proportion to the 20 reduction in the size of the unit, or on any other basis specified in the 21 declaration; and
- 22 (2) The portion of the allocated interests divested from the 23 partially acquired unit are automatically reallocated to that unit and 24 the remaining units in proportion to the respective allocated interests 25 of those units before the taking, with the partially acquired unit 26 participating in the reallocation on the basis of its reduced allocated 27 interests.
- 3. If part of the common elements is acquired by eminent domain, the portion of the award attributable to the common elements taken must be paid to the association. Any portion of the award attributable to the acquisition of a limited common element must be equally divided among the owners of the units to which that limited common element was allocated at the time of acquisition.

4. The court decree shall be recorded in every county in which any portion of the planned community is located.

445.158. The principles of law and equity, including the law of 2 corporations and unincorporated associations, the law of real property 3 and the law relative to capacity to contract, principal and agent, 4 eminent domain, estoppel, fraud, misrepresentation, duress, coercion, 5 mistake, receivership, substantial performance, or other validating or 6 invalidating cause supplement the provisions of sections 445.151 to 7 445.420, except to the extent inconsistent with sections 445.151 to 8 445.420.

445.159. Sections 445.151 to 445.420 are intended as a unified 2 coverage of its subject matter, no provision shall be construed to be 3 impliedly repealed by subsequent legislation if that construction can 4 reasonably be avoided.

445.160. Sections 445.151 to 445.420 shall be applied and 2 construed so as to effectuate their general purpose to make uniform the 3 law with respect to the subject of sections 445.151 to 445.420 among 4 states enacting it.

445.161. If any provision or clause of sections 445.151 to 445.420 2 or application thereof to any person or circumstances is held invalid, 3 such invalidity shall not affect other provisions or applications of 4 sections 445.151 to 445.420 which can be given effect without the invalid 5 provision or application, and to this end the provisions of sections 6 445.151 to 445.420 are declared to be severable.

445.162. 1. The court, upon finding as a matter of law that a contract or contract clause was unconscionable at the time the contract was made, may refuse to enforce the contract, enforce the remainder of the contract without the unconscionable clause, or limit the application of any unconscionable clause in order to avoid an unconscionable result.

2. Whenever it is claimed, or appears to the court, that a contract or any contract clause is or may be unconscionable, the parties, in order to aid the court in making the determination, shall be afforded a preasonable opportunity to present evidence as to:

(1) The commercial setting of the negotiations;

11 (2) Whether a party has knowingly taken advantage of the 12 inability of the other party reasonably to protect such other party's 13 interests by reason of physical or mental infirmity, illiteracy or inability

14 to understand the language of the agreement or similar factors;

- (3) The effect and purpose of the contract or clause;
- 16 (4) If a sale, any gross disparity, at the time of contracting,
- 17 between the amount charged for the property and the value of the
- 18 property measured by the price at which similar property was readily
- 19 obtainable in similar transactions, but a disparity between the contract
- 20 price and the value of the property measured by the price at which
- 21 similar property was readily obtainable in similar transactions does not,
- 22 of itself, render the contract unconscionable; and
- 23 (5) If the contract is for the sale of a unit restricted to residential
- 24 purposes, whether any clause is so unfair or one-sided, or resulted from
- 25 procedural abuse in contract formation, in light of the relative
- 26 sophistication of the parties.
- 445.163. Every contract or duty governed by sections 445.151 to 2 445.420 imposes an obligation of good faith in its performance or 3 enforcement.
- 445.164. 1. The remedies provided by sections 445.151 to 445.420 2 shall be liberally administered to the end that the aggrieved party is put 3 in as good a position as if the other party had fully 4 performed. However, consequential, special or punitive damages may 5 not be awarded except as specifically provided in sections 445.151 to
- 5 not be awarded except as specifically provided in sections 445.151 to
- 6 445.420 or by other rule of law.
- 7 2. Any right or obligation declared by sections 445.151 to 445.420 8 is enforceable by judicial proceeding.
- 445.201. A planned community may be created under sections
- $2\ 445.151\ to\ 445.420$ only by recording a declaration executed in the same
- 3 manner as a deed. The declaration must be recorded in every county in
- 4 which any portion of the planned community is located, and must be
- 5 indexed in the name of the planned community and the association and
- 6 in the name of each person executing the declaration.

445.202. Except as provided by the declaration:

- 2 (1) If walls, floors or ceilings of a unit are designated as the
- 3 boundaries of that unit, all lath, furring, wallboard, plasterboard,
- 4 plaster, paneling, tiles, wallpaper, paint, finished flooring and any other
- 5 materials constituting any part of the finished surfaces thereof are a
- 6 part of the unit, and all other portions of the walls, floors or ceilings are
- 7 a part of the common elements;

- 8 (2) If any chute, flue, duct, wire, conduit, bearing wall, bearing 9 column, or any other fixture lies partially within and partially outside 10 the designated boundaries of a unit, any portion thereof serving only 11 that unit is a limited common element allocated solely to that unit, and 12 any portion thereof serving more than one unit or any portion of the 13 common elements is a part of the common elements;
- 14 (3) Subject to the provisions of subdivision (2) of this section, all 15 spaces, interior partitions and other fixtures and improvements within 16 the boundaries of a unit are a part of the unit;
- 17 (4) Any shutters, awnings, window boxes, doorsteps, stoops, 18 porches, balconies, patios, and all exterior doors and windows or other 19 fixtures designed to serve a single unit, but located outside the unit's 20 boundaries, are limited common elements allocated exclusively to that 21 unit.
- 445.203. 1. All provisions of the declaration and bylaws are 2 severable.
- 2. The rule against perpetuities may not be applied to defeat any provision of the declaration, bylaws, rules or regulations adopted under subdivision (1) of subsection 1 of section 445.302.
- 3. In the event of a conflict between the provisions of the declaration and the bylaws, the declaration prevails except to the extent the declaration is inconsistent with sections 445.151 to 445.420.
- 9 4. Title to a unit and common elements is not rendered 10 unmarketable or otherwise affected by reason of nonmaterial failure of 11 the declaration to comply with sections 445.151 to 445.420. Whether a 12 material failure impairs marketability of title is not affected by sections 13 445.151 to 445.420.
- 445.204. A description of a unit which sets forth the name of the planned community, the recording data for the declaration, the county in which the planned community is located and the identifying number of the unit is a sufficient legal description of that unit and all rights, obligations and interests appurtenant to that unit which were created by the declaration or bylaws.
- 445.205. 1. The declaration for a planned community must 2 contain:
- 3 (1) The names of the planned community and the association;
- 4 (2) The name of every county in which any part of the planned

- 5 community is situated;
- 6 (3) A legally sufficient description of the real estate included in 7 the planned community;
- 8 (4) A statement of the maximum number of units which the 9 declarant reserves the right to create;
- 10 (5) A description of the boundaries of each unit created by the 11 declaration, including the unit's identifying number;
- 12 (6) A description of any real estate which is or must become 13 common elements and limited common elements, other than those 14 specified in subdivisions (2) and (4) of section 445.202, as provided in 15 section 445.209;
- 16 (7) A description of any real estate, except real estate subject to 17 development rights, which may be allocated subsequently as limited 18 common elements, other than limited common elements specified in 19 subdivisions (2) and (4) of section 445.202, together with a statement 20 that they may be so allocated;
- 21 (8) A description of any development rights and other special 22 declarant rights reserved by the declarant, together with a legally 23 sufficient description of the real estate to which each of those rights 24 applies and a time limit within which each of those rights must be 25 exercised;
- 26 (9) If any development right may be exercised with respect to 27 different parcels of the real estate at different times, a statement to that 28 effect together with:
- 29 (a) Either a statement fixing the boundaries of those portions and 30 regulating the order in which those portions may be subjected to the 31 exercise of each development right, or a statement that no assurances 32 are made in those regards; and
- 33 (b) A statement as to whether, if any development right is 34 exercised in any portion of the real estate subject to that development 35 right, that development right must be exercised in all or in any other 36 portion of the remainder of that real estate;
- 37 (10) Any other conditions or limitations under which the rights 38 described in subdivision (8) of subsection 1 of this section may be 39 exercised or will lapse;
- 40 (11) An allocation to each unit of the allocated interests in the 41 manner described in section 445.207;

- 42 (12) Any restrictions on use, occupancy and alienation of the 43 units;
- 44 (13) The recording data for recorded easements and licenses
- 45 appurtenant to or included in the planned community or to which any
- 46 portion of the planned community is or may become subject by virtue
- 47 of a reservation in the declaration; and
- 48 (14) All matters required by sections 445.206, 445.207, 445.208,
- 49 445.209, 445.215, 445.216, and subsection 4 of section 445.303.
- 50 2. The declaration may contain any other matters the declarant
- 51 deems appropriate.
 - 445.206. 1. Any lease the expiration or termination of which may
- 2 terminate the planned community or reduce its size shall be
- 3 recorded. Every lessor of those leases must execute the declaration, and
- 4 the declaration shall state:
- 5 (1) The recording data for the lease;
- 6 (2) The date on which the lease is scheduled to expire;
- 7 (3) A legally sufficient description of the real estate subject to the 8 lease;
- 9 (4) Any right of the unit owners to redeem the revision and the
- 10 manner whereby those rights may be exercised, or a statement that they
- 11 do not have those rights;
- 12 (5) Any right of the unit owners to remove any improvements
- 13 after the expiration or termination of the lease, or a statement that they
- 14 do not have those rights; and
- 15 (6) Any rights of the unit owners to renew the lease and the
- 16 conditions of any renewal, or a statement that they do not have those
- 17 rights.
- 18 2. After the declaration for a leasehold planned community is
- 19 recorded, neither the lessor nor any successor in interest may terminate
- 20 the leasehold interest of a unit owner who makes timely payment of
- 21 such unit owner's share of the rent and otherwise complies with all
- 22 covenants which, if violated, would entitle the lessor to terminate the
- 23 lease. A unit owner's leasehold interest is not affected by failure of any
- 24 other person to pay rent or fulfill any other covenant.
- 25 3. Acquisition of the leasehold interest of any unit owner by the
- 26 owner of the reversion or remainder does not merge the leasehold and
- 27 fee simple interests unless the leasehold interests of all unit owners

28 subject to that reversion or remainder are acquired.

4. If the expiration or termination of a lease decreases the number of units in a planned community, the allocated interests shall be reallocated in accordance with subsection 1 of section 445.157 as though those units had been taken by eminent domain. Reallocations shall be confirmed by an amendment to the declaration prepared, executed and recorded by the association.

445.207. 1. The declaration shall allocate a fraction or percentage of the common expenses of the association, and a portion of the votes in the association to each unit in the planned community, and state the formulas used to establish those allocations. Those allocations may not discriminate in favor of units owned by the declarant.

2. If units may be added to or withdrawn from the planned community, the declaration must state the formulas to be used to reallocate the allocated interests among all units included in the planned community after the addition or withdrawal.

10 3. The declaration may provide:

11 (1) That different allocations of votes shall be made to the units 12 on particular matters specified in the declaration;

13 (2) For cumulative voting only for the purpose of electing 14 members of the executive board; and

15 (3) For class voting on specified issues affecting the class if 16 necessary to protect valid interests of the class. A declarant may not 17 utilize cumulative or class voting for the purpose of evading any 18 limitation imposed on declarants by sections 445.151 to 445.420, nor may 19 units constitute a class because they are owned by a declarant.

4. Except for minor variations due to rounding, the sum of the common expense liabilities allocated at any time to all the units must equal one if stated as a fraction or one hundred percent if stated as a percentage. In the event of a discrepancy between an allocated interest and the result derived from application of the pertinent formula, the allocated interest prevails.

445.208. 1. Except for the limited common elements described in subdivisions (2) and (4) of section 445.202, the declaration shall specify to which unit or units each limited common element is allocated. That allocation may not be altered without the consent of the unit owners whose units are affected.

- 2. Except as the declaration otherwise provides, a limited common element may be reallocated by an amendment to the declaration executed by the unit owners between or among whose units the reallocation is made. The persons executing the amendment shall provide a copy thereof to the association, which shall record it. The amendment shall be recorded in the names of the parties and the planned community.
- 3. A common element not previously allocated as a limited common element may not be so allocated except under provisions in the declaration made in accordance with subdivision (7) of subsection 1 of section 445.205. The allocations shall be made by amendments to the declaration.
- 445.209. 1. Plats and plans are a part of the declaration and are required for all planned communities subject to the chapter. Separate plats and plans are not required by sections 445.151 to 445.420 if all the information required by this section is contained in either a plat or plan. Each plat and plan must be clear and legible and contain a certification that the plat or plan contains all information required by this section.
- 8 2. Each plat must show or project:
- 9 (1) The name and a survey or general schematic map of the entire 10 planned community;
- 11 (2) The location and dimensions of all real estate not subject to 12 development rights, or subject only to the development right to 13 withdraw, and the location and dimensions of all existing improvements 14 within that real estate;
- 15 (3) A legally sufficient description of any real estate subject to 16 development rights, labeled to identify the rights applicable to each 17 parcel;
- 18 (4) The extent of any encroachments by or upon any portion of 19 the planned community;
- 20 (5) To the extent feasible, a legally sufficient description of all 21 easements serving or burdening any portion of the planned community;
- 22 (6) Except as provided in subsection 7 of this section, the 23 approximate location and dimensions of any vertical unit boundaries 24 not shown or projected on plans recorded under subsection 4 of this 25 section and that unit's identifying number;

- 26 (7) Except as provided in subsection 7 of this section, the 27 approximate location with reference to an established datum of any 28 horizontal unit boundaries not shown or projected on plans recorded 29 under subsection 4 of this section and that unit's identifying number;
- 30 (8) A legally sufficient description of any real estate in which the 31 unit owners will own only an estate for years, labeled as "leasehold real 32 estate";
- 33 (9) The distance between noncontiguous parcels of real estate 34 comprising the planned community;
- 35 (10) The approximate location and dimensions of limited common 36 elements, including porches, balconies and patios, other than parking 37 spaces and the other limited common elements described in subdivisions 38 (2) and (4) of section 445.202; and
- 39 (11) In the case of real estate not subject to development rights, 40 all other matters customarily shown on land surveys.
- 3. A plat may also show the intended location and dimensions of any contemplated improvement to be constructed anywhere within the planned community. Any contemplated improvement shown must be labeled either "SHALL BE BUILT" or "NEED NOT BE BUILT".
- 45 4. Except as provided in subsection 7 of this section, to the extent 46 not shown or projected on the plats, plans of the units must show or 47 project:
- 48 (1) The approximate location and dimensions of the vertical 49 boundaries of each unit and that unit's identifying number;
- 50 (2) The approximate location of any horizontal unit boundaries, 51 with reference to an established datum, and that unit's identifying 52 number; and
- 53 (3) The approximate location of any units in which the declarant 54 has reserved the right to create additional units or common elements, 55 identified appropriately.
- 56 5. Unless the declaration provides otherwise, the horizontal boundaries of part of a unit located outside of a building have the same elevation as the horizontal boundaries of the inside part, and need not 59 be depicted on the plats and plans.
- 6. Upon exercising any development right, the declarant shall 61 record either new plats and plans necessary to conform to the 62 requirements of subsections 1, 2, and 3 of this section, or new

63 certifications of plats and plans previously recorded if those plats and 64 plans conform to the requirements of those subsections.

- 7. Any certification of a plat required by this section must be made by a registered and licensed surveyor, and any certification of a plan required by subsection 2 of section 445.201 shall be made by an architect or engineer.
- 8. Plats and plans need not show the location and dimensions of the units' boundaries or their limited common elements if:
- 71 (1) The plat shows the location and dimensions of all buildings 72 containing or comprising the units; and
- 73 (2) The declaration includes other information that shows or 74 contains a narrative description of the general layout of the units in 75 those buildings and the limited common elements allocated to those 76 units.
- 445.210. 1. To exercise any development right reserved under subdivision (8) of subsection 1 of section 445.205, the declarant shall prepare, execute and record an amendment to the declaration and comply with section 445.209. The declarant is the owner of any units thereby created. The amendment to the declaration must assign an identifying number to each new unit created, and except in the case of subdivision or conversion of units described in subsection 2 of this section, reallocate the allocated interests among all units. The amendment must describe any common elements and any limited common elements thereby created and, in the case of limited common elements, designate the units to which each is allocated to the extent required by section 445.208.
- 2. Development rights may be reserved within any real estate added to the planned community if the amendment adding that real estate includes all matters required by section 445.205 or 445.206, as the case may be, and the plats and plans include all matters required by section 445.209. This provision does not extend the time limit on the exercise of development rights imposed by the declaration under subdivision (8) of subsection 1 of section 445.205.
- 3. Whenever a declarant exercises a development right to subdivide or convert a unit previously created into additional units, common elements, or both:

23

(1) If the declarant converts the unit entirely to common

24 elements, the amendment to the declaration must reallocate all the 25 allocated interests of that unit among the other units as if that unit had 26 been taken by eminent domain;

- (2) If the declarant subdivides the unit into two or more units, whether or not any part of the unit is converted into common elements, the amendment to the declaration must reallocate all the allocated interests of the unit among the units created by the subdivision in any reasonable manner prescribed by the declarant.
- 4. If the declaration provides, under subdivision (8) of subsection 33 1 of section 445.205, that all or a portion of the real estate is subject to 34 the development right of withdrawal:
- 35 (1) If all the real estate is subject to withdrawal, and the 36 declaration does not describe separate portions of real estate subject to 37 that right, none of the real estate may be withdrawn after a unit has 38 been conveyed to a purchaser; and
- 39 (2) If a portion or portions are subject to withdrawal, no portion 40 may be withdrawn after a unit in that portion has been conveyed to a 41 purchaser.
- 445.211. Subject to the provisions of the declaration and other 2 provisions of law, a unit owner:
- 3 (1) May make any improvements or alterations to said unit 4 owner's unit that do not impair the structural integrity or mechanical 5 systems or lessen the support of any portion of the planned community;
- 6 (2) May not change the appearance of the common elements, or 7 the exterior appearance of a unit or any other portion of the planned 8 community, without permission of the association;
- 9 (3) After acquiring an adjoining unit or an adjoining part of an adjoining unit, may remove or alter any intervening partition or create apertures therein, even if the partition in whole or in part is a common le element, if those acts do not impair the structural integrity or mechanical systems or lessen the support of any portion of the planned community. Removal of partitions or creation of apertures under this subdivision is not an alteration of boundaries.
- 445.212. 1. Subject to the provisions of the declaration and other 2 provisions of law, the boundaries between adjoining units may be 3 relocated by an amendment to the declaration upon application to the 4 association by the owners of those units. If the owners of the adjoining

5 units have specified a reallocation between their units of their allocated 6 interests, the application must state the proposed reallocations. Unless 7 the executive board determines, within thirty days, that the 8 reallocations are unreasonable, the association shall prepare an 9 amendment that identifies the units involved, states the reallocations, 10 is executed by those unit owners, contains words of conveyance between 11 them, and, upon recordation, is indexed in the name of the grantor and 12 the grantee.

2. The association shall prepare and record plats or plans 14 necessary to show the altered boundaries between affected units, and 15 their dimensions and identifying numbers.

445.213. 1. If the declaration expressly so permits, a unit may be subdivided into two or more units. Subject to the provisions of the declaration and other provisions of law, upon application of a unit owner to subdivide a unit, the association shall prepare, execute and record an amendment to the declaration, including the plats and plans, subdividing that unit.

The amendment to the declaration must be executed by the swner of the unit to be subdivided, assign an identifying number to each unit created and reallocate the allocated interests formerly allocated to the subdivided unit to the new units in any reasonable manner prescribed by the owner of the subdivided unit.

445.214. The existing physical boundaries of a unit or the physical boundaries of a unit reconstructed in substantial accordance with the description contained in the original declaration are the legal boundaries rather than the boundaries derived from the description contained regardless of vertical or lateral movement of the building, or minor variance between those boundaries and the boundaries derived. This section does not relieve a unit owner of liability in case of such owner's willful misconduct nor relieve a declarant or any other person of liability for failure to adhere to the plats and plans.

445.215. A declarant may maintain sales offices, management offices and models in units or on common elements in the planned community only if the declaration so provides and specifies the rights of a declarant with regard to the number, size, location and relocation thereof. Subject to any limitations in the declaration, a declarant may maintain signs on the common elements advertising the planned

7 community. The provisions of this section are subject to the provisions 8 of other state law and to local ordinances.

445.216. 1. Subject to the provisions of section 445.312, the unit 2 owners have an easement:

- 3 (1) In the common elements for purposes of access to their units; 4 and
- 5 (2) To use the common elements and all real estate which must 6 become common elements for all other purposes.
- 2. Subject to the provisions of the declaration, a declarant has an 8 easement through the common elements as may be reasonably necessary 9 for the purpose of discharging a declarant's obligations or exercising 10 special declarant rights, whether arising under sections 445.151 to 11 445.420 or reserved in the declaration.
- 445.217. 1. Except in cases of amendments that may be executed 2 by a declarant under subsection 6 of section 445.209 or section 445.210; 3 or by the association under section 445.157, subsection 4 of section 445.206, subsection 3 of section 445.208, subsection 1 of section 445.212 or subsection 1 of section 445.213; or by certain unit owners under 6 subsection 2 of section 445.208, subsection 1 of section 445.212, 7 subsection 2 of section 445.213, or subsection 2 of section 445.218, and 8 except as limited by subsections 4, 5, 6, and 7 of this section, the 9 declaration, including the plats and plans, may be amended only by vote 10 or agreement of unit owners of units to which at least sixty-seven 11 percent of the votes in the association are allocated, or any larger 12 majority the declaration specifies. The declaration may specify a 13 smaller number only if all of the units are restricted exclusively to 14 nonresidential use.
- 2. No action to challenge the validity of an amendment adopted by the association under this section may be brought more than one year after the amendment is recorded.
- 3. Every amendment to the declaration must be recorded in every county in which any portion of the planned community is located, and is effective only upon recordation. Every amendment, except an amendment under subsection 1 of section 445.212, shall be indexed in the name of the planned community and the association and in the name of the parties executing the amendment.
- 4. Except to the extent expressly permitted or required by other

provisions of sections 445.151 to 445.420, no amendment may create or increase the special declarant rights, increase the number of units or change the boundaries of any unit or the allocated interests of a unit in the absence of unanimous consent of the unit owners.

- 5. An amendment to the declaration may be adopted that prohibits or materially restricts the permitted uses of, or behavior in, a unit or the number or other qualifications, of persons who may occupy units, by vote or agreement of unit owners to which eighty percent of the votes in the association are allocated; provided however, that the amendment must provide reasonable protection for a valid use or occupancy existing at the time the amendment was adopted.
- 6. The time limits specified in the declaration under subdivision (8) of subsection 1 of section 445.205 within which reserved development rights must be exercised may be extended, and additional development rights may be created, if persons entitled to cast at least eighty percent of the votes in the association, including eighty percent of the votes allocated to units not owned by the declarant, agree to that action. The agreement is effective thirty days after an amendment to the declaration reflecting the terms of the agreement is recorded, unless all persons holding the affected special declarant rights or security interests in those rights:
- 46 (1) Record a written objection within that thirty-day period in 47 which case the amendment is void; or
- 48 (2) Consent in writing at the time the amendment is recorded, in 49 which case the amendment is effective when recorded.
- 7. Amendments to the declaration required by sections 445.151 to 445.420 to be recorded by the association shall be prepared, executed, recorded and certified on behalf of the association by any officer of the association designated for that purpose or, in the absence of designation, by the president of the association.
- 445.218. 1. Except in the case of a taking of all the units by 2 eminent domain, a planned community may be terminated only by 3 agreement of unit owners of units to which at least eighty percent of the 4 votes in the association are allocated, or any larger percentage the 5 declaration specifies. The declaration may specify a smaller percentage 6 only if all of the units in the planned community are restricted 7 exclusively to nonresidential uses.

2. An agreement to terminate must be evidenced by the execution of a termination agreement, or ratifications thereof, in the same manner as a deed, by the requisite number of unit owners. The termination agreement must specify a date after which the agreement will be void unless it is recorded before that date. A termination agreement and all ratifications thereof must be recorded in every county in which a portion of the planned community is situated, and is effective only upon recordation.

3. In the case of a planned community containing only units having horizontal boundaries described in the declaration, a termination agreement may provide that all the common elements and units of the planned community shall be sold following termination. If, under the agreement, any real estate in the planned community is to be sold following termination, the termination agreement must set forth the minimum terms of the sale.

4. In the case of a planned community containing any units not having horizontal boundaries described in the declaration, a termination agreement may provide for sale of the common elements, but may not require that the units be sold following termination, unless the declaration as originally recorded provided otherwise or unless all the unit owners consent to the sale.

29 5. The association, on behalf of the unit owners, may contract for 30 the sale of real estate in the planned community, but the contract is not 31 binding until approved under subsections 1 and 2 of this section. If any 32 real estate in the planned community is to be sold following 33 termination, title to that real estate, upon termination, vests in the 34 association as trustee for the holders of all interests in the 35 units. Thereafter, the association has all powers necessary and 36 appropriate to effect the sale. Until the sale has been concluded and the 37 proceeds thereof distributed, the association continues in existence with 38 all powers it had before termination. Proceeds of the sale must be 39 distributed to unit owners and lienholders as their interests may 40 appear, in proportion to the respective interests of unit owners as 41 provided in subsection 8 of this section. Unless otherwise specified in 42 the termination agreement, as long as the association holds title to the 43 real estate, each unit owner and any successors in interest have an 44 exclusive right to occupancy of the portion of the real estate that

45 formerly constituted such owner's unit. During the period of that 46 occupancy, each unit owner and any successors in interest remain liable 47 for all assessments and other obligations imposed on unit owners by 48 sections 445.151 to 445.420 or the declaration.

- 6. If the real estate constituting the planned community is not to be sold following termination, title to the common elements and, in a planned community containing only units having horizontal boundaries described in the declaration, title to all the real estate in the planned community, vests in the unit owners upon termination as tenants in common in proportion to their respective interests as provided in subsection 8 of this section, and liens on the units shift accordingly. While the tenancy in common exists, each unit owner and any successors in interest have an exclusive right to occupancy of the portion of the real estate that formerly constituted said owner's unit.
- 7. Following termination of the planned community, the proceeds of any sale of real estate, together with the assets of the association, are held by the association as trustee for unit owners and holders of liens on the units as their interests may appear. Following termination, creditors of the association holding liens on the units which were recorded before termination may enforce those liens in the same manner as any lienholder. All other creditors of the association are to be treated as if they had perfected liens on the units immediately before termination.
- 8. The respective interests of unit owners referred to in subsections 5, 6 and 7 of this section are as follows:
- (1) Except as provided in subdivision (2) of this subsection, the respective interests of unit owners are the fair market values of their units and limited common elements immediately before the termination, as determined by one or more independent appraisers selected by the association. The decision of the independent appraisers shall be distributed to the unit owners and becomes final unless disapproved within thirty days after distribution by unit owners of units to which twenty-five percent of the votes in the association are allocated. The proportion of any unit owner's interest to that of all unit owners is determined by dividing the fair market value of that unit owner's unit by the total fair market values of all the units and common elements;

81

(2) If any unit or any limited common element is destroyed to the

82 extent that an appraisal of the fair market value thereof before 83 destruction cannot be made, the interests of all unit owners are their 84 respective common expense liabilities immediately before the 85 termination.

- 9. Except as provided in subsection 10 of this section, foreclosure or enforcement of a lien or encumbrance against the entire planned community does not of itself terminate the planned community, and foreclosure or enforcement of a lien or encumbrance against a portion of the planned community does not of itself withdraw that portion from the planned community. Foreclosure or enforcement of a lien or encumbrance against withdrawable real estate does not of itself withdraw that real estate from the planned community, but the person taking title thereto has the right to require from the association, upon request, an amendment excluding the real estate from the planned community.
- 10. If a lien or encumbrance against a portion of the real estate comprising the planned community has priority over the declaration, and the lien or encumbrance has not been partially released, the parties foreclosing the lien or encumbrance may upon foreclosure, record an instrument excluding the real estate subject to that lien or encumbrance from the planned community.
 - 445.219. The declaration may require that all or a specified 2 number or percentage of the mortgagees or beneficiaries of deeds of 3 trust encumbering the units approve specified actions of the unit 4 owners or the association as a condition to the effectiveness of those 5 actions, but no requirement for approval may operate to:
 - 6 (1) Deny or delegate control over the general administrative 7 affairs of the association by the unit owners or the executive board; or
- 8 (2) Prevent the association or the executive board from 9 commencing, intervening in, or settling any litigation or proceeding, or 10 receiving and distributing any insurance proceeds except under section 11 445.313.
- 445.220. 1. If the declaration for a planned community provides that any of the powers described in section 445.302 are to be exercised by or may be delegated to a profit or nonprofit corporation or unincorporated association which exercises those or other powers on behalf of one or more other planned communities or for the benefit of

6 the unit owners of one or more other planned communities, all 7 provisions of sections 445.151 to 445.420 applicable to unit owners' 8 associations apply to any such corporation or unincorporated 9 association, except as modified by this section.

- 2. Unless a master association is acting in the capacity of an association described in section 445.301, it may exercise the powers set forth in subdivision (2) of subsection 1 of section 445.302 only to the extent expressly permitted in the declarations of the planned communities which are part of the master association or expressly described in the delegations of power from those planned communities to the master association.
- 3. If the declaration of any planned community provides that the executive board may delegate certain powers to a master association, the members of the executive board have no liability for the acts or omissions of the master association with respect to those powers following delegation.
- 4. The rights and responsibilities of unit owners with respect to the unit owners' association set forth in sections 445.303, 445.308, 445.309, 445.310 and 445.312 apply in the conduct of the affairs of a master association only to those persons who elect the board of a master association, whether or not those persons are otherwise unit owners within the meaning of sections 445.151 to 445.420.
- 5. Even if a master association is also an association described in section 445.301, the certificate of incorporation or other instrument creating the master association and the declaration of each planned community the powers of which are assigned by the declaration or delegated to the master association may provide that the executive board of the master association must be elected after the period of declarant control in any of the following ways:
- 35 (1) All unit owners of all planned communities subject to the 36 master association may elect all members of the master association's 37 executive board;
- 38 (2) All members of the executive boards of all planned 39 communities subject to the master association may elect all members of 40 the master association's executive board;
- 41 (3) All unit owners of each planned community subject to the 42 master association may elect specified members of the master

43 association's executive board;

44 (4) All members of the executive board of each planned 45 community subject to the master association may elect specified 46 members of the master association's executive board.

445.221. 1. Any two or more planned communities, by agreement of the unit owners as provided in subsection 2 of this section, may be merged or consolidated into a single planned community. In the event of a merger or consolidation, unless the agreement otherwise provides, the resultant planned community is, for all purposes, the legal successor of all of the preexisting planned communities, and the operations and activities of all associations of the preexisting planned communities shall be merged or consolidated into a single association which shall hold all powers, rights, obligations, assets and liabilities of all preexisting associations.

2. An agreement of two or more planned communities to merge or consolidate under subsection 1 of this section must be evidenced by an agreement prepared, executed, recorded and certified by the president of the association of each of the preexisting planned communities following approval by owners of units to which are allocated the percentage of votes in each planned community required to terminate that planned community. Any such agreement must be recorded in every county in which a portion of the planned community is located and is not effective until recorded.

3. Every merger or consolidation agreement must provide for the reallocation of the allocated interests in the new association among the units of the resultant planned community either:

23 (1) By stating the reallocations or the formulas upon which they 24 are based; or

(2) By stating the percentage of overall common expense liabilities and votes in the new association which are allocated to all of the units comprising each of the preexisting planned communities, and providing that the portion of the percentages allocated to each unit formerly comprising a part of the preexisting planned community must be equal to the percentages of common expense liabilities and votes in the association allocated to that unit by the declaration of the preexisting planned community.

445.222. If the right is originally reserved in the declaration, the

declarant may, in addition to any other development right, amend the declaration at any time during as many years as are specified in the declaration to add additional real estate to the planned community without describing the location of that real estate in the original declaration; provided, that the amount of real estate added to the planned community under this section may not exceed ten percent of the real estate described in subdivision (3) of subsection 1 of section 445.205, and provided further, that the declarant may not in any event increase the number of units in the planned community beyond the number stated in the original declaration under subdivision (5) of subsection 1 of section 445.205.

445.223. 1. The declaration for a planned community may state that it is a master planned community if the declarant has reserved the development right to create at least five hundred units that may be used for residential purposes and, at the time of the reservation, that declarant owns or controls more than five hundred acres on which the units may be built.

- 2. If the requirements of subsection 1 of this section are satisfied, 8 the declaration for the master planned community need not state a 9 maximum number of units and need not contain any of the information 10 required by subdivisions (3) to (14) of subsection 1 of section 445.205 11 until the declaration is amended under subsection 3 of this section.
- 12 3. At the time each unit in a master planned community is 13 conveyed to a purchaser, the declaration shall contain:
- 14 (1) A sufficient legal description of the unit and all portions of 15 the master planned community in which any other units have been 16 conveyed to a purchaser; and
- 17 (2) All the information required by subdivisions (3) to (14) of 18 subsection 1 of section 445.205 with respect to that real estate.
- 19 4. Notwithstanding any other provision of the chapter:
- 20 (1) The only real estate in a master planned community which is 21 subject to the chapter is:
- 22 (a) Units that have been declared or which are being offered for 23 sale; and
- 24 (b) Any other real estate described under subsection 3 of this 25 section;
- 26 (2) Other real estate that is or may become part of the master

27 planned community is only subject to other law and to any other 28 restrictions and limitations that appear of record; and

- (3) If the original sale certificate conspicuously identifies the fact that the community is a master planned community, the disclosure requirements contained in sections 445.401 to 445.407 apply only with respect to units that have been declared or are being offered for sale in connection with the original sale certificate and to the real estate described under subsection 3 of this section.
- 5. The limitations contained in section 445.222 do not apply to a master planned community.
- 6. Subject to the requirements of good faith in section 445.163 and unconscionability in section 445.162, the period of declarant control of the association for a master planned community terminates in accordance with any conditions specified in the declaration or otherwise at the time of the declarant, in a recorded instrument and after giving written notice to all the unit owners, voluntarily surrenders all rights to control the activities of the associations.
- 445.301. A unit owners' association must be organized no later than the date the first unit in the planned community is conveyed. The membership of the association at all times shall consist exclusively of all the unit owners or, following termination of the planned community, of all unit owners entitled to distributions of proceeds under section 445.218 or their heirs, successors or assigns. The association shall be organized as a profit or nonprofit corporation.
- 445.302. 1. Except as provided in subsection 2 of this section, and 2 subject to the provisions of the declaration, the association may:
- 3 (1) Adopt and amend bylaws and rules and regulations for the 4 planned community and those who own or lease units within it;
- 5 (2) Adopt and amend budgets for revenues, expenditures and 6 reserves and collect assessments for common expenses from unit 7 owners;
- 8 (3) Hire and discharge managing agents and other employees, 9 agents and independent contractors;
- 10 (4) Institute, defend or intervene in litigation or administrative 11 proceedings in its own name on behalf of itself or two or more unit 12 owners on matters affecting the planned community;
- 13 (5) Make contracts and incur liabilities;

- 14 (6) Regulate the use, maintenance, repair, replacement and 15 modification of common elements;
- 16 (7) Cause additional improvements to be made as a part of the 17 common elements;
- 18 (8) Acquire, hold, encumber and convey in its own name any 19 right, title or interest to real or personal property, but common 20 elements may be conveyed or subjected to a security interest only under 21 section 445.312;
- 22 (9) Grant easements, leases, licenses and concessions through or 23 over the common elements;
- 24 (10) Impose and receive any payments, fees or charges for the 25 use, rental or operation of the common elements, other than the limited 26 common elements described in subdivisions (2) and (4) of section 27 445.202, and for services provided to unit owners;
- 28 **(11) Impose:**
- 29 (a) Charges for late payment of assessments; and
- 30 (b) After notice and an opportunity to be heard, levy reasonable 31 fines for violations of the declaration, bylaws and rules and regulations 32 of the association;
- 33 (12) Impose reasonable charges for the preparation and 34 recordation of amendments to the declaration, resale certificates 35 required by section 445.409, or statements of unpaid assessments;
- 36 (13) Provide for the indemnification of its officers and executive 37 board and maintain directors' and officers' liability insurance;
- 38 (14) Assign its right to future income, including the right to 39 receive common expense assessments, subject to the limitations 40 expressly provided in the declaration;
- 41 (15) Exercise any other powers conferred by the declaration or 42 bylaws;
- 43 (16) Exercise all other powers that may be exercised in this state 44 by legal entities of the same type as the association; and
- 45 (17) Exercise any other powers necessary and proper for the 46 governance and operation of the association.
- 2. The declaration may not impose limitations on the power of the association to deal with a declarant which are more restrictive than the limitations imposed on the power of the association to deal with other persons.

- 3. The association may adopt rules with respect to units that may be used for residential purposes to:
- 53 (1) By regulation, require that disputes between the executive 54 board and unit owners or between two or more unit owners regarding 55 the planned community must be submitted to nonbinding alternative 56 dispute resolution in the manner described in the regulations as a 57 prerequisite to instituting a judicial proceeding;
- 58 (2) Prevent any use of, or behavior in, residential units which 59 violates the declaration or adversely affects the use and enjoyment of 60 other units or the common elements by other unit owners; or
- 61 (3) Reasonably restrict the leasing of residential units so long as 62 the rules are designed to meet the current underwriting requirements 63 adopted by institutional lenders who regularly lend money secured by 64 first mortgages on units in common interest communities or regularly 65 purchase those mortgages.
- 66 Otherwise, the association may not regulate the use of, or behavior in, 67 units unless empowered to do so by the declaration or sections 445.151 68 to 445.420.
- 445.303. 1. Except as provided in the declaration, the bylaws, 2 subsection 2 of this section, or other provisions of sections 445.151 to 3 445.420, the executive board may act in all instances on behalf of the 4 association. In the performance of their duties, officers and members 5 of the executive board appointed by the declarant are required to 6 exercise the care required of a trustee for the unit owners. Otherwise, 7 officers and members of the executive board shall exercise reasonable 8 care.
- 2. The executive board may not act on behalf of the association to amend the declaration, to terminate the planned community, or to elect members of the executive board or determine the qualifications, powers and duties, or terms of office of executive board members, but the executive board may fill vacancies in its membership for the unexpired portion of any term.
- 3. Within thirty days after adoption of any proposed budget for the planned community, the executive board shall provide a summary of the budget to all the unit owners, and shall set a date for a meeting of the unit owners to consider ratification of the budget not less than fourteen nor more than thirty days after mailing of the

summary. Unless at that meeting a majority of all the unit owners or any larger vote specified in the declaration reject the budget, the budget is ratified, whether or not a quorum is present. In the event the proposed budget is rejected, the periodic budget last ratified by the unit owners shall be continued until such time as the unit owners ratify a subsequent budget proposed by the executive board.

- 4. Subject to subsection 5 of this section, the declaration may provide for a period of declarant control of the association, during which period a declarant, or persons designated by him, may appoint and remove the officers and members of the executive board. Regardless of the period provided in the declaration, a period of declarant control terminates no later than the earlier of:
- 32 (1) Sixty days after conveyance of seventy-five percent of the 33 units which may be created to unit owners other than a declarant;
- 34 (2) Two years after all declarants have ceased to offer units for 35 sale in the ordinary course of business; or
- 36 (3) Two years after any development right to add new units was 37 last exercised.
- A declarant may voluntarily surrender the right to appoint and remove officers and members of the executive board before termination of that period, but in that event the declarant may require, for the duration of the period of declarant control, that specified actions of the association or executive board, as described in a recorded instrument executed by the declarant, be approved by the declarant before they become 44 effective.
- 5. Not later than sixty days after conveyance of twenty-five percent of the units which may be created to unit owners other than a declarant, at least one member and not less than twenty-five percent of the members of the executive board must be elected by unit owners other than the declarant. Not later than sixty days after conveyance of fifty percent of the units which may be created to unit owners other than a declarant, not less than thirty-three and one-third percent of the members of the executive board must be elected by unit owners other than the declarant.
- 6. Not later than the termination of any period of declarant to control, the unit owners shall elect an executive board of at least three members, at least a majority of whom must be unit owners. The

57 executive board shall elect the officers. The executive board members 58 and officers shall take office upon election.

- 7. Notwithstanding any provision of the declaration or bylaws to the contrary, the unit owners, by a two-thirds vote of all persons present and entitled to vote at any meeting of the unit owners at which a quorum is present, may remove any member of the executive board with or without cause, other than a member appointed by the declarant.
- 8. On or before the date of termination of declarant control, the declarant shall relinquish control of the planned community and the unit owners shall accept control. At the same time, the declarant shall deliver to the planned community all property, books, accounts and articles of incorporation of the association and of the planned community held or controlled by the declarant from the date the association was organized.
- 445.304. 1. No special declarant right created or reserved under sections 445.151 to 445.420 may be transferred except by an instrument evidencing the transfer recorded in every county in which any portion of the planned community is located. The instrument is not effective unless executed by the transferee.
- 6 2. Upon transfer of any special declarant right, the liability of a 7 transferor declarant is as follows:
- 8 (1) A transferor is not relieved of any obligation or liability
 9 arising before the transfer, and remains liable for warranty obligations
 10 imposed by sections 445.151 to 445.420. Lack of privity does not deprive
 11 any unit owner of standing to maintain an action to enforce any
 12 obligation of the transferor;
- 13 (2) If a successor to any special declarant right is an affiliate of 14 a declarant, the transferor is jointly and severally liable with the 15 successor for any obligations or liabilities of the successor relating to 16 the planned community;
- (3) If a transferor retains any special declarant rights, but transfers other special declarant rights to a successor who is not an affiliate of the declarant, the transferor is liable for any obligations or liabilities imposed on a declarant by sections 445.151 to 445.420 or by the declaration relating to the retained special declarant rights and arising after the transfer;
 - (4) A transferor has no liability for any act or omission or any

24 breach of a contractual or warranty obligation arising from the exercise
25 of a special declarant right by a successor declarant who is not an
26 affiliate of the transferor.

- 3. Unless otherwise provided in a mortgage instrument, deed of trust or other agreement creating a security interest, in case of foreclosure of a security interest, sale by a trustee under an agreement creating a security interest, tax sale, judicial sale or sale under bankruptcy code or receivership proceedings, of any units owned by a declarant or real estate in a planned community subject to development rights, a person acquiring title to all the property being foreclosed or sold, but only upon such person's request, succeeds to all special declarant rights related to that property held by that declarant, or only to any rights reserved in the declaration under section 445.215 and held by that declarant to maintain models, sales offices and signs. The judgment or instrument conveying title shall provide for transfer of only the special declarant rights requested.
- 40 4. Upon foreclosure of a security interest, sale by a trustee under an agreement creating a security interest, tax sale, judicial sale or sale under bankruptcy code or receivership proceedings, of all interests in a planned community owned by a declarant:
 - (1) The declarant ceases to have any special declarant rights; and
- 45 (2) The period of declarant control terminates unless the 46 judgment or instrument conveying title provides for transfer of all 47 special declarant rights held by that declarant to a successor declarant.
- 5. The liabilities and obligations of a person who succeeds to special declarant rights are as follows:
- 50 (1) A successor to any special declarant right who is an affiliate 51 of a declarant is subject to all obligations and liabilities imposed on the 52 transferor by sections 445.151 to 445.420 or by the declaration;
- 53 (2) A successor to any special declarant right, other than a 54 successor described in subdivision (3) or (4) of this subsection, who is 55 not an affiliate of a declarant, is subject to all obligations and liabilities 56 imposed by sections 445.151 to 445.420 or the declaration:
- 57 (a) On a declarant which relate to the successor's exercise or 58 nonexercise of special declarant rights; or
 - (b) On the declarant's transferor, other than:
- a. Misrepresentations by any previous declarant;

b. Warranty obligations on improvements made by any previous
declarant, or made before the planned community was created;

- 63 c. Breach of any fiduciary obligation by any previous declarant 64 or the previous declarant's appointees to the executive board; or
- d. Any liability or obligation imposed on the transferor as a few result of the transferor's acts or omissions after the transfer;
- (3) A successor to only a right reserved in the declaration to maintain models, sales offices and signs, may not exercise any other special declarant right, and is not subject to any liability or obligation as a declarant, except the obligation to provide an original sale certificate and any liability arising as a result thereof; and
- 72 (4) A successor to all special declarant rights held by the 73 successor's transferor who succeeded to those rights under a deed or 74 other instrument of conveyance in lieu of foreclosure or a judgment or 75 instrument conveying title under subsection 3 of this section may 76 declare such successor's intention in a recorded instrument to hold 77 those rights solely for transfer to another person. Thereafter, until 78 transferring all special declarant rights to any person acquiring title to 79 any unit or real estate subject to development rights owned by the 80 successor, or until recording an instrument permitting exercise of all 81 those rights, that successor may not exercise any of those rights other 82 than any right held by the successor's transferor to control the 83 executive board in accordance with the provisions of subsection 4 of 84 section 445.303 for the duration of any period of declarant control, and 85 any attempted exercise of those rights is void. So long as a successor 86 declarant may not exercise special declarant rights under this 87 subsection, the successor declarant is not subject to any liability or 88 obligation as a declarant other than liability for the successor 89 declarant's acts and omissions under subsection 4 of section 445.303.
- 6. Nothing in this section subjects any successor to a special declarant right to any claims against or other obligations of a transferor declarant, other than claims and obligations arising under sections 445.151 to 445.420 or the declaration.

445.305. Except for a planned community consisting exclusively 2 of nonresidential units, if entered into before the executive board 3 elected by the unit owners under subsection 5 of section 445.303 takes 4 office:

5 (1) Any management contract, employment contract or lease of 6 recreational or parking areas or facilities;

7 (2) Any other contract or lease between the association and a 8 declarant or an affiliate of a declarant; or

9 (3) Any contract or lease that is not bona fide or was 10 unconscionable to the unit owners at the time entered into under the 11 circumstances then prevailing.

May be terminated without penalty by the association at any time after the executive board elected by the unit owners under subsection 5 of section 445.303 takes office upon not less than ninety days' notice to the other party. This section does not apply to any lease, the termination of which would terminate the planned community or reduce its size, unless the real estate subject to that lease was included in the planned community for the purpose of avoiding the right of the association to terminate a lease under this section.

445.306. 1. The bylaws of the association must provide for:

2 (1) The number of members of the executive board and the titles 3 of the officers of the association;

4 (2) Election by the executive board of a president, treasurer, 5 secretary and any other officers of the association the bylaws specify;

6 (3) The qualifications, powers and duties, terms of office, and 7 manner of electing and removing executive board members and officers 8 and filling vacancies;

9 (4) Which, if any, of its powers the executive board or officers 10 may delegate to other persons or to a managing agent;

11 (5) Which of its officers may prepare, execute, certify and record 12 amendments to the declaration on behalf of the association; and

13 (6) The method of amending the bylaws by vote or agreement of 14 unit owners to which at least a majority of the votes in the association 15 are allocated.

2. Subject to the provisions of the declaration, the bylaws may provide for any other matters the association deems necessary and appropriate.

445.307. 1. Except to the extent provided by the declaration, 2 subsection 2 of this section, or subsection 8 of section 445.313, the 3 association is responsible for maintenance, repair and replacement of 4 the common elements, and each unit owner is responsible for

5 maintenance, repair and replacement of the owner's unit. Each unit 6 owner shall afford to the association and the other unit owners, and to 7 their agents or employees, access through the owner's unit reasonably 8 necessary for those purposes. If damage is inflicted on the common 9 elements, or on any unit through which access is taken, the unit owner 10 responsible for the damage, or the association if it is responsible, is 11 liable for the prompt repair thereof.

2. In addition to the liability that a declarant has under sections
445.151 to 445.420 as a unit owner, the declarant alone is liable for all
expenses in connection with real estate subject to development rights.
No other unit owner and no other portion of the planned community is
subject to a claim for payment of those expenses. Unless the declaration
provides otherwise, any income or proceeds from real estate subject to
development rights inures to the declarant. In the event all
development rights have expired with respect to any real estate, the
declarant remains liable for all expenses of that real estate unless, upon
expiration, the declaration provides that such real estate becomes
common elements or units.

445.308. A meeting of the association must be held at least once each year. Special meetings of the association may be called by the president, a majority of the executive board or by unit owners having twenty percent, or any lower percentage specified in the bylaws, of the votes in the association. Not less than ten nor more than sixty days in advance of any meeting, the secretary or other officer specified in the bylaws shall cause notice to be hand-delivered or sent prepaid by United States mail to the mailing address of each unit or to any other mailing address designated in writing by the unit owner. The notice of any meeting must state the time and place of the meeting and the items on the agenda, including the general nature of any proposed amendment to the declaration or bylaws, any budget changes, and any proposal to remove a director or officer.

445.309. 1. Unless the bylaws provide otherwise, a quorum is present throughout any meeting of the association if persons entitled to cast twenty percent of the votes which may be cast for election of the executive board are present in person or by proxy at the beginning of the meeting.

2. Unless the bylaws specify a larger percentage, a quorum is

7 deemed present throughout any meeting of the executive board if 8 persons entitled to cast fifty percent of the votes on that board are 9 present at the beginning of the meeting.

445.310. 1. If only one of the multiple owners of a unit is present 2 at a meeting of the association, such multiple owner is entitled to cast 3 all the votes allocated to that unit. If more than one of the multiple 4 owners are present, the votes allocated to that unit may be cast only in 5 accordance with the agreement of a majority in interest of the multiple 6 owners, unless the declaration expressly provides otherwise. There is 7 majority agreement if any one of the multiple owners casts the votes 8 allocated to that unit without protest being made promptly to the 9 person presiding over the meeting by any of the other owners of the 10 unit.

- 2. Votes allocated to a unit may be cast under a proxy or mail ballot duly executed by a unit owner. If a unit is owned by more than one person, each owner of the unit may vote or register protest to the casting of votes by the other owners of the unit through a duly executed proxy or mail ballot. A unit owner may not revoke a proxy or mail ballot given under this section except by actual notice of revocation to the person presiding over a meeting of the association. A proxy is void if it is not dated or purports to be revocable without notice. A proxy terminates one year after its date, unless it specifies a shorter term.
- 3. If the declaration requires that votes on specified matters affecting the planned community be cast by lessees rather than unit 22 owners of leased units:
- 23 (1) The provisions of subsections 1 and 2 of this section apply to 24 lessees as if they were unit owners;
- (2) Unit owners who have leased their units to other persons may
 not cast votes on those specified matters; and
- (3) Lessees are entitled to notice of meetings, access to records, and other rights respecting those matters as if they were unit owners. Unit owners must also be given notice, in the manner provided in section 445.308, of all meetings at which lessees may be entitled to 31 vote.
- 4. No votes allocated to a unit owned by an owner who is delinquent in the payment of assessments may be cast, and no such unit shall be counted for the purpose of determining the presence of a

35 quorum at any meeting of the association.

445.311. 1. No unit owner is liable for an injury or damage 2 arising out of the condition or use of the common elements, except to 3 the extent of such unit owner's negligent act or omission. Neither the 4 association nor any unit owner except the declarant is liable for that 5 declarant's torts in connection with any part of the planned community 6 which that declarant has the responsibility to maintain.

- 2. An action alleging a wrong done by the association, including an action arising out of the conditions or use of the common elements, may be maintained against the association and not against any unit owner. If the wrong occurred during any period of declarant control and the association gives the declarant reasonable notice of and an opportunity to defend against the action, the declarant who then controlled the association is liable to the association or to any unit owner:
- 15 (1) For all tort losses not covered by insurance suffered by the 16 association or that unit owner; and
- 17 (2) For all costs which the association would not have incurred 18 but for a breach of contract or other wrongful act or omission.
- 19 Whenever the declarant is liable to the association under this section,
- 20 the declarant is also liable for all litigation expenses, including
- 21 reasonable attorney's fees, incurred by the association. Any statute of
- 22 limitation affecting the association's right of action under this section
- 23 is tolled until the period of declarant control terminates. A unit owner
- 24 is not precluded from bringing an action contemplated by this section
- 25 because the unit owner is a unit owner or a member or officer of the
- 26 association. Liens resulting from judgments against the association are
- 27 governed by section 445.317.
- 3. A unit owner shall be liable for any claim, damage or judgment entered as a result of the use or operation of the unit owner's unit, or a caused by the unit owner's own conduct.
- 4. Notwithstanding the provisions of subsection 1 of section 32 445.303, no member of the executive board or officer of a planned 33 community, who serves without compensation other than 34 reimbursement for actual expenses incurred, is liable to any person 35 including a unit owner for tort losses resulting from the exercise of 36 judgment or discretion in connection with governing or operating the

37 planned interest community, unless the act or omission involves conduct 38 that is actually or deliberately intended to cause harm or which shows 39 an utter indifference to or conscious disregard for the safety of others 40 or their property.

445.312. 1. Portions of the common elements may be conveyed or subjected to a security interest, and the nature of the use of portions of the common elements and improvements thereon may be charged, by the association if persons entitled to cast at least eighty percent of the votes in the association, including eighty percent of the votes allocated to units not owned by a declarant, or any larger percentage the declaration specifies, agree to that action; but all the owners of units to which any limited common element is allocated must agree in order to convey that limited common element or subject it to a security interest. The declaration may specify a smaller percentage only if all the units are restricted exclusively to nonresidential uses. Proceeds of the sale are an asset of the association, but the proceeds of the sale of limited common elements shall be distributed equitably among the owners of units to which the limited common elements were allocated.

2. An agreement to convey common elements or subject them to a security interest must be evidenced by the execution of an agreement, or ratifications thereof, in the same manner as a deed, by the requisite number of unit owners. The agreement must specify a date after which the agreement will be void unless recorded before that date. The agreement and all ratifications thereof must be recorded in every county in which a portion of the planned community is situated, and is effective only upon recordation.

3. The association, on behalf of the unit owners, may contract to convey an interest in a planned community under subsection 1 of this section, but the contract is not enforceable against the association until approved under subsections 1 and 2 of this section. Thereafter, the association has all powers necessary and appropriate to effect the conveyance or encumbrance, including the power to execute deeds or other instruments.

4. Any purported conveyance, encumbrance, judicial sale or other involuntary transfer of common elements, unless made under this section is void.

33

5. A conveyance or encumbrance of common elements under this

34 section does not deprive any unit of its rights of access and support.

445.313. 1. Commencing not later than the time of the first conveyance of a unit to a person other than a declarant, the association shall maintain, to the extent reasonably available:

- 4 (1) Property insurance on the common elements and on property 5 which must become common elements, insuring against all risks of 6 direct physical loss commonly insured against, in the case of a 7 conversion building, against fire and extended coverage perils. The 8 total amount of insurance after application of any deductibles shall be 9 not less than eighty percent of the actual cash value of the insured 10 property at the time the insurance is purchased and at each renewal 11 date, exclusive of land, excavations, foundations and other items 12 normally excluded from property policies; and
- (2) Commercial general liability insurance against claims and liabilities arising in connection with the ownership, existence, use or management of the property an amount, if any, specified by the planned community instruments or otherwise deemed sufficient in the judgment of the executive board, insuring the executive board, the unit owners' association, the management agent and their respective employees, agents and all persons acting as agents. The declarant shall be included as an additional insured in the capacity of unit owner and board member. The unit owners shall be included as additional insureds but only for claims and liabilities arising in connection with the ownership, existence, use or management of the common elements. The insurance shall cover claims of one or more insured parties against other insured parties.
- 26 2. In the case of a building containing units having horizontal boundaries described in the declaration, the insurance maintained under subdivision (1) of subsection 1 of this section, to the extent reasonably available, shall include the units, but need not include improvements and betterments installed by unit owners, but if they are covered, any increased charge shall be assessed by the association to those owners.
- 33 3. If the insurance described in subsections 1 and 2 of this section 34 is not reasonably available, the association promptly shall cause notice 35 of that fact to be hand-delivered or sent prepaid by United States mail 36 to all unit owners. The declaration may require the association to carry

37 any other insurance, and the association in any event may carry any 38 other insurance it deems appropriate to protect the association or the 39 unit owners.

- 40 4. Insurance policies carried under subsections 1 and 2 of this 41 section must provide that:
- 42 (1) Each unit owner is an insured person under the policy with 43 respect to liability arising out of the unit owner's interest in the 44 common elements or membership in the association;
- 45 (2) The insurer waives its right to subrogation under the policy 46 against any unit owner or member of the unit owner's household;
- 47 (3) No act or omission by any unit owner, unless acting within the 48 scope of the unit owner's authority on behalf of the association, will 49 void the policy or be a condition to recovery under the policy; and
- 50 (4) If, at the time of a loss under the policy, there is other 51 insurance in the name of a unit owner covering the same risk covered 52 by the policy, the association's policy provides primary insurance.
- 53 5. Any loss covered by the property policy under subdivision (1) 54 of subsection 1 of this section and under subsection 2 of this section 55 must be adjusted with the association, but the insurance proceeds for 56 that loss are payable to any insurance trustee designated for that 57 purpose, or otherwise to the association, and not to any holder of a 58 security interest. The insurance trustee or the association shall hold 59 any insurance proceeds in trust for the association unit owners and 60 lienholders as their interests may appear. Subject to the provisions of 61 subsection 7 of this section, the proceeds must be disbursed first for the 62 repair or restoration of the damaged property, and the association unit 63 owners and lienholders are not entitled to receive payment of any 64 portion of the proceeds unless there is a surplus of proceeds after the 65 property has been completely repaired or restored, or the planned community is terminated. 66
- 6. An insurance policy issued to the association does not prevent a unit owner from obtaining insurance for the unit owner's own benefit.
- 7. An insurer that has issued an insurance policy under this section shall issue certificates or memoranda of insurance to the association and, upon written request, to any unit owner or holder of a security interest. The insurer issuing the policy may not cancel or refuse to renew it until thirty days after notice of the proposed

- 74 cancellation or nonrenewal has been mailed to the association, each 75 unit owner and holder of a security interest whom a certificate or 76 memorandum of insurance have been issued at their respective last 77 known addresses.
- 8. Any portion of the planned community for which insurance is required under this section which is damaged or destroyed shall be repaired or replaced promptly by the association unless:
- 81 (1) The planned community is terminated, in which case section 82 445.210 applies;
- 83 (2) Repair or replacement would be illegal under any state or 84 local ordinance governing health or safety; or
- 85 (3) Eighty percent of the unit owners, including every owner of 86 a unit or assigned limited common element which will not be rebuilt, 87 vote not to rebuild.
- 9. The cost of repair or replacement in excess of insurance proceeds and reserves is a common expense.
- 90 10. If the entire planned community is not repaired or replaced:
- 91 (1) The insurance proceeds attributable to the damaged common 92 elements must be used to restore the damaged area to a condition 93 compatible with the remainder of the planned community;
- 94 (2) The insurance proceeds attributable to units and limited 95 common elements which are not rebuilt must be distributed to the 96 owners of those units and the owners of the units to which those limited 97 common elements were allocated, or to lienholders, as their interests 98 may appear; and
- 99 (3) The remainder of the proceeds must be distributed to all the 100 unit owners or lienholders, as their interests may appear, in proportion 101 to the common expense liabilities of all the units.
- 11. If the unit owners vote not to rebuild any unit, that unit's allocated interests are automatically reallocated upon the vote as if the unit had been condemned under subsection 1 of section 445.157, and the association promptly shall prepare, execute and record an amendment to the declaration reflecting the reallocations.
- 12. The provisions of this section may be varied or waived in the 108 case of a planned community all of whose units are restricted to 109 nonresidential use.
 - 445.314. Unless otherwise provided in the declaration, any

 $2 \ \ surplus \ funds \ of the \ association \ remaining \ after \ payment \ of \ or \ provision$

- 3 for common expenses and any prepayment of reserves must be paid to
- 4 the unit owners in proportion to their common expense liabilities or
- 5 credited to them to reduce their future common expense assessments.
- 445.315. 1. Until the association makes a common expense
- 2 assessment, the declarant shall pay all common expenses. After any
- 3 assessment has been made by the association, assessments must be made
- 4 at least annually, based on a budget adopted at least annually by the
- 5 association.
- 2. Except for assessments under subsections 3, 4, and 5 of this
- 7 section, all common expenses must be assessed against all the units in
- 8 accordance with the allocation set forth in the declaration under
- 9 subsection 1 of section 445.207. Any past due common expense
- 10 assessment or installment thereof bears interest at the rate established
- 11 by the association not exceeding eighteen percent per year.
- 12 3. To the extent required by the declaration:
- 13 (1) Any common expense associated with the maintenance, repair
- 14 or replacement of a limited common element must be assessed against
- 15 the units to which that limited common element is assigned, equally, or
- 16 in any other proportion that the declaration provides;
- 17 (2) Any common expense or portion thereof benefiting fewer than
- 18 all of the units must be assessed exclusively against the units benefited;
- 19 and
- 20 (3) The costs of insurance must be assessed in proportion to risk
- 21 and the costs of utilities must be assessed in proportion to usage.
- 4. Assessments to pay a judgment against the association may be
- 23 made only against the units in the planned community at the time the
- 24 judgment was entered, in proportion to their common expense
- 25 liabilities.
- 5. If any common expense is caused by the misconduct of any unit
- 27 owner, the association may assess that expense exclusively against such
- 28 unit owner's unit.
- 29 6. If common expense liabilities are reallocated, common expense
- 30 assessments and any installment thereof not yet due shall be
- 31 recalculated in accordance with the reallocated common expense
- 32 liabilities.
- 33 7. The purchaser of a unit in a planned community at a judicial

foreclosure sale, or a mortgagee who receives title to a unit by deed in lieu of foreclosure or judgment by foreclosure or otherwise takes possession under court order under chapter 443, RSMo, shall have the duty to pay the unit owner's proportionate share of the common expenses for the unit assessed from and after the first day of the month after the date of the judicial foreclosure sale, delivery of the deed in lieu of foreclosure, entry of a judgment in foreclosure, or taking of possession under such court order.

445.316. 1. The association has a statutory lien on a unit for any 2 assessment levied against that unit for fines imposed against its unit 3 owner from the time the assessment or fine becomes due. The 4 association's lien may be foreclosed in like manner as a mortgage on 5 real estate or a power of sale under chapter 443, RSMo. Unless the 6 declaration otherwise provides, fees, charges, late charges, fines and 7 interest charged under subdivisions (10), (11), and (12) of subsection 1 8 of section 445.302 are enforceable as assessments under this section. If 9 an assessment is payable in installments, the lien is for the full amount 10 of the assessment from the time the first installment thereof becomes 11 due, together with such annual assessments as may become payable in 12 the future. No unit owner may exempt such unit owner from liability 13 for payment of any assessment levied against the unit owner's unit by 14 waiver of the use or enjoyment of any of the common elements or 15 facilities or by abandonment of the unit or otherwise, and no unit owner 16 shall be entitled to an offset, deduction or waiver of assessments or 17 other charges levied and lawfully assessed by the association.

- 2. A lien under this section is prior to all other liens and 19 encumbrances on a unit except:
- 20 (1) Liens and encumbrances recorded before the recordation of 21 the declaration;
- 22 (2) A first security interest or refinancing thereof on the unit 23 recorded before the date on which the assessment sought to be enforced 24 became delinquent; and
- 25 (3) Liens for real estate taxes and other governmental 26 assessments or charges against the unit. This lien is also prior to a 27 security interest described in subdivision (2) of this subsection to the 28 extent of the common expense assessments based on the periodic budget 29 adopted by the association under subsection 1 of section 445.315 which

30 would have to become due in the absence of acceleration during the six 31 months immediately preceding institution of an action to enforce the 32 lien or collect the debt; provided that the association shall not be 33 entitled to this lien priority if it exercises its right to foreclose the lien 34 as provided in subsection 1 of this section. In addition to the lien 35 priority of this subdivision, the association shall be entitled to any costs 36 and reasonable attorney's fees incurred in the collection of the unpaid 37 assessment provided by the association, when any portion of the 38 assessment or installment thereof has been delinquent for at least sixty 39 days subsequent to August 28, 2008, the association sends a notice by 40 return receipt mail, stating the amount of the delinquency, to the unit 41 owner and the holder of a first security interest, provided that such 42 holder has informed the association of its name and mailing address; 43 and at least thirty days prior to initiating a proceeding to enforce the 44 association's lien under subsection 1 of this section, the association 45 shall send a notice by return receipt mail, stating its intention to file 46 such action, to the holder of a first security interest, provided that the 47 holder has informed the association of its name and mailing address. 48 This subsection does not affect the priority of mechanic's or materialmen's liens, or the priority of liens for other assessments made by the association. The lien under this section is not subject to the provisions of section 513.475, RSMo. 51

- 3. Unless the declaration otherwise provides, if two or more associations have liens for assessments created at any time on the same real estate, those liens have equal priority.
- 4. Recording of the declaration constitutes record notice and perfection of the lien. No further recordation of any claim of lien for assessment under this section is required.
- 58 5. A lien for unpaid assessments is extinguished unless 59 proceedings to enforce the lien are instituted within three years after 60 the full amount of the assessments becomes due.
- 6. This section does not prohibit actions to recover sums for 62 which subsection 1 of this section creates a lien, or prohibit an 63 association from taking a deed in lieu of foreclosure.
- 7. A judgment or decree in any action brought under this section must include costs and reasonable attorney's fees for the prevailing party.

8. The association upon written request shall furnish to a unit of owner a recordable statement setting forth the amount of unpaid assessments against such owner's unit. The statement must be furnished within ten business days after receipt of the request and is binding on the association, the executive board and every unit owner.

445.317. 1. Except as provided in subsection 2 of this section, a 2 judgment for money against the association if recorded is not a lien on 3 the common elements, but is a lien in favor of the judgment lienholder 4 against all of the units in the planned community at the time the 5 judgment was entered. No other property of a unit owner is subject to 6 the claims of creditors of the association.

2. If the association has granted a security interest in the security common elements to a creditor of the association under section 445.312, the holder of that security interest shall exercise its right against the common elements before its judgment lien on any unit may be enforced.

3. Whether perfected before or after the creation of the planned community, if a lien other than a security interest, including a judgment lien or lien attributable to work performed or materials supplied before creation of the planned community, becomes effective against two or more units, the unit owner of an affected unit may pay to the lienholder the amount of the lien attributable to the unit owner's unit, and the lienholder, upon receipt of payment, promptly shall deliver a release of the lien covering that unit. The amount of the payment must be proportionate to the ratio which that unit owner's common expense liability bears to the common expense liabilities of all unit owners whose units are subject to the lien. After payment, the association may not assess or have a lien against that unit owner's unit for any portion of the common expenses incurred in connection with that lien.

4. A judgment against the association must be indexed in the name of the planned community and the association, and, when so indexed, is notice of the lien against the units.

445.318. The association shall keep financial records sufficiently detailed to enable the association to comply with section 445.409. All financial and other records shall be made reasonably available for examination by any unit owner and the unit owner's authorized agents.

445.319. With respect to a third person dealing with the 2 association in the association's capacity as a trustee, the existence of

3 trust powers and their proper exercise by the association may be
4 assumed without inquiry. A third person is not bound to inquire
5 whether the association has power to act as trustee or is properly
6 exercising trust powers. A third person, without actual knowledge that
7 the association is exceeding or improperly exercising its powers, is fully
8 protected in dealing with the association as if it possessed and properly
9 exercised the powers it purports to exercise. A third person is not
10 bound to assure the proper application of trust assets paid or delivered
11 to the association in its capacity as trustee.

445.401. 1. Sections 445.401 to 445.420 apply to all units subject 2 to sections 445.151 to 445.420, except as provided in subsection 2 of this 3 section or as modified or waived by agreement of purchasers of units in 4 a planned community in which all units are restricted to nonresidential 5 use.

6 2. Neither an original sale certificate nor a resale certificate need 7 be prepared or delivered in the case of:

- 8 (1) A gratuitous disposition of a unit;
- 9 (2) A disposition under court order;
- 10 (3) A disposition by a government or governmental agency;
- 11 (4) A disposition by foreclosure or deed in lieu of foreclosure;
- 12 (5) A disposition to a dealer;
- 13 (6) A disposition that may be canceled at any time and for any 14 reason by the purchaser without penalty; or
- 15 (7) A disposition of a unit restricted to nonresidential purposes.

445.402. 1. Except as provided in subsection 2 of this section, a 2 declarant, prior to the offering of any interest in a unit to the public, 3 shall prepare an original sale certificate conforming to the 4 requirements of sections 445.403, 445.404, 445.405, and 445.406.

- 2. A declarant may transfer responsibility for preparation of all or a part of the original sale certificate to a successor declarant or to a dealer. In the event of any such transfer, the transferor shall provide the transferee with any information necessary to enable the transferee to fulfill the requirements of subsection 1 of this section.
- 3. Any declarant or dealer who offers a unit to a purchaser shall deliver an original sale certificate in the manner prescribed in section 445.408. The person who prepared all or a part of the original sale certificate is liable under sections 445.408 and 445.417 for any false or

misleading statement set forth therein or for any omission of material fact therefrom with respect to that portion of the original sale certificate which the declarant prepared. If a declarant did not prepare any part of an original sale certificate that such declarant delivers, such declarant is not liable for any false or misleading statement set forth therein or for any omission of material fact therefrom unless such declarant had actual knowledge of the statement or omission or, in the exercise of reasonable care, should have known of the statement or omission.

4. If a unit is part of two or more planned communities or is part of a planned community and is part of any other real estate regime in connection with the sale of which the delivery of an original sale certificate is required under the laws of this state, a single original sale certificate conforming to the requirements of sections 445.403, 445.404, 445.405, and 445.406 as those requirements relate to each planned community in which the unit is located, and to any other requirements imposed under the laws of this state, may be prepared and delivered in lieu of providing two or more original sale certificates.

445.403. 1. Except as provided in subsection 2 of this section, an 2 original sale certificate must contain and fully and accurately disclose:

- 3 (1) The names and principal addresses of the declarant and of the 4 planned community, and a statement that the community is a planned 5 community;
- 6 (2) A general description of the planned community, including, to 7 the extent possible, the types, number, and declarant's schedule of 8 commencement and completion of construction of buildings and 9 amenities that declarant anticipates including in the planned 10 community;
 - (3) The number of units in the planned community;

11

(4) Copies and a brief narrative description of the significant features of the declaration, other than the plats and plans, and any other recorded covenants, conditions, restrictions, and reservations affecting the planned community; the bylaws, and any rules or regulations of the association; copies of any contracts and leases to be signed by purchasers at closing; and a brief narrative description of any contracts or leases that will or may be subject to cancellation by the association under section 445.305;

- 20 (5) Any current balance sheet and a projected budget for the association, including reasonable reserves for repair and replacement, 22 either within or as an exhibit to the original sale certificate, for one 23 year after the date of the first conveyance to a purchaser, and 24 thereafter the current budget of the association, a statement of who 25 prepared the budget, and a statement of the budget's assumptions 26 concerning occupancy and inflation factors. The budget must include, 27 without limitation:
- 28 (a) A statement of the amount, or a statement that there is no 29 amount, included in the budget as a reserve for repairs and 30 replacement;
 - (b) A statement of any other reserves;

31

- 32 (c) The projected common expense assessment by category of 33 expenditures for the association; and
- 34 (d) The projected monthly common expenses assessment for each 35 type of unit;
- (6) Any services, including but not limited to water or sewer district or utility provider owned or controlled by declarant, and any private roadway that serves other property in addition to the planned community, not reflected in the budget that the declarant provides, or expenses that said declarant pays, and that said declarant expects may become at any subsequent time a common expense of the association and the projected common expense assessment attributable to each of those services or expenses for the association and for each type of unit;
- 44 (7) Any initial or special fee due from the purchaser at closing, 45 together with a description of the purpose and method of calculating 46 the fee;
- 47 (8) A description of any liens, defects, or encumbrances on or 48 affecting the title to the planned community including but not limited 49 to subsurface rights to minerals, natural gas storage, and other such 50 rights;
- 51 (9) A description of any financing offered or arranged by the 52 declarant;
- 53 (10) The terms and significant limitations of any warranties 54 provided by the declarant, including statutory warranties, and 55 limitations on the enforcement thereof or on damages;
- 56 (11) A statement that:

- 57 (a) Within ten days after receipt of an original sale certificate 58 and before conveyance, the seller may cancel any contract for purchase 59 of a unit from a declarant;
- 60 (b) If a purchaser receives the original sale certificate more than 61 ten days before signing a contract, such purchaser cannot cancel the 62 contract;
- 63 (12) A statement of any unsatisfied judgments or pending suits 64 against the association, and the status of any pending suits material to 65 the planned community of which a declarant has actual knowledge;
- 66 (13) A statement that any deposit made in connection with the 67 purchase of a unit will be held in an escrow until closing and will be 68 returned to the purchaser if the purchaser cancels the contract under 69 section 445.408, together with the name and address of the escrow agent;
- 70 (14) Any restraints on alienation of any portion of the planned 71 community;
- 72 (15) A description of the insurance coverage provided for the 73 benefit of unit owners;
- 74 (16) Any current or expected fees or charges to be paid by unit 75 owners for the use of any common elements and other facilities related 76 to the planned community;
- (17) A list of all improvements contemplated in the planned community which the declarant reserves the right not to build, and a list of all improvements contemplated in the planned community which the declarant is obligated to build, as provided in sections 445.418 and 445.419;
- 82 (18) Any contingencies related to development or sales 83 achievements of the planned community contained in financial 84 arrangements which declarant has obtained for all improvements 85 labeled "SHALL BE BUILT" under section 445.419, but incomplete at 86 time of the execution of the sale contract;
- 87 (19) A brief narrative description of any zoning and other land 88 use requirements affecting the planned community; and
- (20) All unusual and material circumstances, features and characteristics of the planned community and the units, including but not limited to natural features, view, any additional charges or premiums for a particular unit, and any material fact relating to adjacent property of which the declarant has or should have knowledge.

- 2. If a planned community composed of not more than twelve units is not subject to any development rights, and no power is reserved to a declarant to make the planned community part of a larger planned community, group of planned communities, or other real estate, an original sale certificate may, but need not, include the information otherwise required by subdivisions (9), (10), (15), (16), (17), (18), and (19) of subsection 1 of this section, and the narrative descriptions of documents required by subdivision (4) of subsection 1 of this section.
- 3. A declarant promptly shall amend the original sale certificate to report any material change in the information required by this section.
 - 445.404. If the declaration provides that a planned community is 2 subject to any development rights, the original sale certificate must 3 disclose, in addition to the information required by section 445.403:
 - 4 (1) The maximum number of units, the maximum number of units 5 per acre, and the estimated completion date, to the extent reasonably 6 ascertainable, which may be created;
 - 7 (2) A statement of the extent of nonresidential use to which any 8 real estate or unit may be put, regardless of when added to the planned 9 community;
- 10 (3) If any of the units that may be built within real estate subject
 11 to development rights are not to be restricted exclusively to residential
 12 use, a statement, with respect to each portion of that real estate, of the
 13 maximum percentage of the real estate areas, and the maximum
 14 percentage of the floor areas of all units that may be created therein,
 15 that are not restricted exclusively to residential use;
- 16 (4) A brief narrative description of any development rights
 17 reserved by a declarant and of any conditions relating to or limitations
 18 upon the exercise of development rights, including a description of
 19 improvements labeled "SHALL BE BUILT" and "NEED NOT BE BUILT"
 20 as provided by the plat;
- 21 (5) A statement of the maximum extent to which each unit's 22 allocated interests may be changed by the exercise of any development 23 right described in subdivision (3) of this section;
- 24 (6) A statement of the extent to which any buildings or other 25 improvements that may be erected under any development right in any 26 part of the planned community will be compatible with existing

27 buildings and improvements in the planned community in terms of 28 architectural style, quality of construction and size, or a statement that 29 no assurances are made in those regards;

- 30 (7) General descriptions of all other improvements that may be 31 made and limited common elements that may be created within any part 32 of the planned community under any development right reserved by the 33 declarant, or a statement that no assurances are made in that regard;
- 34 (8) A statement of any limitations as to the locations of any 35 building or other improvement that may be made within any part of the 36 planned community under any development right reserved by the 37 declarant, or a statement that no assurances are made in that regard;
- 38 (9) A statement that any limited common elements created under 39 any development right reserved by the declarant will be of the same 40 general types and sizes as the limited common elements within other 41 parts of the planned community, or a statement of the types and sizes 42 planned, or a statement that no assurances are made in that regard;
- (10) A statement that the proportion of limited common elements to units created under any development right reserved by the declarant will be approximately equal to the proportion existing within other parts of the planned community, or a statement of any other assurances in that regard, or a statement that no assurances are made in that regard;
- 49 (11) A statement that all restrictions in the declaration affecting 50 use, occupancy and alienation of units will apply to any units created 51 under any development right reserved by the declarant, or a statement 52 of any differentiations that may be made as to those units, or a 53 statement that no assurances are made in that regard; and
- 54 (12) A statement of the extent to which any assurances made 55 under this section apply or do not apply in the event that any 56 development right is not exercised by the declarant.
- 445.405. If the declaration provides that ownership or occupancy 2 of any units is or may be in time shares, the original sale certificate 3 shall disclose, in addition to the information required by section 4 445.403:
- 5 (1) The number and identity of units in which time shares may be 6 created;
- 7 (2) The total number of time shares that may be created;

8 (3) The minimum duration of any time shares which may be 9 created; and

10 (4) The extent to which the creation of time shares will or may 11 affect the enforceability of the association's lien for assessments 12 provided in section 445.316.

445.406. 1. The original sale certificate statement of a planned 2 community containing any conversion building must contain, in 3 addition to the information required by section 445.403:

4 (1) A statement of work done, including the nature thereof, on the 5 foundation, structural members, roof, chimney, gutters and downspouts, 6 exterior and interior walls, ceilings, floors, windows, attic and wall 7 insulation, including installer's statement of present "R" value, sewers 8 and stacks, plumbing system and related fixtures, electrical system and 9 related fixtures, and furnace and heating system, including the 10 manufacturer's energy efficiency ratio of any new heating or 11 refrigeration equipment;

12 (2) A statement by the declarant of the expected useful life of 13 each item reported on in subdivision (1) of this subsection or a 14 statement that no representations are made in that regard; and a list of 15 any outstanding notices of uncured violations of building code or other 16 municipal regulations.

2. This section applies only to buildings containing units that may be occupied for residential use.

445.407. If an interest in a planned community is currently registered with the United States Securities and Exchange Commission, a declarant satisfies all requirements relating to the preparation of an original sale certificate of sections 445.151 to 445.420 if such declarant delivers to the purchaser a copy of the original sale certificate filed with the Securities and Exchange Commission. An interest in a planned community is not a security under the provisions of the laws of this state.

445.408. 1. A person required to deliver an original sale certificate under subsection 3 of section 445.402 shall provide a purchaser with the original sale certificate and all amendments thereto before conveyance of that unit, and not later than the date of any contract of sale. Unless a purchaser is given the original sale certificate more than ten days before execution of a contract for the purchase of

7 a unit, the purchaser, before conveyance, may cancel the contract 8 within ten days after first receiving the original sale certificate.

- 2. If a purchaser elects to cancel a contract under subsection 1 of this section, such purchaser may do so by hand-delivering notice thereof to the offeror or by mailing notice thereof by prepaid United States mail to the offeror or to the offeror's agent for service of process. Cancellation is without penalty, and all payments made by the purchaser before cancellation shall be refunded promptly.
- 445.409. 1. Except in the case of a sale where delivery of an 2 original sale certificate is required, or unless exempt under subsection 2 of section 445.401, a unit owner shall furnish to a purchaser before the 4 earlier of conveyance or transfer of the right to possession of a unit, a 5 resale certificate containing: a copy of the declaration, other than the 6 plats and plans, the bylaws, and the rules or regulations of the 7 association. Such resale certificate shall disclose:
- 8 (1) The effect on the proposed disposition of any right of first 9 refusal or other restraint on the free alienability of the unit held by the 10 association, and any restriction on the owner's right to use or occupy 11 the unit or to lease the unit to another person;
- 12 (2) The amount of the periodic common expense assessment and 13 any unpaid common expense assessment or special assessment currently 14 due and payable from the selling unit owner;
- 15 (3) Any other fees payable by unit owners;
- 16 (4) Any capital expenditures approved by the association for the 17 current and two next succeeding fiscal years;
- 18 (5) The amount of any reserves for capital expenditures and of 19 any portions of those reserves designated by the association for any 20 specified projects;
- 21 (6) The most recent regularly prepared balance sheet and income 22 and expense statement, if any, of the association;
- 23 (7) The current operating budget of the association;
- 24 (8) Any unsatisfied judgments against the association and the 25 status of any pending suits in which the association is a defendant;
- 26 (9) Any insurance coverage provided for the benefit of unit 27 owners:
- 28 (10) Whether the executive board has given or received any 29 written notice that any uses, occupancies, alterations or improvements

30 to the unit or to any limited common elements assigned thereto violate 31 any provision of the declaration;

- 32 (11) Whether the executive board has received written notice 33 from a governmental agency of any violation of environmental, health 34 or building codes with respect to the unit, the limited common elements 35 assigned thereto, or any other portion of the planned community; and
- 36 (12) The remaining term of any leasehold estate affecting the 37 planned community and the provisions governing any extension or 38 renewal thereof.
- 2. The association, within ten days after a request by a unit 40 owner, shall furnish a resale certificate containing the information 11 necessary to enable the unit owner to comply with this section. A unit 12 owner providing a certificate under subsection 1 of this section is not 12 liable to the purchaser for any erroneous information provided by the 14 association and included in the certificate.
- 3. A purchaser is not liable for any unpaid assessment or fee 46 greater than the amount set forth in the resale certificate prepared by 47 the association. A unit owner is not liable to a purchaser for the failure 48 or delay of the association to provide the resale certificate in a timely 49 manner, but the purchase contract is voidable by the purchaser until 50 the certificate has been provided and for five days thereafter or until 51 conveyance, whichever first occurs.
- 445.410. Any deposit made in connection with the purchase or reservation of a unit from a person required to deliver an original sale certificate under subsection 3 of section 445.402 shall be placed in escrow and held either in this state or in the state where the unit is located until refunded to purchaser under section 445.408 or the cancellation provided therein expires.
- 445.411. 1. In the case of a sale of a unit where delivery of an 2 original sale certificate is required under subsection 3 of section 3 445.402, a seller shall, before conveying a unit, record or furnish to the 4 purchaser, releases of all liens affecting that unit and any limited 5 common elements assigned thereto which the purchaser does not 6 expressly agree to take subject to or assume, or shall provide a surety 7 bond or substitute collateral for or insurance against the lien. This 8 subsection does not apply to any real estate which a declarant has the 9 right to withdraw.

- 10 2. Before conveying real estate to the association, the declarant 11 shall have that real estate released from:
- 12 (1) All liens the foreclosure of which would deprive unit owners 13 of the right of access to or easement of support of their units; and
- 14 (2) All other liens on that real estate unless the original sale 15 certificate describes certain real estate which may be conveyed subject 16 to liens in specified amounts.
- 445.412. 1. A declarant of a planned community containing 2 conversion buildings, and any dealer who intends to offer units in such 3 a planned community, shall give each of the residential tenants and any 4 residential subtenant in possession of a portion of a conversion building 5 notice of the conversion and provide those persons with the original 6 sale certificate no later than one hundred twenty days before the 7 tenants and any subtenant in possession are required to vacate. The 8 notice must set forth generally the rights of tenants and subtenants 9 under this section and shall be hand-delivered to the unit or mailed by 10 prepaid United States mail to the tenant and subtenant at the address 11 of the unit or any other mailing address provided by a tenant. No 12 tenant or subtenant may be required to vacate upon less than one 13 hundred twenty-days notice, except by reason of nonpayment of rent, 14 waste or conduct that disturbs other tenants' peaceful enjoyment of the 15 premises, and the terms of the tenancy may not be altered during that 16 period. Failure to give notice as required by this section is a defense to 17 an action for possession.
- 2. For sixty days after delivery or mailing of the notice described in subsection 1 of this section, the person required to give the notice shall offer to convey each unit or proposed unit occupied for residential use to the tenant who leases that unit. If a tenant fails to purchase the unit during that sixty-day period, the offeror may not offer to dispose of an interest in that unit during the following one hundred twenty days at a price or on terms more favorable to the offeree than the price or terms offered to the tenant. This subsection does not apply to any unit in a conversion building if that unit will be restricted exclusively to nonresidential use or the boundaries of the converted unit do not substantially conform to the dimensions of the residential unit before conversion.
 - 3. If a seller, in violation of subsection 2 of this section, conveys

a unit to a purchaser for value who has no knowledge of the violation, recordation of the deed conveying the unit extinguishes any right a tenant may have under subsection 2 of this section to purchase that unit if the deed states that the seller has complied with subsection 2 of this section, but does not affect the right of a tenant to recover damages from the seller for a violation of subsection 2 of this section.

4. If a notice of conversion specifies a date by which a unit or 38 proposed unit must be vacated, and otherwise complies with the 39 provisions of sections 441.050 and 441.060, RSMo, the notice also 40 constitutes notice to vacate specified by that statute.

5. Nothing in this section permits termination of a lease by a declarant in violation of its terms.

445.413. 1. Express warranties made by any seller to a purchaser 2 of a unit, if relied upon by the purchaser, are created as follows:

(1) Any affirmation of fact or promise which relates to the unit, 4 its use or rights appurtenant thereto, improvements that would directly 5 benefit the unit or the right to use or have the benefit of facilities not 6 located in the planned community, creates an express warranty that the 7 unit and related rights and uses will conform to the affirmation or 8 promise;

9 (2) Any model or description of the physical characteristics of the 10 planned community, including plans and specifications of or for 11 improvements, creates an express warranty that the planned community 12 will conform to the model or description;

13 (3) Any description of the quantity or extent of the real estate 14 comprising the planned community, including plats or surveys, creates 15 an express warranty that the planned community will conform to the 16 description, subject to customary tolerances; and

17 (4) A provision that a purchaser may put a unit only to a 18 specified use is an express warranty that the specified use is lawful.

2. Neither formal words, such as "warranty" or "guarantee", nor a specific intention to make a warranty, are necessary to create an express warranty of quality, but a statement purporting to be merely an opinion or commendation of the real estate or its value does not create a warranty.

3. Any conveyance of a unit transfers to the purchaser and all subsequent purchasers all express warranties of quality made by

26 previous sellers.

445.414. 1. A declarant and dealer warrants that a unit will be in 2 at least as good condition at the earlier of the time of the conveyance 3 or delivery of possession as it was at the time of contracting, reasonable 4 wear and tear excepted.

- 2. A declarant and a dealer impliedly warrants that a unit and the common elements in the planned community are suitable for the rodinary uses of real estate of its type and that any improvements made or contracted for by the declarant or dealer, or made by any person before the creation of the planned community, will be:
- 10 (1) Free from defective materials; and
- 11 (2) Constructed in accordance with applicable law, according to 12 sound engineering and construction standards and in a workmanlike 13 manner.
- 3. In addition, a declarant and a dealer warrants to a purchaser of a unit that may be used for residential use that an existing use, continuation of which is contemplated by the parties, does not violate applicable law at the earlier of the time of conveyance or delivery of possession.
- 19 4. Warranties imposed by this section may be excluded or 20 modified as specified in section 445.415.
- 5. For purposes of this section, improvements made or contracted for by an affiliate of a declarant are made or contracted for by the declarant.
- 6. Any conveyance of a unit transfers to the purchaser and subsequent purchasers all of any declarant's implied warranties of quality.
- 445.415. 1. Except as limited by subsection 2 of this section with 2 respect to a purchaser of a unit that may be used for residential use, 3 implied warranties of quality:
- 4 (1) May be excluded or modified by agreement of the parties; and
- 5 (2) Are excluded by expression of disclaimer, such as "as is", "with 6 all faults", or other language which in common understanding calls the 7 purchaser's attention to the exclusion of warranties.
- 8 2. With respect to a purchaser of a unit that may be occupied for 9 residential use, no general disclaimer of implied warranties of quality 10 of the unit or any of the common elements is effective, but a declarant

11 and a dealer may disclaim liability in an instrument signed by the 12 purchaser:

- 13 (1) For a specified defect or specified failure to comply with 14 applicable law, if the defect or failure entered into and became a part 15 of the basis of the bargain; or
- 16 (2) For any defect in improvements which are otherwise covered 17 by express warranties.
- 445.416. 1. Unless the limitation period is tolled under section 2 445.417 or as provided in subsection 4 of this section, a judicial 3 proceeding for breach of any obligation arising under section 445.413 or 445.414 must be commenced within three years after the cause of action 5 accrues.
- 2. Subject to subsection 3 of this section, a cause of action for breach of warranty of quality, regardless of the purchaser's lack of knowledge of the breach, accrues:
- 9 (1) As to a unit, at the time the purchaser to whom the warranty 10 is first made enters into possession if a possessory interest was 11 conveyed or at the time of acceptance of the instrument of conveyance 12 if a nonpossessory interest was conveyed; and
- (2) As to each common element, a judicial proceeding for breach of any obligation to the association arising under section 445.413 or 445.414 shall be commenced within three years after the cause of action accrues. Subject to subsections 3 and 4 of this section, a cause of action of the association for breach of warranty of quality, as to each common element, accrues at the time the common element is completed or, if later:
- 20 (a) As to a common element which is added to the planned 21 community by exercise of development rights, at the time the first unit 22 therein is conveyed to a bona fide purchaser; or
- 23 (b) As to a common element within any other portion of the 24 planned community, at the time the first unit in the planned community 25 is conveyed to a purchaser.
- 3. If a warranty of quality explicitly extends to future performance or duration of any improvement or component of the common elements, the cause of action accrues at the time the breach is discovered or at the end of the period for which the warranty explicitly extends, whichever is earlier.

4. During the period of declarant control, the association may authorize an independent committee of the executive board to evaluate and enforce by any lawful means warranty claims involving the common elements and to compromise those claims. Only members of the executive board elected by unit owners other than the declarant and other persons appointed by those independent members may serve on the committee and the committee's decision shall be free of any control by the declarant or any member of the executive board or officer appointed by the declarant. All costs reasonably incurred by the committee, including attorney's fees, are common expenses and shall be added to the budget annually adopted by the association under section 42 445.315. If the committee is so created, the limitation period for claims for these warranties begins to run from the date of the first meeting of the committee, regardless of when declarant control terminates.

445.417. 1. If a declarant or any other person subject to sections 445.151 to 445.420 fails to comply with any provision hereof or any provision of the declaration or bylaws, any person or class of persons adversely affected by the failure to comply has a claim for appropriate relief. Punitive damages may be awarded for a willful, wanton and malicious failure to comply with sections 445.151 to 445.420. The court, in an appropriate case, may award court costs and reasonable attorney's fees.

- 9 2. Parties to a dispute arising under sections 445.151 to 445.420, 10 the declaration or the bylaws may agree to resolve the dispute by any 11 form of binding or nonbinding alternative dispute resolution, but:
- 12 (1) A declarant may agree with the association to do so only after 13 the period of declarant control passes, unless the agreement is made 14 with an independent committee of the executive board under subsection 15 4 of section 445.416;
- 16 (2) An agreement to submit to binding arbitration must be made 17 in writing signed by the parties; and
- 18 (3) Except as provided in subsection 4 of section 445.416, any 19 statute of limitation affecting any right of action of the association 20 against a declarant under sections 445.151 to 445.420 is tolled until the 21 period of declarant control terminates.

445.418. If any improvement contemplated in a planned 2 community is labeled "NEED NOT BE BUILT" on a plat or plan, or is to

3 be located within a portion of the planned community with respect to
4 which the declarant has reserved a development right, no promotional
5 material may be displayed or delivered to prospective purchasers which
6 describes or portrays that improvement unless the description or
7 portrayal of the improvement in the promotional material is
8 conspicuously labeled or identified as "NEED NOT BE BUILT".

445.419. 1. Except for improvements labeled "NEED NOT BE BUILT", the declarant shall complete all improvements depicted on any site plan or other graphic representation, including any plats or plans prepared under section 445.209, whether or not that site plan or other graphic representation is contained in the original sale certificate or in any promotional material distributed by or for the declarant.

2. The declarant is subject to liability for the prompt repair and 8 restoration, to a condition compatible with the remainder of the 9 planned community, of any portion of the planned community affected 10 by the exercise of rights reserved under or created by section 445.210, 11 445.211, 445.212, 445.213, 445.215 or 445.216.

445.420. In the case of sale of a unit where delivery of an original sale certificate is required, a contract of sale may be executed, but no interest in that unit may be conveyed until the declaration is recorded and the unit is substantially completed, as evidenced by a recorded certificate of substantial completion executed by an independent registered architect, surveyor or engineer, or by issuance of a certificate of occupancy authorized by law.
