AN ACT

To amend chapter 407, RSMo, by adding thereto one new section relating to deceptive advertising practices.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 407, RSMo, is amended by adding thereto one new 2 section, to be known as section 407.311, to read as follows:

- 407.311. 1. As used in this section, the following terms shall mean:
- (1) "Local telephone directory", a publication listing telephone numbers for various businesses in a certain geographic area and distributed free of charge to some or all telephone subscribers in that area;
- 7 (2) "Local telephone number", a telephone number that can be 8 dialed without incurring long distance charges from telephones located 9 within the area covered by the local telephone directory in which the 10 number is listed. The term shall not include long distance numbers, 11 toll-free numbers, or nine hundred exchange numbers listed in the local
- 13 (3) "Person", an individual, partnership, limited liability 14 partnership, corporation, or limited liability corporation.
- 2. No person who sells, or offers for sale, any service or product shall:
- 17 (1) List a fictitious business name or an assumed business name 18 in a local telephone directory if:
- 19 (a) The name misrepresents the geographic location of such 20 person;
- 21 (b) The listing fails to identify the person's business address,

- 22 including the state;
- (c) Calls to the local telephone number are routinely forwarded or otherwise transferred to a business location that is outside the calling area covered by the local telephone directory; and
- 26 (d) The business location of the person is located in a county 27 that is not contiguous to a county in the calling area covered by the 28 local telephone directory; or
- 29 (2) List a fictitious business name or assumed business name in 30 a directory assistance database if:
- 31 (a) The name misrepresents the geographic location of such 32 person;
- 33 (b) Calls to the local telephone number are routinely forwarded 34 or otherwise transferred to a business location that is outside the local 35 calling area; and
- 36 (c) The business location of the person is located in a county that 37 is not contiguous to a county in the local calling area.
- 38 3. For purposes of this section, a telephone company or other provider of a telephone directory or directory assistance service or its officer or agent is immune from liability for publishing the listing of a fictitious business name or assumed business name of a person in its directory or directory assistance database unless the telephone company or other provider of a telephone or directory assistance service is the same person as the person who has committed the deceptive act.
- 46 4. Any person who violates the provisions of this section is guilty of an unlawful practice under section 407.020.
