## Senate Committees Named and Assigned

In the Missouri Senate this week, Senate President Pro Tem Charlie Shields (R-St. Joseph) named and assigned the 18 Senate committees that will review legislation for the 2009 session. He also appointed senators to serve as chairmen and chairwomen of the committees.

Sen. Shields also appointed Senate Minority Floor Leader Victor Callahan (D-Independence) to a chairman position on the newly created Senate Progress and Development Committee. Chair positions are typically reserved for members of the majority party. For the first time in recent history, a committee chair position is now held by a member of the minority party.

I was assigned four committees: Financial and Governmental Organizations and Elections; Veterans' Affairs, Pensions and Urban Affairs; Gubernatorial Appointments; and Administration.

The Financial and Governmental Organizations and Elections Committee considers all measures relating to banks and banking, savings and loan associations, and other financial institutions in our state. The committee also handles bills relating to the internal operation of any state agency and election law.

The Veterans' Affairs, Pensions and Urban Affairs Committee handles all matters concerning veterans' issues, as well as retirement pension plans and urban

renewal.

The Gubernatorial Appointments Committee considers the nominations of people appointed by the governor to serve on state boards, commissions, and head various state departments.

The Administration Committee oversees the operations of the Senate.

Senate committees are responsible for holding public hearings and refining legislation before it heads to the Senate floor for consideration by the full body. I look forward to serving on each one of these committees and working with my colleagues to pass legislation beneficial to the citizens of our state.

Senate seminars designed to inform senators about some of the key issues they will be facing this session continued this week. On Tuesday, my colleagues and I attended two seminars—the first covering transportation infrastructure and development in Missouri, and the second focusing on agriculture, Missouri's primary industry.

Lawmakers also attended seminars on Wednesday, with presentations on education and economic development. The education seminar covered early childhood and elementary and secondary education. They discussed the newly established "Schools First Elementary and Secondary Education Improvement Fund," which was part of a ballot initiative passed by voters in November 2008, as well as urban schools. During the economic development seminar, lawmakers discussed how Missouri can compete with other states.

The Senate seminars wrapped up on Thursday, with discussion on higher education and a focus on what measures other states have taken to strengthen their coordinating boards.

It was also announced that the governor will speak before the Legislature in a jointsession next Tuesday, January 27, during the "State of the State" address. The governor is expected to outline his plan for the state budget.

The Missouri Senate stood adjourned on Monday, January 19, in honor of Martin Luther King, Jr. Day. Last week I told you about the annual Dr. Martin Luther King, Jr. Celebration held in the Capitol Rotunda. I was the chairwoman of the event this year and also served as Mistress of Ceremonies. The theme of this year's event, hosted by the Missouri Legislative Black Caucus, was "Uniting Communities — Past, Present and Future."

The Missouri Senate will reconvene at 4 p.m. Monday, January 26. The First Regular Session of the 95th Missouri General Assembly will run through Friday, May 15, 2009.
