**Addressing Autism In Missouri**

April is National Autism Awareness Month and the Missouri General Assembly's continued efforts on this important health care issue is bringing our state to the forefront regarding autism therapy and research. Since the 1970s, the [Autism Society of America](#) (ASA) has used the month of April to educate citizens about autism and issues within the autism community.

Autism is an extremely complex developmental disability that affects a person (usually during the first three years of life) and their ability to communicate and interact with others. This

**“spectrum disorder” reveals a specific set of behaviors that can affect individuals differently and to various degrees.**

**According to the Centers for Disease Control and Prevention (CDC), 1.5 million Americans are living with the effects of autism and 1 in every 150 American children is diagnosed with autism. There is no known cause for autism. However, increased awareness and funding can help families in Missouri and throughout our country.**

**Currently, the ASA estimates that the lifetime cost for caring for a child with autism ranges from \$3.5 to \$5 million. In addition, our nation is facing almost \$90 billion in annual costs for autism. This includes research, insurance costs and non-covered expenses, Medicaid waivers, educational spending, housing, transportation, employment, therapeutic services, and caregiver costs.**

**Lawmakers in the General Assembly realize the emotional and financial toll autism can have on families. [Senate Bill 167](#), which recently received final approval in the Senate, requires health insurance carriers to provide coverage for the diagnosis and treatment of an autism spectrum disorder for individuals under the age of 18. Senate Bill 167 would prohibit health carriers from denying or refusing to provide coverage to an individual or their dependent solely because the individual is diagnosed with an autism spectrum disorder.**

**Final approval in the House of Representatives would send Senate Bill 167 to the governor for his signature.**

## Utility Bill Help for the 5<sup>th</sup> Senatorial District

Recently, a bill I have filed in the Senate received a hearing and is one step further in the legislative process. Senate Bill 474, if signed into law, would allow certain public utilities to require deposits for new or continued service only in certain circumstances. For

instance, customers who have wrongly interfered with or diverted the utility's service within the past five years, individuals who have their service shut off due to their delinquency in payment, or customers who do not meet the acceptable credit rating would be the only ones that would have to pay a deposit to utility companies.

In addition, no deposit or other guarantee would be required for any customer who has consistently paid at least a portion of his or her monthly utility bill and when the outstanding balance owed is \$500 or less. Utilities covered under Senate Bill 474 include telephone, gas, electric, sewer, heating, and water.

My bill would have to be approved by the full Senate before moving on to the House for similar consideration.

The Senate passed legislation last year, which was signed into law, that ensures citizens are not denied electric or natural gas service during dangerously hot temperatures during Missouri's summer months. [Senate Bill 720](#), sponsored by the former senator of the 5<sup>th</sup> Senatorial District, established a hot weather rule from June 1 to Sept. 20. The measure also prohibits electric or natural gas companies from shutting off service to delinquent customers on days when the temperature is forecasted to rise above 95 degrees or the heat index is above 105 degrees.

And with summer right around the corner, it's almost impossible to think about heating our homes during our state's cold winters. However, I would like to remind

our citizens about Missouri's Low Income Home Energy Assistance Program (LIHEAP), which is available to help Missourians with their winter heating bills. The program is designed with two components:

- Energy Assistance/Regular Heating (EA)
- Energy Crisis Assistance Program (ECIP)

The first program (EA) is designed to provide financial assistance to help pay heating bills for Missourians from October through March. Eligibility requirements for EA are based on income, family size, available resources, and responsibility for payment of home heating costs.

The Energy Crisis Assistance Program (ECIP) provides individuals with additional financing and/or weatherization services funded by LIHEAP.
