If you have ever seen the movie *Ground Hog Day*, you would remember that it is a movie about a news reporter who woke up every morning and relived the same day over and over again. It seems that this movie has come to life in our own time as we wake up every morning to news of more bailouts, bankruptcies, unemployment, and more ideas on how the government wants to spend our way to prosperity.

I am sure that, like me, you receive credit card offers in the mail every day. In order to keep finances in shape and under control, in my household those offers go from the mailbox to the trashcan. The State of Missouri now has its own credit card from the federal government and the plastic better be in good shape because it will be put to use.

One month ago the state was facing over \$800 million in budget shortfalls. State departments, colleges, and other departments that depend on state funding were looking at ways to trim up staffs and budgets in order to keep our state constitutional requirement of a balanced budget.

All of a sudden the State of Missouri along with every other state in the nation received the credit card offer of the century. We are now able to use the federal government's credit card with an expiration date of two years on it and a credit limit of \$4.4 billion.
