Reported from the Committee on Transportation, February 26, 2009, with recommendation that the Senate Committee Substitute do pass. 0374S.02C AN ACT

To amend chapter 226, RSMo, by adding thereto one new section relating to billboards.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 226, RSMo, is amended by adding thereto one new 2 section, to be known as section 226.541, to read as follows:

226.541. 1. As used in this section, the following words or 2 phrases mean:

3 (1) "Conforming out of standard signs", signs that fail to meet the 4 current statutory and administrative rule requirements for outdoor 5 advertising but currently comply with the terms of the federal/state 6 agreement and meet the August 27, 1999, statutory and administrative 7 rule requirements that governed outdoor advertising and the highway 8 beautification act of 1965;

9 (2) "Federal/state agreement", an agreement executed between 10 the United States Department of Transportation and the state highways 11 and transportation commission on February 22, 1972, for carrying out 12 national policy relative to control of outdoor advertising in areas 13 adjacent to the national system of interstate and defense highways and 14 the federal-aid primary system;

(3) "Reset", movement of a sign structure from one location to
another location on the same or adjoining property, as authorized by
a sign permit amendment and the terms of an executed written partial
waiver and reset agreement between the permit owner and the state
highways and transportation commission.

2. Subject to the I-44/I-70 provisions under this section,

21 conforming out of standard signs shall be treated as conforming signs 22 under commission administrative rules, including new display 23 technologies, lighting, cutouts, and extensions, except that such signs 24 shall not be substantially rebuilt. New technologies, lighting, cutouts, 25 and extensions may be utilized on conforming and conforming out of 26 standard signs in accordance with Missouri department of 27 transportation regulations.

3. On the date the commission approves funding for any phase or portion of construction or reconstruction of Interstate 70 or Interstate 44, the rules in effect for outdoor advertising on August 27, 1999, shall be reinstated for that section of highway scheduled for construction and there shall immediately be a moratorium imposed on the issuance of state sign permits for new sign structures.

4. Owners of existing signs which meet the requirements for 34outdoor advertising in effect on August 27, 1999, and the requirements 35of the federal/state agreement and who voluntarily execute a partial 36waiver and reset agreement may reset such signs on the same or 3738adjoining property. Such reset agreements shall be contingent upon 39obtaining any required local approval to reset the sign structure. Any 40sign which has been reset must still comply with the August 27, 1999, 41outdoor advertising regulations after it has been reset.

5. Owners of existing signs who elect to reset qualifying signs shall receive compensation representing the actual cost to reset the existing sign. Signs which have been reset under these provisions must be reconstructed of the same type materials and may not exceed the square footage of the original sign structure.

476. Sign owners may elect to reset existing qualifying signs by executing a partial waiver and reset agreement with the 4849commission. Such agreement shall specify the size, type, and location of the rebuilt sign and the reset expenses to be paid the owner by the 50commission. In the event the owner fails to execute such an agreement 51within one hundred twenty days of receiving written notice the sign 52will be displaced by construction, the commission shall have the right 53at its sole discretion to initiate normal condemnation procedures for 54the compensated removal of the sign. 55

567. Immediately upon the completion of construction on any57section of Interstate 70 or Interstate 44, the moratorium on new permits

shall be lifted and the rules for outdoor advertising in effect on the
date the construction is completed shall apply to such section of
highway.

Local zoning authorities may prohibit the resetting of 62 qualifying signs which fail to comply with local regulations, but local 63 authorities which choose to prohibit such resetting shall reimburse the 64 commission the cost to condemn such signs less the cost to reset the 65 sign under the provisions in this section.

9. All signs shall be subject to the biennial inspection fees
pursuant to section 226.550.
