AN ACT

To repeal section 160.540, RSMo, and to enact in lieu thereof one new section relating to teacher tenure.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 160.540, RSMo, is repealed and one new section 2 enacted in lieu thereof, to be known as section 160.540, to read as follows:

160.540. 1. In any school district [whose graduation rate, as defined in section 160.011, is below sixty-five percent], the district school board or other governing entity shall determine which schools in the district do not meet the criteria set forth [pursuant to section 160.538 as being academically deficient] for a classification of accreditation by the state board of education, based on the results of the assessment system developed pursuant to section 160.518, whether or not the state board of education has made a finding that the [schools are academically deficient] district as a whole has been determined to be unaccredited or provisionally accredited for purposes of its annual performance report or full accreditation review. With respect to any such school, notwithstanding any provision of state law or regulation, district rule or 11 12 regulation, or contract, the school district board or other governing entity shall have the authority to suspend or terminate contracts of certificated staff, 13 14 the principal and any administrators having responsibility for the school and to 15 reconstitute the school with new teachers and administrative staff. The authority granted herein shall not preclude the district board or other governing entity 16 from offering contracts to individual teachers or administrators as the board or 17 18 other governing entity may deem appropriate. Any termination of a contract of an individual permanent teacher pursuant to this section [shall be subject to

22 determination that the teacher has contributed at least one grade level

In any school district subject to the provisions of subsection 1 of this section, the district shall develop a program of incentives and rewards for 25teachers who contribute to a successful effort to prevent schools from becoming 26 27 [academically deficient as defined in this section] provisionally accredited or 28 unaccredited on the annual performance report or to remove schools that 29 have been so identified from that category. The district's plan shall be subject to 30 approval by the commissioner of education and may include, but shall not be limited to, [bonuses] pay for performance, opportunities for staff development 31 and the granting of status as master teachers.
