#### AN ACT

To repeal sections 115.277 and 115.283, RSMo, and to enact in lieu thereof two new sections relating to absentee voting.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 115.277 and 115.283, RSMo, are repealed and two new sections enacted in lieu thereof, to be known as sections 115.277 and 115.283, to read as follows:

115.277. 1. Except as provided in subsections 3, 4 and 5 of this section, any registered voter of this state may vote by absentee ballot for all candidates and issues for which such voter would be eligible to vote at the polling place [if such voter expects to be prevented from going to the polls to vote on election day due to:

6 (1) Absence on election day from the jurisdiction of the election authority 7 in which such voter is registered to vote;

8 (2) Incapacity or confinement due to illness or physical disability, 9 including a person who is primarily responsible for the physical care of a person 10 who is incapacitated or confined due to illness or disability;

(3) Religious belief or practice;

12 (4) Employment as an election authority, as a member of an election
13 authority, or by an election authority at a location other than such voter's polling

15 (5) Incarceration, provided all qualifications for voting are retained].

16 2. Any person in federal service, as defined in section 115.275, who is 17 eligible to register and vote in this state but is not registered may vote only in the 18 election of presidential and vice presidential electors, United States senator and

### EXPLANATION-Matter enclosed in bold-faced brackets [thus] in this bill is not enacted and is intended to be omitted in the law.

3. Any interstate former resident, as defined in section 115.275, may vote
by absentee ballot for presidential and vice presidential electors.

4. Any intrastate new resident, as defined in section 115.275, may vote by absentee ballot at the election for presidential and vice presidential electors, United States senator, representative in Congress, statewide elected officials and statewide questions, propositions and amendments from such resident's new jurisdiction of residence after registering to vote in such resident's new jurisdiction of residence.

5. Any new resident, as defined in section 115.275, may vote by absentee ballot for presidential and vice presidential electors after registering to vote in such resident's new jurisdiction of residence.

115.283. 1. Each ballot envelope shall bear a statement on which the voter shall state the voter's name, the voter's voting address, the voter's mailing  $\mathbf{2}$ address and the voter's reason for voting an absentee ballot. On the form, the 3 voter shall also state under penalties of perjury that the voter is qualified to vote 4 5in the election, that the voter has not previously voted and will not vote again in 6 the election, that the voter has personally marked the voter's ballot in secret or supervised the marking of the voter's ballot if the voter is unable to mark it, that 7 8 the ballot has been placed in the ballot envelope and sealed by the voter or under the voter's supervision if the voter is unable to seal it, and that all information 9 contained in the statement is true. In addition, any person providing assistance 10to the absentee voter shall include a statement on the envelope identifying the 11 person providing assistance under penalties of perjury. Persons authorized to 1213vote only for federal and statewide officers shall also state their former Missouri residence. 14
