AN ACT

To repeal section 94.900, RSMo, and to enact in lieu thereof one new section relating to a sales tax for public safety improvement.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 94.900, RSMo, is repealed and one new section enacted 2 in lieu thereof, to be known as section 94.900, to read as follows:

94.900. 1. The governing body of any city of the third classification with more than ten thousand eight hundred but less than ten thousand nine hundred $\mathbf{2}$ inhabitants located at least partly within a county of the first classification with 3 more than one hundred eighty-four thousand but less than one hundred 4 eighty-eight thousand inhabitants, or any city of the fourth classification with 5more than eight thousand nine hundred but fewer than nine thousand 6 inhabitants, or any city of the fourth classification with more than two 7 8 thousand six hundred but fewer than two thousand seven hundred inhabitants and located in any county of the first classification with 9 10 more than eighty-two thousand but fewer than eighty-two thousand one 11 hundred inhabitants is hereby authorized to impose, by ordinance or order, a sales tax in the amount of up to one-half of one percent on all retail sales made 12in such city which are subject to taxation under the provisions of sections 144.010 13to 144.525, RSMo, for the purpose of improving the public safety for such city, 14 including but not limited to expenditures on equipment, city employee salaries 15and benefits, and facilities for police, fire and emergency medical providers. The 16 tax authorized by this section shall be in addition to any and all other sales taxes 17

18 allowed by law, except that no ordinance or order imposing a sales tax pursuant 19 to the provisions of this section shall be effective unless the governing body of the 20 city submits to the voters of the city, at a county or state general, primary or 21 special election, a proposal to authorize the governing body of the city to impose 22 a tax.

23 2. If the proposal submitted involves only authorization to impose the tax
24 authorized by this section, the ballot of submission shall contain, but need not be
25 limited to, the following language:

26 Shall the city of (city's name) impose a 27 citywide sales tax of (insert amount) for the purpose of improving the 28 public safety of the city?

If a majority of the votes cast on the proposal by the qualified voters voting 32thereon are in favor of the proposal submitted pursuant to this subsection, then 3334the ordinance or order and any amendments thereto shall be in effect on the first day of the second calendar quarter after the director of revenue receives 3536notification of adoption of the local sales tax. If a proposal receives less than the 37required majority, then the governing body of the city shall have no power to impose the sales tax herein authorized unless and until the governing body of the 38city shall again have submitted another proposal to authorize the governing body 39of the city to impose the sales tax authorized by this section and such proposal 40is approved by the required majority of the qualified voters voting 41 thereon. However, in no event shall a proposal pursuant to this section be 4243submitted to the voters sooner than twelve months from the date of the last 44proposal pursuant to this section.

3. All revenue received by a city from the tax authorized under the
provisions of this section shall be deposited in a special trust fund and shall be
used solely for improving the public safety for such city for so long as the tax
shall remain in effect.

49 4. Once the tax authorized by this section is abolished or is terminated by 50 any means, all funds remaining in the special trust fund shall be used solely for 51 improving the public safety for the city. Any funds in such special trust fund 52 which are not needed for current expenditures may be invested by the governing 53 body in accordance with applicable laws relating to the investment of other city 54 funds.

555. All sales taxes collected by the director of the department of revenue under this section on behalf of any city, less one percent for cost of collection 5657which shall be deposited in the state's general revenue fund after payment of premiums for surety bonds as provided in section 32.087, RSMo, shall be 5859deposited in a special trust fund, which is hereby created, to be known as the "City Public Safety Sales Tax Trust Fund". The moneys in the trust fund shall 60 61not be deemed to be state funds and shall not be commingled with any funds of the state. The provisions of section 33.080, RSMo, to the contrary 62 notwithstanding, money in this fund shall not be transferred and placed to the 63 credit of the general revenue fund. The director of the department of revenue 64 shall keep accurate records of the amount of money in the trust and which was 65 collected in each city imposing a sales tax pursuant to this section, and the 66 67 records shall be open to the inspection of officers of the city and the public. Not later than the tenth day of each month the director of the department of revenue 68 shall distribute all moneys deposited in the trust fund during the preceding 69 70month to the city which levied the tax; such funds shall be deposited with the city treasurer of each such city, and all expenditures of funds arising from the trust 71fund shall be by an appropriation act to be enacted by the governing body of each 7273such city. Expenditures may be made from the fund for any functions authorized 74in the ordinance or order adopted by the governing body submitting the tax to the 75voters.

766. The director of the department of revenue may make refunds from the amounts in the trust fund and credited to any city for erroneous payments and 77overpayments made, and may redeem dishonored checks and drafts deposited to 78the credit of such cities. If any city abolishes the tax, the city shall notify the 7980 director of the department of revenue of the action at least ninety days prior to the effective date of the repeal and the director of the department of revenue may 81 82order retention in the trust fund, for a period of one year, of two percent of the amount collected after receipt of such notice to cover possible refunds or 83 overpayment of the tax and to redeem dishonored checks and drafts deposited to 84 85the credit of such accounts. After one year has elapsed after the effective date of abolition of the tax in such city, the director of the department of revenue shall 86 87 remit the balance in the account to the city and close the account of that city. The director of the department of revenue shall notify each city of each 88 instance of any amount refunded or any check redeemed from receipts due the 89

90 city.

91	7. Except as modified in this section, all provisions of sections 32.085 and
92	32.087, RSMo, shall apply to the tax imposed pursuant to this section.
