This year, I would like to let you know about a couple programs offered by the state that you can use in 2010.



Promoting Energy Efficiency: A new *Energize*Missouri Appliance Rebates program is scheduled to begin

April 19, 2010, to coincide with the state's second annual

"Show Me Green Energy Star Sales Tax Holiday." The

program will help Missourians buy appliances at a lower cost
while reducing their overall utility bills and boosting area
businesses by stimulating energy-efficient appliance sales.

When Missourians purchase qualified Energy Star-rated

appliances, including gas furnaces, air source heat pumps, central air conditioners, clothes washers, dishwashers and water heaters, they will receive a rebate. To receive an Energy Star rating, appliances are required to meet certain minimum energy efficiency standards. According to Department of Natural Resources, a typical Missouri household can save more money and energy by replacing inefficient heating, cooling or water-heating equipment—which can account for more than half of a home's energy bill—than any other home appliances. The federal government will provide more than \$5.6 million in funding to Missouri for the rebates, drawing down from funds reserved for the American Recovery and Reinvestment Act of 2009. Common Sense Vehicle Requirements: A new state law that went into effect on January 1 exempts motor vehicles from safety inspection requirements for the first five years following the model year of manufacture. Currently, the Missouri Department of Revenue requires proof of a safety inspection when



vehicle registrations (license plates) are renewed. Citizens presently have the option of renewing their license plates for one-year or two-year periods, so the need to obtain safety inspections for owners of newer vehicles will be minimized.
