AN ACT

To amend chapter 301, RSMo, by adding thereto three new sections relating to special license plates.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 301, RSMo, is amended by adding thereto three new

- 2 sections, to be known as sections 301.477, 301.3158, and 301.3160, to read as
- 3 follows:
 - 301.477. 1. Any person who has been awarded the combat action
- 2 badge may apply for special personalized motor vehicle license plates
- 3 for any vehicle the person owns, either solely or jointly, other than an
- 4 apportioned motor vehicle or a commercial motor vehicle licensed in
- 5 excess of eighteen thousand pounds gross weight.
- 6 2. Any such person shall make application for the special license
- 7 plates on a form provided by the director of revenue and furnish such
- 8 proof as a recipient of the combat action badge as the director may
- 9 require.
- 3. The director shall then issue license plates bearing the words
- 11 "COMBAT ACTION" in place of the words "SHOW-ME STATE" in a form
- 12 prescribed by the director, except that such license plates shall be
- 13 made with fully reflective material, shall have a white background with
- 14 a blue and red configuration at the discretion of the director, shall be
- 15 clearly visible at night, and shall be aesthetically attractive, as

prescribed by section 301.130. Such plates shall also bear an image of 17 the combat action badge.

- 4. There shall be an additional fee charged for each set of special combat action badge license plates issued equal to the fee charged for personalized license plates in section 301.144.
- 5. There shall be no limit on the number of license plates any 22person qualified under this section may obtain so long as each set of license plates issued under this section is issued for vehicles owned 23solely or jointly by such person.
 - 6. License plates issued pursuant to the provisions of this section shall not be transferable to any other person except that any registered co-owner of the motor vehicle shall be entitled to operate the motor vehicle with such plates for the duration of the year licensed in the event of the death of the qualified person.

301.3158. Any person who has been awarded the military service award known as the legion of merit medal may apply for special motor vehicle license plates for any vehicle such person owns, either solely or jointly, other than an apportioned motor vehicle or a commercial motor vehicle licensed in excess of eighteen thousand pounds gross weight. Any such person shall make application for the special license plates on a form provided by the director of revenue and furnish such proof as a recipient of the legion of merit medal as the director may require. The director shall then issue license plates bearing letters or numbers or a combination thereof as determined by the advisory 10 committee established in section 301.129, with the words "LEGION OF 11 MERIT" in place of the words "SHOW-ME STATE". Such license plates 12shall be made with fully reflective material with a common color scheme and design, shall be clearly visible at night, and shall be aesthetically attractive, as prescribed by section 301.130. Such plates 15shall also bear an image of the legion of merit medal. There shall be an 16 additional fee charged for each set of legion of merit license plates 17issued under this section equal to the fee charged for personalized 18 license plates. There shall be no limit on the number of license plates 19 20any person qualified under this section may obtain so long as each set of license plates issued under this section is issued for vehicles owned 21solely or jointly by such person. License plates issued under the 22provisions of this section shall not be transferable to any other person 23

except that any registered co-owner of the motor vehicle shall be entitled to operate the motor vehicle with such plates for the duration of the year licensed in the event of the death of the qualified person.

301.3160. 1. Notwithstanding any other provision of law to the contrary, any person, after an annual payment of an emblem-use fee to the National Multiple Sclerosis Society, may receive special personalized license plates for any vehicle the person owns, either solely or jointly, other than an apportioned motor vehicle or a commercial motor vehicle licensed in excess of eighteen thousand pounds gross weight. The National Multiple Sclerosis Society hereby authorizes the use of its official emblem to be affixed on multi-year personalized license plates as provided in this section. Any contribution to the National Multiple Sclerosis Society derived from 10 this section, except reasonable administrative costs, shall be used solely 11 for the purposes of the National Multiple Sclerosis Society. Any vehicle 12owner may annually apply for the use of the emblem. 13

- 2. Upon annual application and payment of a twenty-five dollar 14 15 emblem-use contribution to the National Multiple Sclerosis Society, the 16 National Multiple Sclerosis Society shall issue to the vehicle owner, 17 without further charge, an emblem-use authorization statement, which shall be presented by the vehicle owner to the director of revenue at the time of registration. Upon presentation of the annual statement 19 20 and payment of a twenty-five dollar fee in addition to the regular 21 registration fees, and presentation of any documents which may be 22required by law, the director of revenue shall issue to the vehicle owner a special license plate which shall bear the emblem of the 23National Multiple Sclerosis Society. Such license plates shall be made 2425with fully reflective material with a common color scheme and design, shall be clearly visible at night, and shall be aesthetically attractive, as 26 prescribed by section 301.130. In addition, upon such set of license 27 plates shall be inscribed, in lieu of the words "SHOW-ME STATE", the 28words "JOIN THE MOVEMENT". Notwithstanding the provisions of 29section 301.144, no additional fee shall be charged for the 30 31 personalization of license plates issued pursuant to this section.
 - 3. A vehicle owner who was previously issued a plate with the National Multiple Sclerosis Society's emblem authorized by this section, but who does not provide an emblem-use authorization statement at a

subsequent time of registration, shall be issued a new plate which does 35 36 not bear the National Multiple Sclerosis Society's emblem, as otherwise provided by law. The director of revenue shall make necessary rules 3738 and regulations for the enforcement of this section, and shall design all necessary forms required by this section. 39

4. Prior to the issuance of a National Multiple Sclerosis Society's specialty plate authorized under this section the department of revenue must be in receipt of an application, as prescribed by the director, which shall be accompanied by a list of at least two hundred potential applicants who plan to purchase the specialty plate, the proposed art design for the specialty license plate, and an application fee, not to exceed five thousand dollars, to defray the department's cost for issuing, developing, and programming the implementation of the specialty plate. Once the plate design is approved, the director of revenue shall not authorize the manufacture of the material to produce such specialized license plates with the individual seal, logo, or emblem until such time as the director has received two hundred applications, 5152the twenty-five dollar specialty plate fee per application, and emblem-use statements, if applicable, and other required documents or 54 fees for such plates.
