**AN ACT**

To repeal sections 227.303 and 227.409, RSMo, and to enact in lieu thereof eleven new sections relating to memorial highway designations.

---

*Be it enacted by the General Assembly of the State of Missouri, as follows:*

Section A. Sections 227.303 and 227.409, RSMo, are repealed and eleven  
2 new sections enacted in lieu thereof, to be known as sections 227.303, 227.365,  
3 227.391, 227.405, 227.408, 227.409, 227.412, 227.413, 227.414, 227.415, and  
4 227.416, to read as follows:

227.303. The portion of interstate highway 70 within a city not within a  
2 county to the border with the state of Illinois shall be designated the "Mark  
3 [McGwire] Twain Highway".

227.365. **The portion of Lindbergh Boulevard located in St. Louis  
2 County, from its intersection with Lemay Ferry Road, to the highway's  
3 connection with Barracksview Road, shall be designated as the "Dave  
4 Sinclair Memorial Highway". The department of transportation shall  
5 erect and maintain appropriate signs designating such highway, with  
6 the costs for such designation to be paid for by private donations.**

227.391. **The portion of Highway 80 in New Madrid County from  
2 the intersection of Highways 61, 80, and H, east to Interstate 55 shall be  
3 designated the "Gene Curtis Memorial Highway". Costs for such  
4 designation shall be paid by private donation.**

227.405. **The portion of Interstate 44 in St. Louis County  
2 beginning from its intersection with South Geyer Road and proceeding  
3 east to its intersection with South Elm Avenue shall be designated the**

4 "Police Officer Ernest M. Brockman Sr. Memorial Highway". The  
5 department of transportation shall erect and maintain appropriate  
6 signs designating such highway, with the costs to be paid for by private  
7 donations.

227.408. The portion of state highway 53 in Butler County from  
2 the city limits of Qulin to one mile south of the city limits shall be  
3 designated the "Johnny Lee Hays Memorial Highway". The department  
4 of transportation shall erect and maintain appropriate signs  
5 designating such highway, with the costs to be paid for by private  
6 donations.

227.409. [The portion of Interstate Highway I-64/US 40 from the  
2 McCausland/Skinker interchange east to the I-64/I-55 interchange shall be  
3 designated the "Jack Buck Memorial Highway". The department of  
4 transportation shall erect and maintain appropriate signs designating such  
5 highway designation, with the cost to be paid for by private donation] The  
6 portion of Interstate Highway I-64/US 40 from the McCausland/Skinker  
7 interchange east to the I-64/I-55 interchange shall be designated the  
8 "Jack Buck Memorial Highway". The department of transportation shall  
9 erect and maintain appropriate signs designating such highway  
10 designation, with the cost to be paid for by private donation.

227.412. The bridge crossing over the Union Pacific Railroad  
2 located on U.S. Highway 24 near Wilson Road in the Fairmont Business  
3 District of the City of Independence in Jackson County shall be  
4 designated the "Sergeant Charles R. Long Memorial Bridge". The  
5 department of transportation shall erect and maintain appropriate  
6 signs designating such bridge, with the costs to be paid for by private  
7 donations.

227.413. The portion of U.S. Highway 24 in Jackson County from  
2 the bridge crossing over the Union Pacific Railroad in the Fairmont  
3 Business District of the City of Independence to the intersection of  
4 Noland Road shall be designated the "Harry S Truman Memorial  
5 Highway". The department of transportation shall erect and maintain  
6 appropriate signs designating such highway, with the costs to be paid  
7 for by private donations.

227.414. The portion of Interstate 44 located in Franklin County  
2 from the Highway 100 overpass west to the St. Mary's Road overpass  
3 shall be designated as the "Mo. Hwy. Patrolman Corporal Dennis E.

4 Engelhard Memorial Highway". The department of transportation shall  
5 erect and maintain appropriate signs designating such highway, with  
6 the costs to be paid for by private donations.

227.415. The portion of Highway 36, 1.7 miles west of the  
2 intersection of Highway 36 and Route O in Macon County shall be  
3 designated as the "Missouri State Trooper William Brandt Memorial  
4 Highway". The department of transportation shall erect and maintain  
5 appropriate signs designating such highway, with the costs to be paid  
6 for by private donations.

227.416. The portion of Highway 13 from the intersection of  
2 Highway 32 to the intersection of Highway 83 in Polk County shall be  
3 designated the "John Playter Memorial Highway". The department of  
4 transportation shall erect and maintain appropriate signs designating  
5 such highway, with the costs for such designation to be paid for by  
6 private donation.
