AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to special license plates.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 301, RSMo, is amended by adding thereto one new 2 section, to be known as section 301.473, to read as follows:

301.473. 1. Notwithstanding any other provision of law, any person, after an annual payment of an emblem-use fee to the Missouri Junior Golf Foundation, may receive personalized speciality license plates for any vehicle owned, either solely or jointly, other than an apportioned motor vehicle or a commercial motor vehicle licensed in excess of eighteen thousand pounds gross weight. The Missouri Junior Golf Foundation hereby authorizes the use of its official emblem to be affixed on multi-year personalized speciality license plates as provided in this section. Any contribution to the Missouri Junior Golf Foundation derived from this section, except reasonable administrative costs, shall be used solely for the purposes of the Missouri Junior Golf Foundation. Any person may annually apply for the use of the emblem.

2. Upon annual application and payment of a twenty-five dollar 13 emblem-use contribution to the Missouri Junior Golf Foundation, the 14 15 Missouri Junior Golf Foundation shall issue to the vehicle owner, without further charge, an emblem-use authorization statement, which 16 17shall be presented by the vehicle owner to the director of revenue at 18 the time of registration. Upon presentation of the annual emblem-use authorization statement and payment of a fifteen dollar fee in addition 20 to the regular registration fees, and presentation of any documents which may be required by law, the director of revenue shall issue to the

vehicle owner a personalized speciality license plate which shall bear 2223the emblem of the Missouri Junior Golf Foundation. Such license plates shall be made with fully reflective material with a common color 2425scheme and design, shall be clearly visible at night, and shall be aesthetically attractive, as prescribed by section 301.130. In addition, 26upon each set of license plates shall be inscribed, in lieu of the words 27"SHOW-ME STATE", the words "MISSOURI JUNIOR GOLF FOUNDATION 28- BUILDING THE FUTURE". Notwithstanding the provisions of section 2930 301.144, no additional fee shall be charged for the personalized specialty plates issued under this section. 31

- 3. A vehicle owner who was previously issued a plate with the Missouri Junior Golf Foundation's emblem authorized by this section, but who does not provide an emblem-use authorization statement at a subsequent time of registration, shall be issued a new plate which does not bear the Missouri Junior Golf Foundation's emblem, as otherwise provided by law. The director of revenue shall make necessary rules and regulations for the enforcement of this section, and shall design all necessary forms required by this section.

Prior to the issuance of a Missouri Junior Golf Foundation 41 speciality plate authorized under this section, the department of 42revenue must be in receipt of an application, as prescribed by the director, which shall be accompanied by a list of at least two hundred 4344 potential applicants who plan to purchase the speciality plate, the proposed art design for the specialty license plate, and an application 45fee, not to exceed five thousand dollars, to defray the department's cost 46for issuing, developing, and programming the implementation of the 4748 specialty plate. Once the plate design is approved, the director of revenue shall not authorize the manufacture of the material to produce 49 such personalized specialty license plates with the individual seal, logo, 50or emblem until such time as the director has received two hundred 51applications, the fifteen dollar specialty plate fee per application, and 52emblem-use statements, if applicable, and other required documents or 53fees for such plates.
