Amend _____ House Bill No. 316, Page 1, Section Title, Lines 2-3,

2 by striking the following: "the division of tourism supplemental
3 revenue fund" and inserting in lieu thereof the following:

4 "statutes with expiration dates"; and

5 Further amend said bill, page 3, section 620.467, line 66,

6 by inserting after all of said line the following:

7 "[21.830. 1. There is hereby established a joint
8 committee of the general assembly, which shall be known
9 as the "Joint Committee on Missouri's Energy Future",
10 which shall be composed of five members of the senate,
11 with no more than three members of one party, and five
12 members of the house of representatives, with no more
13 than three members of one party. The senate members of
14 the committee shall be appointed by the president pro
15 tem of the senate and the house members by the speaker
16 of the house of representatives. The committee shall
17 select either a chairperson or co-chairpersons, one of
18 whom shall be a member of the senate and one a member
19 of the house of representatives. A majority of the
20 members shall constitute a quorum. Meetings of the
21 committee may be called at such time and place as the
22 chairperson or chairpersons designate.

23 2. The committee shall examine Missouri's present
24 and future energy needs to determine the best strategy
25 to ensure a plentiful, affordable and clean supply of
26 electricity that will meet the needs of the people and
27 businesses of Missouri for the next twenty-five years
28 and ensure that Missourians continue to benefit from
29 low rates for residential, commercial, and industrial
30 energy consumers.

31 3. The joint committee may hold hearings as it
32 deems advisable and may obtain any input or information
33 necessary to fulfill its obligations. The committee

1 may make reasonable requests for staff assistance from
2 the research and appropriations staffs of the house and
3 senate and the committee on legislative research, as
4 well as the department of economic development,
5 department of natural resources, and the public service
6 commission.

7 4. The joint committee shall prepare a final
8 report, together with its recommendations for any
9 legislative action deemed necessary, for submission to
10 the general assembly by December 31, 2009, at which
11 time the joint committee shall be dissolved.

12 5. Members of the committee shall receive no
13 compensation but may be reimbursed for reasonable and
14 necessary expenses associated with the performance of
15 their official duties.]

17 [21.910. 1. There is hereby created the "Joint
18 Committee on the Reduction and Reorganization of
19 Programs within State Government". The committee shall
20 be composed of thirteen members as follows:

21 (1) Three majority party members and two minority
22 party members of the senate, to be appointed by the
23 president pro tem of the senate;

24 (2) Three majority party members and two minority
25 party members of the house of representatives, to be
26 appointed by the speaker of the house of
27 representatives;

28 (3) The commissioner of the office of
29 administration, or his or her designee;

30 (4) A representative of the governor's office;
31 and

32 (5) A supreme court judge, or his or her
33 designee, as selected by the Missouri supreme court.

34 2. The committee shall study programs within
35 every department that should be eliminated, reduced, or
36 combined with another program or programs. As used in
37 this section, the term "program" shall have the same
38 meaning as in section 23.253.

39 3. In order to assist the committee with its
40 responsibilities under this section, each department
41 shall comply with any request for information made by
42 the committee with regard to any programs administered
43 by such department.

44 4. The members of the committee shall elect a
45 chairperson and vice chairperson.

46 5. The committee shall submit a report to the
47 general assembly by December 31, 2010, and such report
48 shall contain any recommendations of the committee for
49 eliminating, reducing, or combining any program with
50 another program or programs in the same or a different
51 department.

52 6. The provisions of this section shall expire on

1 January 1, 2011.]

3 [301.129. There is established in this section an
4 advisory committee for the department of revenue, which
5 shall exist solely to develop uniform designs and
6 common colors for motor vehicle license plates issued
7 under this chapter and to determine appropriate license
8 plate parameters for all license plates issued under
9 this chapter. The advisory committee may adopt more
10 than one type of design and color scheme for license
11 plates issued under this chapter; however, each license
12 plate of a distinct type shall be uniform in design and
13 color scheme with all other license plates of that
14 distinct type. The specifications for the fully
15 reflective material used for the plates, as required by
16 section 301.130, shall be determined by the committee.
17 Such plates shall meet any specific requirements
18 prescribed in this chapter. The advisory committee
19 shall consist of the director of revenue, the
20 superintendent of the highway patrol, the correctional
21 enterprises administrator, and the respective
22 chairpersons of both the senate and house of
23 representatives transportation committees.
24 Notwithstanding section 226.200 to the contrary, the
25 general assembly may appropriate state highways and
26 transportation department funds for the requirements of
27 section 301.130 and this section. Prior to January 1,
28 2007, the committee shall meet, select a chairman from
29 among their members, and develop uniform design and
30 license plate parameters for the motor vehicle license
31 plates issued under this chapter. Prior to determining
32 the final design of the plates, the committee shall
33 hold at least three public meetings in different areas
34 of the state to invite public input on the final
35 design. Members of the committee shall be reimbursed
36 for their actual and necessary expenses incurred in the
37 performance of their duties under this section out of
38 funds appropriated for that purpose. The committee
39 shall direct the director of revenue to implement its
40 final design of the uniform motor vehicle license
41 plates and any specific parameters for all license
42 plates developed by the committee not later than
43 January 1, 2007. The committee shall be dissolved upon
44 completion of its duties under this section.]

46 [620.602. 1. There is established a permanent
47 joint committee of the general assembly to be known as
48 the "Joint Committee on Economic Development Policy and
49 Planning" to be composed of five members of the senate,
50 appointed by the president pro tem of the senate, and
51 five members of the house, appointed by the speaker of
52 the house. No more than three members of the senate

1 and three members of the house shall be from the same
2 political party. The appointment of members shall
3 continue during their terms of office as members of the
4 general assembly or until successors have been duly
5 appointed to fill their places when their terms of
6 office as members of the general assembly have expired.
7 Members of the joint committee shall receive no
8 compensation in addition to their salary as members of
9 the general assembly, but may receive their necessary
10 expenses for attending the meetings of the committee,
11 to be paid out of the committee's appropriations or the
12 joint contingent fund.

13 2. The joint committee on economic development
14 policy and planning shall meet within ten days after
15 its establishment and organize by selecting a chairman
16 and a vice chairman, one of whom shall be a member of
17 the senate and the other a member of the house of
18 representatives. These positions shall rotate annually
19 between a member of the senate and a member of the
20 house of representatives. The committee shall
21 regularly meet at least quarterly. A majority of the
22 members of the committee shall constitute a quorum.
23 The committee may, within the limits of its
24 appropriations, employ such persons as it deems
25 necessary to carry out its duties. The compensation of
26 such personnel shall be paid from the committee's
27 appropriations or the joint contingent fund.

28 3. The joint committee on economic development
29 policy and planning shall, at its regular meetings,
30 confer with representatives from the governor's office,
31 the department of economic development, the University
32 of Missouri extension service, and other interested
33 parties from the private and public sectors. The joint
34 committee shall review the annual report produced by
35 the department of economic development, as required by
36 section 620.607, and plan, develop and evaluate a
37 long-term economic development policy for the state of
38 Missouri to ensure the state's competitive status with
39 other states.

40 4. The provisions of this section shall expire on
41 July 1, 2010.]

43 [630.461. 1. There is hereby created in the
44 department of mental health a committee to be known as
45 the "Review Committee for Purchasing" to review the
46 manner in which the department of mental health
47 purchases services for persons with mental health
48 disorders and substance abuse problems. By December
49 31, 1995, the committee shall recommend to the governor
50 and the general assembly any changes that should be
51 made in the department of mental health purchasing
52 systems, including whether the department should follow

1 a competitive purchasing model and, if so, the time
2 frame for initiating such change. The recommendation
3 of the committee shall be made in the context of state
4 and national health care reform and with the goal of
5 providing effective services in a coordinated and
6 affordable manner.

7 2. The review committee on purchasing created in
8 subsection 1 of this section shall be composed of nine
9 members as follows:

10 (1) One member of the mental health commission,
11 appointed by the governor;

12 (2) One representative of the office of
13 administration, appointed by the governor;

14 (3) The governor or his designee;

15 (4) Two members appointed at large by the
16 governor, with one member representing the business
17 community and one public member;

18 (5) Two members, appointed at large by the
19 governor, with one member being a private provider and
20 one member being affiliated with a hospital;

21 (6) Two members, appointed at large by the
22 governor, who are consumers of mental health services
23 or family members of consumers of mental health
24 services.

25 3. The review committee established in subsection
26 1 of this section shall be disbanded on January 1,
27 1996.

28 4. Notwithstanding any other provision of law to
29 the contrary, beginning July 1, 1997, if the review
30 committee failed to make the recommendations to the
31 governor and the general assembly as required in
32 subsection 1 of this section, the department of mental
33 health may contract directly with vendors operated or
34 funded pursuant to sections 205.975 to 205.990, or
35 operated or funded pursuant to sections 205.968 to
36 205.973, without competitive bids. All contracts with
37 vendors who are providers of a consortium of treatment
38 services to the clients of the division of
39 comprehensive psychiatric services shall be awarded in
40 accordance with chapter 34.]; and
