AN ACT

To amend chapter 407, RSMo, by adding thereto one new section relating to florists.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 407, RSMo, is amended by adding thereto one new
2 section, to be known as section 407.312, to read as follows:

**407.312. 1. As used in this section, the following terms shall
2 mean:**

3 **(1) "Florist", any business that derives fifty percent or more of its
4 gross income from the sale or arranging for the sale of flowers or floral
5 arrangements;**

6 **(2) "Local telephone number", a specific telephone number with
7 area code and prefix assigned for the purpose of completing local calls
8 between a calling party or station and any other party or station within
9 a designated exchange or all of its designated local calling areas. The
10 term "local telephone number" shall not mean long distance telephone
11 numbers or any toll-free telephone numbers listed in a local telephone
12 directory;**

13 **(3) "Person", shall have the same meaning as in section 407.010.**

14 **2. A person shall not misrepresent the geographical location of
15 a florist in a contact listing:**

16 **(1) In a telephone directory or other directory assistance
17 database;**

18 **(2) On an internet website; or**

19 **(3) In a print advertisement.**

20 **3. A person is considered to misrepresent the geographical**

21 location of a florist for purposes of this section if the name of the florist
22 indicates that the florist is located in a geographical area and:

23 (1) The florist is not physically located within the geographical
24 area indicated;

25 (2) The listing fails to identify the municipality and state of the
26 florist's actual physical geographical location; and

27 (3) A telephone call to the local telephone number provided for
28 the florist that is:

29 (a) Listed in the directory or database is routinely forwarded or
30 transferred to a location that is outside the calling area covered by the
31 directory or database in which the number is listed; or

32 (b) Provided on the internet website or in a print advertisement
33 is routinely forwarded or transferred to a location that is outside the
34 calling area of the geographical area indicated by the name of the
35 florist.

36 4. A person may place a contact listing for a florist under this
37 section when the name of the florist indicates that it is located in a
38 geographical area that is different from the geographical area in which
39 the florist is actually physically located if a conspicuous notice in the
40 listing states the municipality and state in which the florist is actually
41 physically located.

42 5. This section shall not apply to:

43 (1) A publisher of a telephone directory or other publication, or
44 a provider of a directory assistance service publishing or providing
45 information about another business;

46 (2) An internet website that aggregates and provides information
47 about other businesses;

48 (3) An owner or publisher of a print medium providing
49 information about other businesses;

50 (4) An internet service provider; or

51 (5) An internet service that displays or distributes
52 advertisements for other businesses.

53 6. A violation of this section shall be considered an unlawful
54 practice under 407.020 and may be prosecuted in the same manner as
55 any unlawful practice under that section.
