AN ACT

To repeal section 99.825, RSMo, and to enact in lieu thereof one new section relating to tax increment financing.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 99.825, RSMo, is repealed and one new section enacted 2 in lieu thereof, to be known as section 99.825, to read as follows:

99.825. 1. Prior to the adoption of an ordinance proposing the designation of a redevelopment area, or approving a redevelopment plan or redevelopment $\mathbf{2}$ project, the commission shall fix a time and place for a public hearing as required 3 in subsection 4 of section 99.820 and notify each taxing district located wholly or 4 partially within the boundaries of the proposed redevelopment area, plan or 56 project. At the public hearing any interested person or affected taxing district 7 may file with the commission written objections to, or comments on, and may be heard orally in respect to, any issues embodied in the notice. The commission 8 9 shall hear and consider all protests, objections, comments and other evidence 10 presented at the hearing. The hearing may be continued to another date without 11 further notice other than a motion to be entered upon the minutes fixing the time and place of the subsequent hearing; provided, if the commission is created under 12subsection 3 of section 99.820, the hearing shall not be continued for more than 1314thirty days beyond the date on which it is originally opened unless such longer period is requested by the chief elected official of the municipality creating the 15commission and approved by a majority of the commission. Prior to the 16 conclusion of the hearing, changes may be made in the redevelopment plan, 17redevelopment project, or redevelopment area, provided that each affected taxing 18

19 district is given written notice of such changes at least seven days prior to the 20conclusion of the hearing. After the public hearing but prior to the adoption of an ordinance approving a redevelopment plan or redevelopment project, or 2122designating a redevelopment area, changes may be made to the redevelopment 23plan, redevelopment projects or redevelopment areas without a further hearing, if such changes do not enlarge the exterior boundaries of the redevelopment area 24or areas, and do not substantially affect the general land uses established in the 2526redevelopment plan or substantially change the nature of the redevelopment 27projects, provided that notice of such changes shall be given by mail to each 28affected taxing district and by publication in a newspaper of general circulation 29in the area of the proposed redevelopment not less than ten days prior to the 30 adoption of the changes by ordinance. After the adoption of an ordinance 31approving a redevelopment plan or redevelopment project, or designating a 32redevelopment area, no ordinance shall be adopted altering the exterior 33 boundaries, affecting the general land uses established pursuant to the redevelopment plan or changing the nature of the redevelopment project without 3435complying with the procedures provided in this section pertaining to the initial 36 approval of a redevelopment plan or redevelopment project and designation of a redevelopment area. Hearings with regard to a redevelopment project, 37 38 redevelopment area, or redevelopment plan may be held simultaneously.

2. [Effective January 1, 2008,] (1) If, after concluding the hearing required under this section, the commission formed under subsection 2 of section 99.820 makes a recommendation [under section 99.820] in opposition to a proposed redevelopment plan, redevelopment project, or designation of a redevelopment area, or any amendments thereto, a municipality desiring to approve such project, plan, designation, or amendments shall do so only upon a two-thirds majority vote of the governing body of such municipality.

(2) If, after concluding the hearing required under this section, the commission formed under subsection 3 of section 99.820 makes a recommendation in opposition to a proposed redevelopment plan, redevelopment project, or designation of a redevelopment area, or any amendments thereto, a municipality desiring to approve such project, plan, designation, or amendments shall do so only upon a threeguarters majority vote of the governing body of such municipality.

53 3. Tax incremental financing projects within an economic development 54 area shall apply to and fund only the following infrastructure projects: highways,

- $55\,$ roads, streets, bridges, sewers, traffic control systems and devices, water
- 56 distribution and supply systems, curbing, sidewalks and any other similar public
- 57 improvements, but in no case shall it include buildings.
