AN ACT

To repeal sections 337.025, 337.029, and 337.033, RSMo, and to enact in lieu thereof three new sections relating to the licensure of psychologists.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 337.025, 337.029, and 337.033, RSMo, are repealed

2 and three new sections enacted in lieu thereof, to be known as sections 337.025,
3 337.029, and 337.033, to read as follows:

337.025. 1. The provisions of this section shall govern the education and
2 experience requirements for initial licensure as a psychologist for the following
3 persons:

4 (1) A person who has not matriculated in a graduate degree program 5 which is primarily psychological in nature on or before August 28, 1990; and

6 (2) A person who is matriculated after August 28, 1990, in a graduate 7 degree program designed to train professional psychologists.

8 2. Each applicant shall submit satisfactory evidence to the committee that 9 the applicant has received a doctoral degree in psychology from a recognized 10 educational institution, and has had at least one year of satisfactory supervised 11 professional experience in the field of psychology.

3. A doctoral degree in psychology is defined as:

(1) A program accredited, or provisionally accredited, by the American
Psychological Association or the Psychological Clinical Science
Accreditation System; or

(2) A program designated or approved, including provisional approval, by
the American Association of State Psychology Boards or the Council for the
National Register of Health Service Providers in Psychology, or both; or

(3) A graduate program that meets all of the following criteria:

20 (a) The program, wherever it may be administratively housed, shall be

clearly identified and labeled as a psychology program. Such a program shall
specify in pertinent institutional catalogues and brochures its intent to educate
and train professional psychologists;

24 (b) The psychology program shall stand as a recognizable, coherent 25 organizational entity within the institution of higher education;

(c) There shall be a clear authority and primary responsibility for the core
and specialty areas whether or not the program cuts across administrative lines;

(d) The program shall be an integrated, organized, sequence of study;

(e) There shall be an identifiable psychology faculty and a psychologistresponsible for the program;

31 (f) The program shall have an identifiable body of students who are32 matriculated in that program for a degree;

33 (g) The program shall include a supervised practicum, internship, field,
34 or laboratory training appropriate to the practice of psychology;

35 (h) The curriculum shall encompass a minimum of three academic years
36 of full-time graduate study, with a minimum of one year's residency at the
37 educational institution granting the doctoral degree; and

(i) Require the completion by the applicant of a core program in
psychology which shall be met by the completion and award of at least one
three-semester-hour graduate credit course or a combination of graduate credit
courses totaling three semester hours or five quarter hours in each of the
following areas:

a. The biological bases of behavior such as courses in: physiological
psychology, comparative psychology, neuropsychology, sensation and perception,
psychopharmacology;

b. The cognitive-affective bases of behavior such as courses in: learning,
thinking, motivation, emotion, and cognitive psychology;

c. The social bases of behavior such as courses in: social psychology,
group processes/dynamics, interpersonal relationships, and organizational and
systems theory;

d. Individual differences such as courses in: personality theory, human
development, abnormal psychology, developmental psychology, child psychology,
adolescent psychology, psychology of aging, and theories of personality;

e. The scientific methods and procedures of understanding, predicting and influencing human behavior such as courses in: statistics, experimental design, psychometrics, individual testing, group testing, and research design and methodology. 584. Acceptable supervised professional experience shall consist of a minimum of fifteen hundred hours of professional experience obtained in not less 59than twelve nor more than twenty-four consecutive calendar months. In no case 60 61 shall this experience be accumulated at a rate of less than twenty hours per week 62 nor more than fifty hours per week. Postdoctoral supervised professional 63 experience for prospective health service providers shall involve and relate to the delivery of psychological health services. Postdoctoral supervised professional 64 65 experience for other applicants shall be in accordance with professional 66 requirements and relevant to the applicant's intended area of practice.

67 5. Postdoctoral experience for those applicants who intend to seek health service provider certification and who have completed a program in one or more 68 of the American Psychological Association designated health service provider 69 delivery areas shall be obtained under the primary supervision of a licensed 70psychologist who is also a health service provider or who otherwise meets the 71requirements for health service provider certification. Postdoctoral experience for 7273those applicants who do not intend to seek health service provider certification 74shall be obtained under the primary supervision of a licensed psychologist or such other qualified mental health professional approved by the committee. 75

766. The psychological activities of the applicant shall be performed pursuant to the primary supervisor's order, control, and full professional 7778responsibility. The primary supervisor shall maintain a continuing relationship 79 with the applicant and shall meet with the applicant a minimum of one hour per 80 month in face-to-face individual supervision. Clinical supervision may be 81 delegated by the primary supervisor to one or more secondary supervisors who 82 are qualified psychologists. The secondary supervisors shall retain order, control 83 and full professional responsibility for the applicant's clinical work under their supervision and shall meet with the applicant a minimum of one hour per week 84 in face-to-face individual supervision. If the primary supervisor is also the 85 clinical supervisor, meetings shall be a minimum of one hour per week. Group 86 supervision shall not be acceptable for supervised professional experience. The 87 primary supervisor shall certify to the committee that the applicant has complied 88 89 with these requirements and that the applicant has demonstrated ethical and competent practice of psychology. The changing by an agency of the primary 90 91 supervisor during the course of the supervised experience shall not invalidate the 92 supervised experience.

93 7. The committee by rule shall provide procedures for exceptions and 94 variances from the requirements for once a week face-to-face supervision due to 6

95 vacations, illness, pregnancy, and other good causes.

337.029. 1. A psychologist licensed in another jurisdiction who has had 2 no violations and no suspensions and no revocation of a license to practice 3 psychology in any jurisdiction may receive a license in Missouri, provided the 4 psychologist passes a written examination on Missouri laws and regulations 5 governing the practice of psychology and meets one of the following criteria:

(1) Is a diplomate of the American Board of Professional Psychology;

7 (2) Is a member of the National Register of Health Service Providers in8 Psychology;

9 (3) Is currently licensed or certified as a psychologist in another 10 jurisdiction who is then a signatory to the Association of State and Provincial 11 Psychology Board's reciprocity agreement;

12 (4) Is currently licensed or certified as a psychologist in another state,13 territory of the United States, or the District of Columbia and:

(a) Has a doctoral degree in psychology from a program accredited, or
provisionally accredited, by the American Psychological Association or the
Psychological Clinical Science Accreditation System, or that meets the
requirements as set forth in subdivision (3) of subsection 3 of section 337.025;

(b) Has been licensed for the preceding five years; and

(c) Has had no disciplinary action taken against the license for thepreceding five years; or

(5) Holds a current certificate of professional qualification (CPQ) issued
by the Association of State and Provincial Psychology Boards (ASPPB).

23 2. Notwithstanding the provisions of subsection 1 of this section,
24 applicants may be required to pass an oral examination as adopted by the
25 committee.

3. A psychologist who receives a license for the practice of psychology in the state of Missouri on the basis of reciprocity as listed in subsection 1 of this section or by endorsement of the score from the examination of professional practice in psychology score will also be eligible for and shall receive certification from the committee as a health service provider if the psychologist meets one or more of the following criteria:

(1) Is a diplomate of the American Board of Professional Psychology in one
or more of the specialties recognized by the American Board of Professional
Psychology as pertaining to health service delivery;

35 (2) Is a member of the National Register of Health Service Providers in36 Psychology; or

(3) Has completed or obtained through education, training, or experience
the requisite knowledge comparable to that which is required pursuant to section
337.033.

337.033. 1. A licensed psychologist shall limit his or her practice to demonstrated areas of competence as documented by relevant professional education, training, and experience. A psychologist trained in one area shall not practice in another area without obtaining additional relevant professional education, training, and experience through an acceptable program of respecialization.

7 2. A psychologist may not represent or hold himself or herself out as a state certified or registered psychological health service provider unless the 8 9 psychologist has first received the psychologist health service provider certification from the committee; provided, however, nothing in this section shall 10 be construed to limit or prevent a licensed, whether temporary, provisional or 11 12permanent, psychologist who does not hold a health service provider certificate 13 from providing psychological services so long as such services are consistent with subsection 1 of this section. 14

153. "Relevant professional education and training" for health service provider certification, except those entitled to certification pursuant to subsection 165 or 6 of this section, shall be defined as a licensed psychologist whose graduate 1718 psychology degree from a recognized educational institution is in an area 19 designated by the American Psychological Association as pertaining to health 20service delivery or a psychologist who subsequent to receipt of his or her graduate 21degree in psychology has either completed a respecialization program from a 22recognized educational institution in one or more of the American Psychological 23Association recognized clinical health service provider areas and who in addition has completed at least one year of postdegree supervised experience in such 24clinical area or a psychologist who has obtained comparable education and 25training acceptable to the committee through completion of postdoctoral 2627fellowships or otherwise.

4. The degree or respecialization program certificate shall be obtained from a recognized program of graduate study in one or more of the health service delivery areas designated by the American Psychological Association as pertaining to health service delivery, which shall meet one of the criteria established by subdivisions (1) to (3) of this subsection:

(1) A doctoral degree or completion of a recognized respecialization
 program in one or more of the American Psychological Association designated

35 health service provider delivery areas which is accredited, or provisionally36 accredited, by the American Psychological Association or the Psychological

37 Clinical Science Accreditation System; or

(2) A clinical or counseling psychology doctoral degree program or
respecialization program designated, or provisionally approved, by the Association
of State and Provincial Psychology Boards or the Council for the National
Register of Health Service Providers in Psychology, or both; or

42 (3) A doctoral degree or completion of a respecialization program in one
43 or more of the American Psychological Association designated health service
44 provider delivery areas that meets the following criteria:

(a) The program, wherever it may be administratively housed, shall be
clearly identified and labeled as being in one or more of the American
Psychological Association designated health service provider delivery areas;

(b) Such a program shall specify in pertinent institutional catalogues and
brochures its intent to educate and train professional psychologists in one or more
of the American Psychological Association designated health service provider
delivery areas.

52 5. A person who is lawfully licensed as a psychologist pursuant to the 53 provisions of this chapter on August 28, 1989, or who has been approved to sit for 54 examination prior to August 28, 1989, and who subsequently passes the 55 examination shall be deemed to have met all requirements for health service 56 provider certification; provided, however, that such person shall be governed by 57 the provisions of subsection 1 of this section with respect to limitation of practice.

6. Any person who is lawfully licensed as a psychologist in this state and who meets one or more of the following criteria shall automatically, upon payment of the requisite fee, be entitled to receive a health service provider certification from the committee:

(1) Is a diplomate of the American Board of Professional Psychology in one
or more of the specialties recognized by the American Board of Professional
Psychology as pertaining to health service delivery; or

65 (2) Is a member of the National Register of Health Service Providers in66 Psychology.
