### AN ACT

To repeal section 301.3097, RSMo, and to enact in lieu thereof one new section relating to the World War I memorial trust fund.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 301.3097, RSMo, is repealed and one new section 2 enacted in lieu thereof, to be known as section 301.3097, to read as follows:

301.3097. 1. Any vehicle owner may apply for "God Bless America"  $\mathbf{2}$ license plates for any motor vehicle the person owns, either solely or jointly, other 3 than an apportioned motor vehicle or a commercial motor vehicle licensed in excess of eighteen thousand pounds gross weight. Upon making a ten dollar 4 contribution to the World War [II] I memorial **trust** fund the vehicle owner may 5 apply for the "God Bless America" plate. If the contribution is made directly to 6 the Missouri veterans' commission they shall issue the individual making the 7 contribution a receipt, verifying the contribution, that may be used to apply for 8 9 the "God Bless America" license plate. If the contribution is made directly to the 10 director of revenue pursuant to section 301.3031, the director shall note the 11 contribution and the owner may then apply for the "God Bless America" plate. The applicant for such plate must pay a fifteen dollar fee in addition to the 12regular registration fees and present any other documentation required by law 13 for each set of "God Bless America" plates issued pursuant to this 14 section. Notwithstanding the provisions of section 301.144, no additional fee 15shall be charged for the personalization of license plates issued pursuant to this 16 section. The "God Bless America" plate shall bear the emblem of the American 17flag in a form prescribed by the director of revenue and shall have the words 18 "GOD BLESS AMERICA" in place of the words "SHOW-ME-STATE". Such 19

license plates shall be made with fully reflective material with a common color
scheme and design, shall be clearly visible at night, and shall be aesthetically
attractive, as prescribed by section 301.130.

232. The director of revenue may promulgate rules and regulations for the administration of this section. Any rule or portion of a rule, as that term is 2425defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the 26provisions of chapter 536 and, if applicable, section 536.028. This section and 27chapter 536 are nonseverable and if any of the powers vested with the general 28assembly pursuant to chapter 536 to review, to delay the effective date or to 29disapprove and annul a rule are subsequently held unconstitutional, then the 30 31grant of rulemaking authority and any rule proposed or adopted after August 28, 322002, shall be invalid and void.
