## AN ACT

To repeal sections 334.700, 334.702, 334.704, 334.706, 334.708, 334.710, 334.712, 334.715, 334.717, 334.719, 334.720, 334.721, and 334.725, RSMo, and to enact in lieu thereof fourteen new sections relating to athletic trainers, with a penalty provision.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 334.700, 334.702, 334.704, 334.706, 334.708, 334.710,

- 2 334.712, 334.715, 334.717, 334.719, 334.720, 334.721, and 334.725, RSMo, are
- 3 repealed and fourteen new sections enacted in lieu thereof, to be known as
- 4 sections 334.700, 334.702, 334.703, 334.704, 334.706, 334.708, 334.710, 334.712,
- 5 334.715, 334.717, 334.719, 334.720, 334.721, and 334.725, to read as follows:
- 334.700. Sections 334.700 to 334.725 shall be known and may be cited as
- 2 the "Missouri Athletic Trainers **Practice** Act".
  - 334.702. As used in sections 334.700 to 334.725, unless the context clearly
- 2 requires otherwise, the following terms mean:
- 3 (1) ["Athlete", a person who participates in a sanctioned amateur or
- 4 professional sport or recreational sport activity;
- 5 (2)] "Athletic trainer", a [person] health care professional who meets
- 6 the qualifications of section 334.708 and who, in collaboration with, or upon
- 7 the direction of [the team physician and/or consulting], or prescription from
- 8 a physician, [practices prevention, emergency care, first aid, treatment, or
- 9 physical rehabilitation of injuries incurred by athletes in the manner, means, and
- 10 methods deemed necessary to effect care or rehabilitation, or both] provides
- 11 health care services for physically active individuals;
- 12 [(3)] (2) "Athletic training", includes but is not limited to the

provision of preventative health services, emergency care, clinical examination and clinical diagnosis, therapeutic intervention and physical medicine, and rehabilitation of injuries and medical conditions. Athletic trainers shall practice within the scope of their education and training as provided in sections 334.700 to 334.725;

- 18 (3) "Athletic training student", a person enrolled in an athletic 19 training program accredited by the Commission on Accreditation of 20 Athletic Training Education, or its successor agency, and who, as part 21 of said program, assists in the duties usually performed by a licensed 22 athletic trainer and who works under the direct supervision of a 23 licensed health care professional;
- 24 (4) "Board", the [Missouri] state board of registration for the healing 25 arts;
- 26 [(4)] **(5)** "Committee", the **Missouri** athletic [trainers] **trainer** advisory 27 committee:
- [(5)] (6) "Division", the division of professional registration of the department of insurance, financial institutions and professional registration[;
- 31 (6) "Student athletic trainer", a person who assists in the duties usually 32 performed by a licensed athletic trainer and who works under the direct 33 supervision of a licensed athletic trainer.
- 334.703. 1. As used in this section, "approved health care provider" means a physician licensed under this chapter, a health care provider entered into a collaborative practice agreement with a physician licensed under this chapter, or any physician duly licensed in another jurisdiction.
- 2. An athletic trainer may initiate treatment for a new injury or illness with a prescription from an approved health care provider or a treatment otherwise endorsed through a functional protocol by a collaborating or directing physician licensed under this chapter.
  - 3. An athletic trainer shall refer to a physician any individual whose medical condition is beyond the scope of the athletic trainer's education, training, and competence.
- 4. Nothing in this section shall be construed as to limit the ability of athletic trainers to provide health care services in accordance with the provisions of this chapter.

- 2 [in this state], by title or description, including the words "athletic
- 3 trainer" (AT), "licensed athletic trainer" (LAT), or "certified athletic
- 4 trainer" (ATC), unless such person has been licensed as such under the
- 5 provisions of sections 334.700 to 334.725.
  - 334.706. 1. The board shall license applicants who meet the qualifications
- 2 for athletic trainers, who file for licensure, and who pay all fees required for this
- 3 licensure.
- 4 2. The board may issue a temporary license to any otherwise
- 5 qualified athletic trainer as defined by rule. A temporary license may
- 6 be granted upon the payment of a license fee and the applicant meeting
- 7 the necessary qualifications for permanent licensure. The board may
- 8 issue a temporary license to any athletic trainer who is licensed in
- 9 another jurisdiction and who has had no violations, suspensions, or
- 10 revocations of a license to practice as an athletic trainer in any
- 11 jurisdiction whose requirements are substantially equal to, or greater
- 12 than, the requirements for licensure of athletic trainers in Missouri.
- 13 **3.** The board shall:
- 14 (1) Prescribe application forms to be furnished to all persons seeking
- 15 licensure pursuant to sections 334.700 to 334.725;
- 16 (2) Prescribe the form and design of the licensure to be issued pursuant
- 17 to sections 334.700 to 334.725;
- 18 (3) Set the fee for licensure and renewal thereof;
- 19 (4) Keep a record of all of its proceedings regarding the Missouri Athletic
- 20 Trainers **Practice** Act and of all athletic trainers licensed in this state;
- 21 (5) [Annually prepare] Make available a roster of the names and
- 22 **business** addresses of all athletic trainers licensed in this state, copies of which
- 23 shall be made available upon request to any person paying the fee therefor;
- 24 (6) Set the fee for the roster at an amount sufficient to cover the actual
- 25 cost of publishing and distributing the roster;
- 26 (7) (6) Appoint members of the Missouri athletic trainer advisory
- 27 committee[;
- 28 (8) Adopt an official seal].
- 29 [3.] **4.** The board may:
- 30 (1) Issue subpoenas to compel witnesses to testify or produce evidence in
- 31 proceedings to deny[, suspend, or revoke] a license or licensure or discipline a
- 32 license;

33 (2) Promulgate rules pursuant to chapter 536 in order to carry out the 34 provisions of sections 334.700 to 334.725;

- 35 (3) Establish guidelines for athletic trainers in sections 334.700 to 36 334.725.
- 37 [4.] 5. No rule or portion of a rule promulgated under the authority of sections 334.700 to 334.725 shall become effective unless it has been promulgated pursuant to the provisions of section 536.024.
- 334.708. [1.] Any person seeking licensure pursuant to sections 334.700 to 334.725 after August 28, 2006, must [be a resident or in the process of establishing residency in this state and] have passed the National Athletic Trainers Association Board of Certification, or its successor agency, examination[.
- 2. The board shall grant, without examination, licensure to any qualified nonresident athletic trainer holding a license or licensure in another state if such other state recognizes licenses or licensure of the state of Missouri in the same manner and meet other requirements established by the board by rule.
- 334.710. 1. All applications for initial licensure pursuant to sections 334.700 to 334.725 shall be submitted on forms prescribed by the board and shall be accompanied by an initial licensure fee. All applications for renewal of licensure issued pursuant to sections 334.700 to 334.725 shall be submitted on forms prescribed by the board and shall be accompanied by a renewal fee.
- 2. All fees of any kind and character authorized to be charged by the board shall be [paid to the director of revenue and shall be deposited by the state treasurer into the board for the healing arts fund, to be disbursed only in payment for expenses of maintaining the athletic trainer licensure program and for the enforcement of the provisions of sections 334.700 to 334.725] collected and deposited pursuant to section 334.050.
  - 334.712. 1. Any person who meets the qualifications listed in section 334.708, submits his or her application and fees in accordance with section 334.710, and has not committed any act listed in section 334.715 shall be issued 4 a license pursuant to sections 334.700 to 334.725.
- 2. Each license issued pursuant to sections 334.700 to 334.725 shall contain the name of the person to whom it was issued, the date on which it was issued and such other information as the board deems advisable. All licenses issued pursuant to sections 334.700 to 334.725 shall expire on [January thirtieth of each year] a schedule established by rule.
  - 334.715. 1. The board may refuse to issue or renew any license required

under sections 334.700 to 334.725 for one or any combination of causes listed in 3 subsection 2 of this section or any cause listed in section 334.100. The board shall notify the applicant in writing of the reasons for the refusal and shall advise the applicant of the applicant's right to file a complaint with the administrative hearing commission as provided in chapter 621. As an alternative to a refusal to issue or renew any certificate, registration, or authority, the board may, in its discretion, issue a license which is subject to reprimand, probation, restriction, or limitation to an applicant for licensure for any one or any combination of causes listed in subsection 2 of this section or section 334.100. The board's order 10 11 of reprimand, probation, limitation, or restriction shall contain a statement of the 12 discipline imposed, the basis therefor, the date such action shall become effective, 13 and a statement that the applicant has thirty days to request in writing a hearing before the administrative hearing commission. If the board issues a probationary, 14 limited, or restricted license to an applicant for licensure, either party may file 15 16 a written petition with the administrative hearing commission within thirty days of the effective date of the probationary, limited, or restricted license seeking 17 18 review of the board's determination. If no written request for a hearing is received by the administrative hearing commission within the thirty-day period, 19 20 the right to seek review of the board's decision shall be considered waived. 21

- 2. The board may cause a complaint to be filed with the administrative hearing commission as provided in chapter 621 against any holder of a certificate of registration or authority, permit, or license required by sections 334.700 to 334.725 or any person who has failed to renew or has surrendered the person's certification of registration or license for any one or any combination of the following causes:
- 27 (1) Violated or conspired to violate any provision of sections 334.700 to 334.725 or any provision of any rule promulgated pursuant to sections 334.700 to 334.725; or
- 30 (2) Has been found guilty of unethical conduct as defined in the ethical 31 standards of the National Athletic Trainers Association or the National Athletic 32 [Trainers] Trainers' Association Board of Certification, or its successor agency, 33 as adopted and published by the committee and the board and filed with the 34 secretary of state; or
  - (3) Is no longer certified as an athletic trainer by the National Athletic Trainers' Association Board of Certification, Inc., or its successor agency; or

- 38 (4) Any cause listed in section 334.100.
- 39 3. After the filing of such complaint before the administrative hearing
- 40 commission, the proceedings shall be conducted in accordance with the provisions
- 41 of chapter 621. Upon a finding by the administrative hearing commission that
- 42 the grounds provided in subsection 2 of this section for disciplinary action are
- 43 met, the board may, singly or in combination[:
- 44 (1) Warn, censure, or place the person named in the complaint on
- 45 probation on such terms and conditions as the board deems appropriate for a
- 46 period not to exceed ten years; or
- 47 (2) Suspend the person's license, certificate, or permit for a period not to
- 48 exceed three years; or
- 49 (3) Administer a public or private reprimand; or
- 50 (4) Deny the person's application for a license; or
- 51 (5) Permanently withhold issuance of a license or require the person to
- 52 submit to the care, counseling, or treatment of physicians designated by the board
- 53 at the expense of the individual to be examined; or
- 54 (6) Require the person to attend such continuing education courses and
- 55 pass such examinations as the board may direct; or
- 56 (7) Restrict or limit the person's license for an indefinite period of time;
- 57 or
- 58 (8) Revoke the person's license.
- 59 4. In any order of revocation, the board may provide that the person shall
- 60 not apply for reinstatement of the person's license for a period of time ranging
- 61 from two to seven years following the date of the order of revocation. All stay
- 62 orders shall toll such time period.
- 5. Before restoring to good standing a license, certificate, or permit issued
- 64 under this chapter which has been in a revoked, suspended, or inactive state for
- 65 any cause for more than two years, the board may require the applicant to attend
- 66 such continuing education courses and pass such examinations as the board may
- 67 direct] impose any of the disciplines authorized in section 334.100.
  - 334.717. 1. There is hereby created the "Missouri Athletic Trainer
  - 2 Advisory Committee", to be composed of five members to be appointed by the
  - 3 board.
  - 4 2. The athletic trainer advisory committee shall:
- 5 (1) Assist the board in conducting [examinations] evaluations for
- 6 applicants of athletic trainer licensure;

7 (2) Advise the board on all matters pertaining to the licensure of athletic 8 trainers;

- 9 (3) Review all complaints and/or investigations wherein there is a possible 10 violation of **section 334.100**, sections 334.700 to 334.725, or regulations 11 promulgated pursuant thereto and make recommendations to the board for action;
- 12 (4) Follow the provisions of the board's administrative practice procedures 13 in conducting all official duties.
  - 3. [Each] **The** athletic trainer advisory committee [member] shall **be** comprised as such:
  - (1) Each member shall be a citizen of the United States and a resident of the state of Missouri for five years [next] immediately preceding appointment and remain a resident of the state of Missouri throughout the term; and
- 19 (2) [Be comprised of] Three **members shall be** licensed athletic trainers 20 [except for initial appointees]; and
- 21 (3) One member shall be a physician duly licensed by the Missouri state 22 board **of registration** for the healing arts; and
  - (4) One member shall be a general public member; and
  - (5) One member shall be a member of the board.
- 4. [Except for the initial appointees,] Members shall hold office for terms of six years. [The board shall designate one member for a term expiring in 1984, one member for a term expiring in 1985, one member for a term expiring in 1986, one member for a term expiring in 1987, and one member for a term expiring in 1988.] In the event of death, resignation, or removal of any member, the vacancy of the unexpired term shall be filled by the board in the same manner as the other appointments.

334.720. Notwithstanding any other provision of law to the contrary, any

- 2 appointed member of the board shall receive as compensation an amount

- 334.721. 1. Nothing in sections 334.700 to 334.725 shall be construed to
- 2 authorize the practice of medicine by any person not licensed by the state board
- 3 of registration for the healing arts.
- 4 2. Athletic trainers are not authorized to prescribe, dispense, or
- 5 administer any controlled substance other than that administered or
- 6 dispensed upon the direction of a physician, or in accordance with
  - sections 167.630, 167.635, and 167.809.
- 8 **3.** The provisions of sections 334.700 to 334.725 shall not apply to the
- 9 following persons:
- 10 (1) Physicians and surgeons licensed by the state board of registration for
- 11 the healing arts as defined in chapter 334;
- 12 (2) [Dentists licensed by the Missouri dental board who confine their
- 13 practice strictly to dentistry;
- 14 (3) Optometrists licensed by the state board of optometry who confine
- 15 their practice strictly to optometry, as defined in section 336.010;
- 16 (4) Nurses licensed by the state board of nursing who confine their
- 17 practice strictly to nursing as defined in section 335.106;
- 18 [(5)] (3) Chiropractors licensed by the state board of chiropractic
- 19 examiners who confine themselves strictly to the practice of chiropractic, as
- 20 defined in section 331.010;
- 21 [(6)] (4) Podiatrists licensed by the state board of chiropody or podiatry
- 22 who confine their practice strictly to that of a podiatrist, as defined in section
- 23 330.010;
- [(7)] (5) Professional physical therapists licensed by the state board of
- 25 registration for the healing arts who confine their practice strictly to professional
- 26 physical therapy, as defined in section 334.500;
- 27 [(8) Coaches and physical education instructors in the performance of
- 28 their duties;
- 29 (9) (6) Athletic training students who confine themselves strictly to their
- 30 duties as defined in sections 334.700 to 334.725;

[(10)] (7) Athletic trainers holding a valid credential from other nations, states, or territories performing their duties for their respective teams or organizations if they restrict their duties only to their teams or organizations and only during the course of their teams' or organizations' [stay] visit, not to exceed thirty days in one calendar year, in this state.

334.725. Any person who violates any provision of sections 334.700 to 2 334.725 is guilty of a misdemeanor and, upon conviction thereof, shall be 3 punished as for a class [C] B misdemeanor.
