AN ACT

To repeal section 143.1016, RSMo, and to enact in lieu thereof one new section relating to the organ donor program fund.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 143.1016, RSMo, is repealed and one new section 2 enacted in lieu thereof, to be known as section 143.1016, to read as follows:

143.1016. 1. For all tax years beginning on or after January 1, 2011, each individual or corporation entitled to a tax refund in an amount sufficient to make 2 3 a designation under this section may designate that two dollars or any amount in excess of two dollars on a single return, and four dollars or any amount in 4 excess of four dollars on a combined return, of the refund due be credited to the $\mathbf{5}$ organ donor program fund established in section 194.297. The contribution 6 7 designation authorized by this section shall be clearly and unambiguously printed 8 on each income tax return form provided by this state. If any individual that is 9 not entitled to a tax refund in an amount sufficient to make a designation under this section wishes to make a contribution to the organ donor program fund, such 10 11 individual may, by separate check, draft, or other negotiable instrument, send in 12with the payment of taxes, or may send in separately, clearly designated for the organ donor program fund, the amount the individual wishes to contribute. The 13 department of revenue shall deposit such amount to the organ donor program 14fund as provided in subsection 2 of this section. 15

2. The director of revenue shall transfer at least monthly all contributions

17 designated by individuals under this section, less an amount sufficient to cover 18 the cost of collecting and handling by the department of revenue which shall not 19 exceed five percent of the transferred contributions, to the state treasurer for 20 deposit in the state treasury to the credit of the organ donor program fund. A 21 contribution designated under this section shall only be transferred and deposited 22 in the organ donor program fund after all other claims against the refund from 23 which such contribution is to be made have been satisfied.

3. All moneys transferred to the fund shall be distributed as provided inthis section and sections 194.297 and 194.299.

26 [4. Under section 23.253 of the Missouri sunset act:

(1) The provisions of the new program authorized under this section shall
automatically sunset on December thirty-first six years after August 28, 2011,
unless reauthorized by an act of the general assembly; and

30 (2) If such program is reauthorized, the program authorized under this
31 section shall automatically sunset on December thirty-first twelve years after the
32 effective date of the reauthorization of this section; and

(3) This section shall terminate on September first of the calendar year
immediately following the calendar year in which the program authorized under
this section is sunset.]
