AN ACT

To amend chapter 227, RSMo, by adding thereto twelve new sections relating to the designation of certain transportation infrastructure.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 227, RSMo, is amended by adding thereto twelve new
2 sections, to be known as sections 227.411, 227.432, 227.433, 227.434, 227.436,
3 227.437, 227.438, 227.440, 227.442, 227.444, 227.528, and 227.529, to read as
4 follows:

**227.411. The portion of Business Highway 37 in Barry County
2 within the city limits of Cassville shall be designated as the "Senator
3 Emory Melton Memorial Highway". The department of transportation
4 shall erect and maintain appropriate signs designating such highway,
5 with the costs for such designation to be paid for by private donation.**

**227.432. The portion of Interstate 470 at the interchange with
2 Woods Chapel Road continuing to Lakewood Boulevard in Jackson
3 County shall be designated as the "Judge Vincent E. Baker Memorial
4 Highway". The department of transportation shall erect and maintain
5 appropriate signs designating such highway, with the costs to be paid**

6 for by private donations.

227.433. The portion of U.S. Highway 61 from the intersection
2 with Warren Barrett Drive continuing north through the city of
3 Hannibal to County Road 407 in Marion County shall be designated as
4 the "Tom Boland Highway". The department of transportation shall
5 erect and maintain appropriate signs designating such highway, with
6 the costs to be paid for by private donations.

227.434. The portion of U.S. Highway 50 from Main Street Road
2 to the intersection of U.S. Highway 65 in Pettis County shall be
3 designated "LeRoy Van Dyke Highway". The department of
4 transportation shall erect and maintain appropriate signs designating
5 such highway with the costs to be paid by private donations.

227.436. The portion of U.S. Highway 63 from Breedlove Drive to
2 Peabody Road in Boone County shall be designated as "U.S. Army
3 Specialist Steven Paul Farnen Memorial Highway". The department of
4 transportation shall erect and maintain appropriate signs designating
5 such highway, with costs to be paid by private donations.

227.437. The portion of U.S. Highway 63 from the interchange
2 with Discovery Parkway to Interstate 70 in Boone County shall be
3 designated as "U.S. Navy Lieutenant Patrick Kelly Connor Memorial
4 Highway". The department of transportation shall erect and maintain
5 appropriate signs designating such highway, with costs to be paid by
6 private donations.

227.438. The portion of U.S. Highway 50 from the intersection
2 with U.S. Highway 65 continuing east to the Air Center Circle in Pettis
3 County shall be designated as the "Scott Joplin Memorial
4 Highway". The department of transportation shall erect and maintain
5 appropriate signs designating such highway with the costs to be paid
6 by private donations.

227.440. The portion of Highway 94 from the intersection with
2 Interstate 64 to Mid Rivers Mall Drive/Pitman Hill Road in St. Charles
3 County shall be designated as the "Col. Stephen Scott Memorial
4 Highway". The department of transportation shall erect and maintain
5 appropriate signs designating such highway, with the costs of such
6 designation to be paid for by private donation.

227.442. The portion of State Route PP from the intersection of
2 Westwood Boulevard west to the Route 67 interchange in Butler County

3 shall be designated the "PVT Billie G. Kanell Cong. Medal of Honor
4 Memorial Highway". The department shall erect and maintain
5 appropriate signs designating such highway with the costs to be paid
6 for by private donations.

227.444. The bridge on U.S. Highway 169 crossing over the
2 Missouri River from Jackson County to Clay County shall be designated
3 the "John Jordan "Buck" O'Neil Memorial Bridge". The department of
4 transportation shall erect and maintain appropriate signs designating
5 the bridge, with the costs for such designation to be paid for by private
6 donation.

227.528. The portion of State Highway 367 from the southern city
2 limit of Bellefontaine Neighbors north to the intersection of Interstate
3 270 in St. Louis County shall be designated "Sgt. Peggy Vassallo
4 Way". The department of transportation shall erect and maintain
5 appropriate signs designating such highway with the costs to be paid
6 by private donations.

227.529. The portion of U.S. Highway 67 from Route M traveling
2 north to U.S. Highway 67/60 Interchange through the city of Poplar
3 Bluff in Butler County shall be designated as the "SSgt Eric W.
4 Summers Memorial Highway". The department of transportation shall
5 erect and maintain appropriate signs designating such highway, with
6 the costs of such designation to be paid for by private donation.
