SENATE BILL NO. 95

AN ACT

To repeal sections 50.622, 347.740, 351.127, 355.023, 356.233, 359.653, 400.9-528, and 417.018, RSMo, and to enact in lieu thereof eight new sections relating to public funds.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF MISSOURI, AS FOLLOWS:

- 1 Section A. Sections 50.622, 347.740, 351.127, 355.023,
- 2 356.233, 359.653, 400.9-528, and 417.018, RSMo, are repealed and
- 3 eight new sections enacted in lieu thereof, to be known as
- 4 sections 50.622, 347.740, 351.127, 355.023, 356.233, 359.653,
- 5 400.9-528, and 417.018, to read as follows:
- 6 50.622. 1. Any county may amend the annual budget during
- 7 any fiscal year in which the county receives additional funds,
- 8 and such amount or source, including, but not limited to, federal
- 9 or state grants or private donations, could not be estimated when
- 10 the budget was adopted. The county shall follow the same
- 11 procedures as required in sections 50.525 to 50.745 for adoption
- of the annual budget to amend its budget during a fiscal year.
- 13 2. Any county may decrease the annual budget twice during
- 14 any fiscal year in which the county experiences a verifiable
- decline in funds of two percent or more, and such amount could
- 16 not be estimated or anticipated when the budget was adopted,

- 1 provided that any decrease in appropriations shall not unduly
- 2 affect any one officeholder. Before any reduction affecting an
- 3 independently elected officeholder can occur, negotiations shall
- 4 take place with all officeholders who receive funds from the
- 5 affected category of funds in an attempt to cover the shortfall.
- 6 The county shall follow the same procedures as required in
- 7 sections 50.525 to 50.745 to decrease the annual budget, except
- 8 that the notice provided for in section 50.600 shall be extended
- 9 to thirty days for purposes of this subsection. Such notice
- shall include a published summary of the proposed reductions and
- 11 an explanation of the shortfall.
- 12 3. Any decrease in an appropriation authorized under
- 13 subsection 2 of this section shall not impact any dedicated fund
- otherwise provided by law.
- 4. County commissioners may reduce budgets of departments
- under their direct supervision and responsibility at any time
- 17 without the restrictions imposed by this section.
- 5. Subsections 2, 3, and 4 of this section shall expire on
- 19 July 1, [2016] 2027.
- 20 6. Notwithstanding the provisions of this section, no
- 21 charter county shall be restricted from amending its budget under
- 22 and pursuant to the terms of its charter.
- 23 347.740. The secretary of state may collect an additional
- fee of five dollars on each and every fee required in this
- 25 chapter. All fees collected as provided in this section shall be
- deposited in the state treasury and credited to the secretary of
- 27 state's technology trust fund account. The provisions of this
- section shall expire on December 31, [2017] 2021.

- 351.127. The secretary of state may collect an additional 2 fee of five dollars on each and every fee required in this chapter, provided that the secretary of state may collect an 3 additional fee of ten dollars on each corporate registration 5 report fee filed under section 351.122. All fees collected as
- 6 provided in this section shall be deposited in the state treasury
- 7 and credited to the secretary of state's technology trust fund
- 8 account. The provisions of this section shall expire on December
- 9 31, [2017] 2021.

- 10 355.023. The secretary of state may collect an additional 11 fee of five dollars on each and every fee required in this 12 chapter. All fees collected as provided in this section shall be 13 deposited in the state treasury and credited to the secretary of 14 state's technology trust fund account. The provisions of this
- 15 section shall expire on December 31, [2017] 2021.
- 16 356.233. The secretary of state may collect an additional 17 fee of five dollars on each and every fee required in this chapter. All fees collected as provided in this section shall be 18 19 deposited in the state treasury and credited to the secretary of 20 state's technology trust fund account. The provisions of this
- 21 section shall expire on December 31, [2017] 2021.
- 22 359.653. The secretary of state may collect an additional 23 fee of five dollars on each and every fee required in this
- chapter. All fees collected as provided in this section shall be 24
- 25 deposited in the state treasury and credited to the secretary of
- 26 state's technology trust fund account. The provisions of this
- 27 section shall expire on December 31, [2017] 2021.
- 28 400.9-528. The secretary of state may collect an additional

1	fee of five dollars on each and every fee paid to the secretary
2	of state as required in chapter 400.9. All fees collected as
3	provided in this section shall be deposited in the state treasury
4	and credited to the secretary of state's technology trust fund
5	account. The provisions of this section shall expire on December
6	31, [2017] <u>2021</u> .
7	417.018. The secretary of state may collect an additional
8	fee of five dollars on each and every fee required in this
9	chapter. All fees collected as provided in this section shall be
10	deposited in the state treasury and credited to the secretary of
11	state's technology trust fund account. The provisions of this
12	section shall expire on December 31, [2017] 2021.
