AN ACT

To amend chapter 227, RSMo, by adding thereto seven new sections relating to infrastructure designations.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF MISSOURI,  
AS FOLLOWS:

1           Section A. Chapter 227, RSMo, is amended by adding thereto  
2 seven new sections, to be known as sections 227.447, 227.448,  
3 227.449, 227.532, 227.533, 227.535, and 1, to read as follows:

4           227.447. The portion of Interstate Highway 55 from its  
5 interchange with U.S. Highway 61 at exit 170 continuing north to  
6 the point at which U.S. Highway 61 overpasses Interstate Highway  
7 55 in Jefferson County shall be designated the "USMA Cadet Thomas  
8 M. Surdyke Memorial Highway". The department of transportation  
9 shall erect and maintain appropriate signs designating such  
10 highway, with the costs to be paid by private donations.

11           227.448. The portion of Business 25 from Taylor Street  
12 continuing north to Douglas Street through the city of Malden in  
13 Dunklin County shall be designated the "Narvel Felts Highway".  
14 The department of transportation shall erect and maintain  
15 appropriate signs designating such highway, with the costs to be  
16 paid by private donations.

17           227.449. The portion of State Highway 163 from the  
18 interchange with Interstate 70 continuing south to Loop 70 in  
19 Boone County shall be designated as "Sherman Brown Jr. Memorial

1 Highway". The department of transportation shall erect and  
2 maintain appropriate signs designating such highway, with the  
3 costs to be paid by private donations.

4 227.532. The portion of Missouri 249 from State Highway VV  
5 continuing north to Missouri 171 in Jasper County shall be  
6 designated as the "Edward F. Dixon The Third Memorial Highway".  
7 The department of transportation shall erect and maintain  
8 appropriate signs designating such highway, with the costs of  
9 such designation to be paid for by private donation.

10 227.533. The bridge on State Highway 100 crossing over Big  
11 Boeuf Creek in Franklin County shall be designated the "Lyndon  
12 Ebker Memorial Bridge". The department of transportation shall  
13 erect and maintain appropriate signs designating such bridge,  
14 with the costs of such designation to be paid for by private  
15 donation.

16 227.535. The portion of State Highway 231 from the  
17 interchange with Interstate 255 north to River City Casino  
18 Boulevard in St. Louis City shall be designated the "Veterans -  
19 Heroes Highway". The department of transportation shall erect and  
20 maintain appropriate signs designating such highway, with costs  
21 to be paid for by private donations.

22 Section 1. The bridge on State Highway 99 crossing over  
23 Eleven Point River in Thomasville in Oregon County shall be  
24 designated as the "Roger "Dusty" Shaw Memorial Bridge". The  
25 department of transportation shall erect and maintain signs  
26 designating such bridge, with the cost of such designation to be  
27 paid for by private donations.
