AN ACT

To repeal sections 160.415, 161.670, 162.401, 162.492, 162.1115, 164.011, 167.121, 168.021, and 178.550, RSMo, and to enact in lieu thereof twelve new sections relating to elementary and secondary education, with an emergency clause for a certain section and a delayed effective date for certain sections.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 160.415, 161.670, 162.401, 162.492, 162.1115, 164.011, 167.121, 2 168.021, and 178.550, RSMo, are repealed and twelve new sections enacted in lieu thereof, to 3 be known as sections 160.415, 161.669, 161.670, 162.401, 162.492, 162.1115, 164.011, 167.121, 4 168.021, 170.018, 170.028, and 178.550, to read as follows:

160.415. 1. For the purposes of calculation and distribution of state school aid under 2 section 163.031, pupils enrolled in a charter school shall be included in the pupil enrollment of 3 the school district within which each pupil resides. Each charter school shall report the names, 4 addresses, and eligibility for free and reduced price lunch, special education, or limited English 5 proficiency status, as well as eligibility for categorical aid, of pupils resident in a school district 6 who are enrolled in the charter school to the school district in which those pupils reside. The 7 charter school shall report the average daily attendance data, free and reduced price lunch count, 8 special education pupil count, and limited English proficiency pupil count to the state department 9 of elementary and secondary education. Each charter school shall promptly notify the state 10 department of elementary and secondary education and the pupil's school district when a student 11 discontinues enrollment at a charter school.

12 2. Except as provided in subsections 3 and 4 of this section, the aid payments for charter 13 schools shall be as described in this subsection.

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

14 (1) A school district having one or more resident pupils attending a charter school shall
15 pay to the charter school an annual amount equal to the product of the charter school's weighted
16 average daily attendance and the state adequacy target, multiplied by the dollar value modifier
17 for the district, plus local tax revenues per weighted average daily attendance from the incidental
18 and teachers' funds in excess of the performance levy as defined in section 163.011 plus all other
19 state aid attributable to such pupils.

20 (2) The district of residence of a pupil attending a charter school shall also pay to the
21 charter school any other federal or state aid that the district receives on account of such child.

22 (3) If the department overpays or underpays the amount due to the charter school, such
23 overpayment or underpayment shall be repaid by the public charter school or credited to the
24 public charter school in twelve equal payments in the next fiscal year.

25 (4) The amounts provided pursuant to this subsection shall be prorated for partial year
26 enrollment for a pupil.

27 (5) A school district shall pay the amounts due pursuant to this subsection as the
28 disbursal agent and no later than twenty days following the receipt of any such funds. The
29 department of elementary and secondary education shall pay the amounts due when it acts as the
30 disbursal agent within five days of the required due date.

31 3. A workplace charter school shall receive payment for each eligible pupil as provided
32 under subsection 2 of this section, except that if the student is not a resident of the district and
33 is participating in a voluntary interdistrict transfer program, the payment for such pupils shall be
34 the same as provided under section 162.1060.

35 4. A charter school that has declared itself as a local educational agency shall receive
36 from the department of elementary and secondary education an annual amount equal to the
37 product of the charter school's weighted average daily attendance and the state adequacy target,
38 multiplied by the dollar value modifier for the district, plus local tax revenues per weighted
39 average daily attendance from the incidental and teachers funds in excess of the performance
40 levy as defined in section 163.011 **except those funds designated by taxpayers in an urban**
41 **district as early childhood education funds**, plus all other state aid attributable to such pupils.
42 If a charter school declares itself as a local educational agency, the department of elementary and
43 secondary education shall, upon notice of the declaration, reduce the payment made to the school
44 district by the amount specified in this subsection and pay directly to the charter school the
45 annual amount reduced from the school district's payment.

46 5. If a school district fails to make timely payments of any amount for which it is the
47 disbursal agent, the state department of elementary and secondary education shall authorize
48 payment to the charter school of the amount due pursuant to subsection 2 of this section and shall
49 deduct the same amount from the next state school aid apportionment to the owing school

50 district. If a charter school is paid more or less than the amounts due pursuant to this section,
51 the amount of overpayment or underpayment shall be adjusted equally in the next twelve
52 payments by the school district or the department of elementary and secondary education, as
53 appropriate. Any dispute between the school district and a charter school as to the amount owing
54 to the charter school shall be resolved by the department of elementary and secondary education,
55 and the department's decision shall be the final administrative action for the purposes of review
56 pursuant to chapter 536. During the period of dispute, the department of elementary and
57 secondary education shall make every administrative and statutory effort to allow the continued
58 education of children in their current public charter school setting.

59 6. The charter school and a local school board may agree by contract for services to be
60 provided by the school district to the charter school. The charter school may contract with any
61 other entity for services. Such services may include but are not limited to food service, custodial
62 service, maintenance, management assistance, curriculum assistance, media services and libraries
63 and shall be subject to negotiation between the charter school and the local school board or other
64 entity. Documented actual costs of such services shall be paid for by the charter school.

65 7. In the case of a proposed charter school that intends to contract with an education
66 service provider for substantial educational services or management services, the request for
67 proposals shall additionally require the charter school applicant to:

68 (1) Provide evidence of the education service provider's success in serving student
69 populations similar to the targeted population, including demonstrated academic achievement
70 as well as successful management of nonacademic school functions, if applicable;

71 (2) Provide a term sheet setting forth the proposed duration of the service contract; roles
72 and responsibilities of the governing board, the school staff, and the service provider; scope of
73 services and resources to be provided by the service provider; performance evaluation measures
74 and time lines; compensation structure, including clear identification of all fees to be paid to the
75 service provider; methods of contract oversight and enforcement; investment disclosure; and
76 conditions for renewal and termination of the contract;

77 (3) Disclose any known conflicts of interest between the school governing board and
78 proposed service provider or any affiliated business entities;

79 (4) Disclose and explain any termination or nonrenewal of contracts for equivalent
80 services for any other charter school in the United States within the past five years;

81 (5) Ensure that the legal counsel for the charter school shall report directly to the charter
82 school's governing board; and

83 (6) Provide a process to ensure that the expenditures that the education service provider
84 intends to bill to the charter school shall receive prior approval of the governing board or its
85 designee.

86 8. A charter school may enter into contracts with community partnerships and state
87 agencies acting in collaboration with such partnerships that provide services to children and their
88 families linked to the school.

89 9. A charter school shall be eligible for transportation state aid pursuant to section
90 163.161 and shall be free to contract with the local district, or any other entity, for the provision
91 of transportation to the students of the charter school.

92 10. (1) The proportionate share of state and federal resources generated by students with
93 disabilities or staff serving them shall be paid in full to charter schools enrolling those students
94 by their school district where such enrollment is through a contract for services described in this
95 section. The proportionate share of money generated under other federal or state categorical aid
96 programs shall be directed to charter schools serving such students eligible for that aid.

97 (2) A charter school shall provide the special services provided pursuant to section
98 162.705 and may provide the special services pursuant to a contract with a school district or any
99 provider of such services.

100 11. A charter school may not charge tuition or impose fees that a school district is
101 prohibited from charging or imposing, except that a charter school may receive tuition payments
102 from districts in the same or an adjoining county for nonresident students who transfer to an
103 approved charter school, as defined in section 167.131, from an unaccredited district.

104 12. A charter school is authorized to incur debt in anticipation of receipt of funds. A
105 charter school may also borrow to finance facilities and other capital items. A school district
106 may incur bonded indebtedness or take other measures to provide for physical facilities and other
107 capital items for charter schools that it sponsors or contracts with. Except as otherwise
108 specifically provided in sections 160.400 to 160.425, upon the dissolution of a charter school,
109 any liabilities of the corporation will be satisfied through the procedures of chapter 355. A
110 charter school shall satisfy all its financial obligations within twelve months of notice from the
111 sponsor of the charter school's closure under subsection 8 of section 160.405. After satisfaction
112 of all its financial obligations, a charter school shall return any remaining state and federal funds
113 to the department of elementary and secondary education for disposition as stated in subdivision
114 (17) of subsection 1 of section 160.405. The department of elementary and secondary education
115 may withhold funding at a level the department determines to be adequate during a school's last
116 year of operation until the department determines that school records, liabilities, and reporting
117 requirements, including a full audit, are satisfied.

118 13. Charter schools shall not have the power to acquire property by eminent domain.

119 14. The governing body of a charter school is authorized to accept grants, gifts or
120 donations of any kind and to expend or use such grants, gifts or donations. A grant, gift or
121 donation may not be accepted by the governing body if it is subject to any condition contrary to

122 law applicable to the charter school or other public schools, or contrary to the terms of the
123 charter.

161.669. As used in sections 161.670 and 167.121, the following terms shall mean:

2 **(1) "Course provider", an entity authorized by the department of elementary and**
3 **secondary education to offer individual courses in person, online, or a combination of the**
4 **two including but not limited to, online education providers, public or private elementary**
5 **and secondary education institutions, education service agencies, private for-profit or not-**
6 **for-profit providers, postsecondary education institutions, and vocational or technical**
7 **course providers;**

8 **(2) "Department", the department of elementary and secondary education;**

9 **(3) "Eligible funded student", any eligible participating student who is currently**
10 **enrolled in a public school, including a public charter school;**

11 **(4) "Eligible participating student", any K-12 student who resides in the state;**

12 **(5) "Local education agency", a public authority legally constituted by the state as**
13 **an administrative agency to provide control and direction for K-12 public educational**
14 **institutions, including public charter schools;**

15 **(6) "State course access catalog", the website developed for the department of**
16 **elementary and secondary education that provides a listing of all courses authorized and**
17 **available to students in the state, detailed information about the courses to inform student**
18 **enrollment decisions, and the ability for students to submit their course enrollments;**

19 **(7) "Virtual", including, but not limited to, instruction in an on-line setting using**
20 **technology, intranet, or internet methods of communication.**

161.670. 1. Notwithstanding any other law, prior to July 1, 2007, the state board of
2 education shall establish ~~[a virtual public school]~~ **the "Missouri Course Access and Virtual**
3 **School Program"** to serve school-age students residing in the state. The ~~[virtual public school]~~
4 **Missouri course access and virtual school program** shall offer instruction in a virtual setting
5 using technology, intranet, and/or internet methods of communication. Any student under the
6 age of twenty-one in grades kindergarten through twelve who resides in this state shall be eligible
7 to enroll in the ~~[virtual public school regardless of the student's physical location]~~ **Missouri**
8 **course access and virtual school program under subsection 3 of this section.**

9 2. For purposes of calculation and distribution of state school aid, students enrolled in
10 ~~[a virtual public school]~~ **the Missouri course access and virtual school program** shall be
11 included~~[, at the choice of the student's parent or guardian,]~~ in the student enrollment of the
12 school district in which the student physically ~~[resides]~~ **is enrolled under subsection 3 of this**
13 **section.** The ~~[virtual public school]~~ **Missouri course access and virtual school program** shall
14 report to the district of residence the following information about each student served by the

15 ~~[virtual public school]~~ **Missouri course access and virtual school program:** name, address,
16 eligibility for free or reduced-price lunch, limited English proficiency status, special education
17 needs, and the number of courses in which the student is enrolled. The ~~[virtual public school]~~
18 **Missouri course access and virtual school program** shall promptly notify the resident district
19 when a student discontinues enrollment. A "full-time equivalent student" is a student who
20 successfully has completed the instructional equivalent of six credits per regular term. Each
21 ~~[virtual]~~ **Missouri course access program** course shall count as one class and shall generate that
22 portion of a full-time equivalent that a comparable course offered by the school district would
23 generate. In no case shall more than the full-time equivalency of a regular term of attendance
24 for a single student be used to claim state aid. Full-time equivalent student credit completed
25 shall be reported to the department of elementary and secondary education in the manner
26 prescribed by the department. Nothing in this section shall prohibit students from enrolling in
27 additional courses under a separate agreement that includes terms for paying tuition or course
28 fees.

29 3. ~~[When a school district has one or more resident students enrolled in a virtual public~~
30 ~~school program authorized by this section, whose parent or guardian has chosen to include such~~
31 ~~student in the district's enrollment, the department of elementary and secondary education shall~~
32 ~~disburse an amount corresponding to fifteen percent of the state aid under sections 163.031 and~~
33 ~~163.043 attributable to such student to the resident district. Subject to an annual appropriation~~
34 ~~by the general assembly, the department shall disburse an amount corresponding to eighty-five~~
35 ~~percent of the state adequacy target attributable to such student to the virtual public school.~~

36 ~~—————4.]~~ **(1) A school district or charter school shall allow any eligible student who**
37 **resides in such district to enroll in Missouri course access program courses or virtual**
38 **school of his or her choice as a part of the student's annual course load each school year**
39 **or a full-time virtual school option, with any costs associated with such course or courses**
40 **to be paid by the school district or charter school if:**

41 **(a) The student is enrolled full-time in and has attended, for at least one semester**
42 **immediately prior to enrolling in the Missouri course access program, a public school,**
43 **including any public charter school; and**

44 **(b) Prior to enrolling in any Missouri course access course or virtual program, a**
45 **student has received approval from his or her school principal through the procedure**
46 **described under subdivision (2) of this subsection.**

47 **(2) School districts and charter schools, through the school principal and in**
48 **cooperation with the school's counselor or a person designated by the district or charter**
49 **school, shall approve or disapprove a student's request to enroll in a Missouri course access**
50 **program course or full-time virtual school. The school counselor or a person designated**

51 by the district or charter school shall advise any student who requests to enroll in a
52 Missouri course access program course or a full-time virtual school and submit a
53 recommendation to the school principal for final approval. The advice of the school
54 counselor or the person designated by the district or charter school shall be based on his
55 or her assessment of whether participation in the program and enrollment in a particular
56 course are in the student's best interest and shall be done in consultation with the student's
57 parent or legal guardian. Each school district and charter school shall develop a procedure
58 under which a student may appeal the decision made under the provisions of this
59 subdivision. In cases of denial of a request, the school district or charter school shall
60 inform students and parents of the reason for denial and inform them of their right to
61 appeal any enrollment denials in state course access program courses or full-time virtual
62 school to the department of elementary and secondary education, which shall provide a
63 final enrollment decision within seven calendar days. The state board of education shall
64 establish guidelines governing the appeals process.

65 (3) Children who have newly moved into the school district and children of active
66 military parents serving out of state shall be exempt from the requirement of attending a
67 public school for at least one semester prior to enrolling in the Missouri course access and
68 virtual school program.

69 (4) For students enrolled in any Missouri course access program course in which
70 costs associated with such course are to be paid by the school district or charter school as
71 described under subdivision (1) of this subsection, the school district or charter school shall
72 pay the content provider directly on a pro rata monthly basis based on a student's
73 completion of assignments and assessments. If a student discontinues enrollment, the
74 district or charter school may stop making monthly payments to the content provider. No
75 school district or charter school shall pay, for any one course for a student, more than the
76 market necessary costs but in no case shall pay more than fourteen percent of the state
77 adequacy target, as defined under section 163.011, as calculated at the end of the most
78 recent school year for any single, year-long course and no more than seven percent of the
79 state adequacy target as described above for any single semester equivalent course.
80 Payment for a full-time virtual school student shall not exceed the state adequacy target,
81 unless the student receives additional federal or state aid. Nothing in this subdivision shall
82 prohibit a school district or charter school from negotiating lower costs directly with
83 course or full-time virtual school providers, particularly in cases where several students
84 enroll in a single course or full-time virtual school.

85 **(5) In the case of a student who is a candidate for A+ tuition reimbursement and**
86 **taking a virtual course under this section, the school shall attribute no less than ninety-five**
87 **percent attendance to any such student who has completed such virtual course.**

88 **(6) The Missouri course access program shall ensure that individual learning plans**
89 **designed by certified teachers and professional staff are developed for all students enrolled**
90 **in more than two full-time course access program courses or a full-time virtual school.**

91 **(7) Providers shall monitor student success and engagement of students enrolled**
92 **in their program and report the information to the school district or charter school.**
93 **Providers may make recommendations to the school district or charter school regarding**
94 **the student's continued enrollment in the program. The school district or charter school**
95 **shall consider recommendations from providers and monitor the progress and success of**
96 **enrolled students that are enrolled in any course or full-time virtual school offered under**
97 **this section and may terminate or alter the course offering if it is found the course or full-**
98 **time virtual school is not meeting the educational needs of the students enrolled in the**
99 **course.**

100 **(8) The school district's decision to terminate a student's enrollment in a course or**
101 **full-time virtual school program shall be subject to the same appeals process outlined in**
102 **subdivision (2) of this subsection.**

103 **(9) Pursuant to rules to be adopted by the department of elementary and secondary**
104 **education, when a student transfers into a school district or charter school, credits**
105 **previously gained through successful passage of approved courses under the Missouri**
106 **course access program shall be accepted by the school district or charter school.**

107 **(10) Nothing in this section shall prohibit home school students, private school**
108 **students, or students wishing to take additional courses beyond their regular course load**
109 **from enrolling in Missouri course access program courses under an agreement that**
110 **includes terms for paying tuition or course fees.**

111 **(11) Nothing in this subsection shall require any school district, charter school, or**
112 **the state to provide computers, equipment, or internet access to any student unless**
113 **required by an eligible student with a disability to comply with federal law.**

114 **(12) The department authorization process shall provide for continuous monitoring**
115 **of approved providers and courses. The department shall revoke or suspend or take other**
116 **corrective action regarding the authorization of any course or provider no longer meeting**
117 **the requirements of the program. Unless immediate action is necessary, prior to revocation**
118 **or suspension, the department shall notify the provider and give the provider a reasonable**
119 **time period to take corrective action to avoid revocation or suspension. The process shall**

120 provide for periodic renewal of authorization no less frequently than once every three
121 years.

122 (13) Courses approved as of January 1, 2018, by the department to participate in
123 the Missouri virtual instruction program shall be automatically approved to participate
124 in the state course access and virtual school program, but shall be subject to periodic
125 renewal.

126 4. School districts and charter schools shall inform parents of their child's right to
127 participate in the program. Availability of the program shall be made clear in the parent
128 handbook, registration documents, and featured on the home page of the school district or
129 charter school's website.

130 5. The department shall:

131 (1) Establish an authorization process for course or full-time virtual school
132 providers that includes multiple opportunities for submission each year;

133 (2) Pursuant to the timeline established by the department, authorize course or full-
134 time virtual school providers that submit all necessary information pursuant to the
135 requirements of the process;

136 (3) Review, pursuant to the authorization process, proposals from providers to
137 provide individual courses or a comprehensive, full-time equivalent course of study for
138 students through the Missouri course access and virtual school program. The department
139 shall ensure that these comprehensive courses of study align with state academic standards
140 and that there is consistency and compatibility in the curriculum used by all providers
141 from one grade level to the next grade level;

142 (4) Within thirty days of any denial, provide a written explanation to any course
143 providers or full-time virtual school providers that are denied authorization.

144 6. If a course or full-time virtual school provider is denied authorization, the course
145 provider may reapply at any point in the future.

146 7. The department shall publish the process established under this section,
147 including any deadlines and any guidelines applicable to the submission and authorization
148 process for course or full-time virtual school providers on its website.

149 8. If the department determines that there are insufficient funds available for
150 evaluating and authorizing course or full-time virtual school providers, the department
151 may charge applicant course or full-time virtual school providers a fee up to, but no
152 greater than, the amount of the costs in order to ensure that evaluation occurs. The
153 department shall establish and publish a fee schedule for purposes of this subsection.

154 **9. School districts and charter schools shall monitor student progress and success,**
155 **and course or full-time virtual school quality, and annually provide feedback to the**
156 **department regarding course quality.**

157 **10. Program providers shall annually report, in such a manner as directed by the**
158 **department:**

159 **(1) Student enrollment data;**

160 **(2) Student outcomes, growth measures if available, proficiency rates, and**
161 **completion rates for each subject area and grade level; and**

162 **(3) Student and parental comments and feedback on overall satisfaction and**
163 **quality, including feedback on the availability of support from teachers.**

164 **11. The department shall submit an annual report to the joint committee on**
165 **education that includes:**

166 **(1) The annual number of unique students participating in courses authorized**
167 **under this section and the total number of courses students are enrolled in;**

168 **(2) The number of authorized providers;**

169 **(3) The number of authorized courses and the number of students enrolled in each**
170 **course;**

171 **(4) The number of courses available by subject and grade level;**

172 **(5) The number of students enrolled in courses by subject and grade level;**

173 **(6) Student outcome data, including completion rates, student learning gains, and**
174 **student performance on state or nationally accepted assessments, by subject and grade**
175 **level by provider. This outcome data shall be published in a manner that protects student**
176 **privacy; and**

177 **(7) School district feedback on student progress and success.**

178 **12. The department shall note any data that is not yet available at the time of**
179 **publication, and when it will become available, and include that data in future reports.**
180 **The report and underlying data shall be published online in an open format that can be**
181 **retrieved, downloaded, indexed, and searched by commonly used web search applications.**

182 **13. Except as specified in this section and as may be specified by rule of the state board**
183 **of education, the ~~[virtual public school]~~ Missouri course access and virtual school program**
184 **shall comply with all state laws and regulations applicable to school districts, including but not**
185 **limited to the Missouri school improvement program (MSIP), ~~[adequate yearly progress (AYP),]~~**
186 **annual performance report (APR), teacher certification, and curriculum standards.**

187 **[5-] 14. The state board of education through the rulemaking process and the department**
188 **of elementary and secondary education in its policies and procedures shall ensure that multiple**
189 **content providers are allowed, ensure digital content conforms to accessibility requirements,**

190 **provide an easily accessible link for providers to submit courses or full-time virtual schools**
191 **on the Missouri course access and virtual school program website, and allow any person,**
192 **organization, or entity to submit courses or full-time virtual schools for approval. No**
193 **content provider shall be allowed that is unwilling to accept payments in the amount and**
194 **manner as described under subdivision (4) of subsection 3 of this section or does not meet**
195 **performance or quality standards adopted by the state board of education.**

196 [6-] 15. Any rule or portion of a rule, as that term is defined in section 536.010, that is
197 created under the authority delegated in this section shall become effective only if it complies
198 with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028.
199 This section and chapter 536 are nonseverable and if any of the powers vested with the general
200 assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and
201 annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and
202 any rule proposed or adopted after August 28, 2006, shall be invalid and void.

162.401. The treasurer, before entering upon the discharge of his duties, shall enter into
2 a bond to the state of Missouri, with [~~two~~] **one** or more sureties, to be approved by the board,
3 conditioned that he will render a faithful and just account of all money that comes into his hands
4 as treasurer, and otherwise perform the duties of his office according to law. The bond shall be
5 filed with the secretary of the board. The treasurer shall be the custodian of all school moneys
6 derived from taxation for school purposes in the district until paid out on the order of the board,
7 and on breach of the conditions of the bond, the secretary of the board, or any resident of the
8 school district, may cause suit to be brought thereon. The suit shall be prosecuted in the name
9 of the state of Missouri, at the relation and to the use of the proper school district.

162.492. 1. In all urban districts containing the greater part of the population of a city
2 which has more than three hundred thousand inhabitants, the election authority of the city in
3 which the greater portion of the school district lies, and of the county if the district includes
4 territory not within the city limits, shall serve ex officio as a redistricting commission. The
5 commission shall on or before November 1, 2018, divide the school district into five subdistricts,
6 all subdistricts being of compact and contiguous territory and as nearly equal in the number of
7 inhabitants as practicable and thereafter the board shall redistrict the district into subdivisions
8 as soon as practicable after each United States decennial census. In establishing the subdistricts
9 each member shall have one vote and a majority vote of the total membership of the commission
10 is required to make effective any action of the commission.

11 2. School elections for the election of directors shall be held on municipal election days
12 in 2014 and 2016. At the election in 2014, directors shall be elected to hold office until 2019 and
13 until their successors are elected and qualified. At the election in 2016, directors shall be elected
14 until 2019 and until their successors are elected and qualified. Beginning in 2019, school

15 elections for the election of directors shall be held on the local election date as specified in the
16 charter of a home rule city with more than four hundred thousand inhabitants and located in more
17 than one county. Beginning at the election for school directors in 2019, the number of directors

67 council's internet website at least five business days in advance of the meeting.

68 9. The advisory council shall make an annual written report to the state board of
69 education and the commissioner of education regarding the development, implementation, and
70 administration of the state budget for career and technical education.

71 10. The advisory council shall annually submit written recommendations to the state
72 board of education and the commissioner of education regarding the oversight and procedures
73 for the handling of funds for student career and technical education organizations.

74 11. The advisory council shall:

75 (1) Develop a comprehensive statewide short- and long-range strategic plan for career
76 and technical education;

77 (2) Identify service gaps and provide advice on methods to close such gaps as they relate
78 to youth and adult employees, workforce development, and employers on training needs;

79 (3) Confer with public and private entities for the purpose of promoting and improving
80 career and technical education;

81 (4) Identify legislative recommendations to improve career and technical education;

82 (5) Promote coordination of existing career and technical education programs;

83 (6) Adopt, alter, or repeal by its own bylaws, rules and regulations governing the manner
84 in which its business may be transacted.

85 12. For purposes of this section, the department of elementary and secondary education
86 shall provide such documentation and information as to allow the advisory council to be
87 effective.

88 13. For purposes of this section, "advisory council" shall mean the career and technical
89 education advisory council.

Section B. Because of the importance of funding early childhood education programs,
2 section 160.415 of this act is deemed necessary for the immediate preservation of the public
3 health, welfare, peace, and safety, and is hereby declared to be an emergency act within the
4 meaning of the constitution, and section 160.415 of this act shall be in full force and effect on
5 July 1, 2017, or upon its passage and approval, whichever occurs later.

Section C. Sections 161.669, 161.670, and 167.121 of this act shall become effective
2 July 1, 2018.
