AN ACT

To repeal sections 150.470, 150.480, 150.490, 150.500, 150.510, 150.520, 150.530, and 150.540, RSMo, relating to peddlers' licenses and taxes.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 150.470, 150.480, 150.490, 150.500, 150.510, 150.520,
2 150.530, and 150.540, RSMo, are repealed, to read as follows:

[150.470. Whoever shall deal in the selling of patents,
2 patent rights, patent or other medicines, lightning rods, goods,
3 wares or merchandise, except pianos, organs, sewing machines,
4 books, charts, maps and stationery, agricultural and horticultural
5 products, including milk, butter, eggs and cheese, by going about
6 from place to place to sell the same, is declared to be a "peddler".]

[150.480. No person shall deal as a peddler without a
2 license; and no two or more persons shall deal under the same
3 license, either as partners, agents or otherwise; and no peddler
4 shall sell wines or spirituous liquors.]

[150.490. Any person may obtain a peddler's license by
2 application to the collector of the county in which he intends to
3 carry on his trade, by paying the amount levied on such license.]

[150.500. 1. There shall be levied and paid on all peddlers'
2 licenses a state tax of the following rates:

3 (1) If the peddler travel and carry his goods on foot, three
4 dollars for every period of six months;

5 (2) If one or more horses or other beasts of burden, ten
6 dollars for every period of six months;

EXPLANATION—Matter enclosed in bold-faced brackets [thus] in this bill is not enacted and is intended to be omitted in the law.

7 (3) If a cart or other land carriage, twenty dollars for every
8 period of six months, and such license may be renewed at the
9 expiration of the first license for a period not greater than six
10 months on the payment of three dollars per month, the number of
11 months to be specified in such license;

12 (4) If any boat or other river vessel, at the rate of one dollar
13 per day for any period not less than five days, and such license
14 may be renewed at the expiration of the first license for any period
15 not greater than six months on payment of fifty cents a day, the
16 number of days to be specified in such license.

17 2. Any county commission may by an order of record require
18 all peddlers doing business in their county to pay a license tax not
19 greater than that levied for state purpose.]

2 [150.510. Every license shall state the manner in which the
3 dealing is to be carried on, whether on foot, or with one or more
4 beasts of burden, the kind of cart or carriage, or if on the water,
5 the kind of boat or vessel to be employed.]

2 [150.520. The clerk of the county commission shall, from
3 time to time, issue, under the seal of the commission, as many
4 blank peddlers' licenses of the several kinds as may be necessary,
5 deliver the same to the collector of the county, and charge such
6 collector therewith.]

2 [150.530. At each regular term, the county commission
3 shall settle with the collector on account of such licenses, charge
4 him with all the licenses not returned, and give him credit for such
5 as are returned. The commission shall certify the amount thus
6 charged against the collector to the state director of revenue.]

2 [150.540. Every person who shall be found dealing as a
3 peddler contrary to the provisions of sections 150.470 to 150.540
4 and as provided for in his license, or who shall, upon the demand
5 of any sheriff, collector, constable, or any citizen householder of the
6 county, refuse to produce such license and permit the same to be
7 read, shall be deemed guilty of a misdemeanor, and, upon
8 conviction thereof, shall be fined not less than ten nor more than
9 one hundred dollars.]
