AN ACT

To repeal section 209.202, RSMo, and to enact in lieu thereof one new section relating to service dogs, with a penalty provision.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 209.202, RSMo, is repealed and one new section 2 enacted in lieu thereof, to be known as section 209.202, to read as follows:

209.202. 1. Any person who knowingly, intentionally, or recklessly causes

- 2 substantial physical injury to or the death of a service dog is guilty of a class A
- 3 misdemeanor. The provisions of this subsection shall not apply to the destruction
- 4 of a service dog for humane purposes.
- 5 2. Any person who knowingly or intentionally fails to exercise sufficient
- 6 control over an animal such person owns, keeps, harbors, or exercises control over
- 7 to prevent the animal from causing the substantial physical injury to or death of
- 8 a service dog, or the subsequent inability to function as a service dog as a result
- 9 of the animal's attacking, chasing, or harassing the service dog is guilty of a class
- 10 A misdemeanor.
- 3. Any person who harasses or chases a dog known to such person to be
- 12 a service dog is guilty of a class B misdemeanor.
- 13 4. Any person who owns, keeps, harbors, or exercises control over an
- 14 animal and who knowingly or intentionally fails to exercise sufficient control over
- 15 the animal to prevent such animal from chasing or harassing a service dog while
- 16 such dog is carrying out the dog's function as a service dog, to the extent that the
- 17 animal temporarily interferes with the service dog's ability to carry out the dog's
- 18 function is guilty of a class B misdemeanor and shall be ordered to pay
- 19 restitution in an amount that fully compensates the owner for the
- 20 injury, loss, or replacement of his or her service dog.

21 5. An owner of a service dog or a person with a disability who uses a

- 22 service dog may file a cause of action to recover civil damages against any person
- 23 who:
- 24 (1) Violates the provisions of subsection 1 or 2 of this section; or
- 25 (2) Steals a service dog resulting in the loss of the services of the service 26 dog.
- 6. Any civil damages awarded under subsection 5 of this section shall be based on the following:
- 29 (1) The replacement value of an equally trained service dog, without any 30 differentiation for the age or experience of the service dog;
- 31 (2) The cost and expenses incurred by the owner of a service dog or the 32 person with a disability who used the service dog, including:
- 33 (a) The cost of temporary replacement services, whether provided by 34 another service dog or by a person;
- 35 (b) The reasonable costs incurred in efforts to recover a stolen service dog; 36 and
- 37 (c) Court costs and attorney's fees incurred in bringing a civil action under 38 subsection 5 of this section.
- 7. An owner of a service dog or a person with a disability who uses a service dog may file a cause of action to recover civil damages against a person who:
- 42 (1) Violates the provisions of subsections 1 to 4 of this section resulting 43 in injury from which the service dog recovers to an extent that the dog is able to 44 function as a service dog for the person with a disability; or
- 45 (2) Steals a service dog and the service dog is recovered resulting in the 46 service dog being able to function as a service dog for the person with a disability.
- 8. Any civil damages awarded under subsection 7 of this section shall be based on the following:
- 49 (1) Veterinary medical expenses;
- 50 (2) Retraining expenses;

- 51 (3) The cost of temporary replacement services, whether provided by 52 another service dog or by a person;
 - (4) Reasonable costs incurred in the recovery of the service dog; and
- 54 (5) Court costs and attorney's fees incurred in bringing the civil action 55 under subsection 7 of this section.
- 56 9. The provisions of this section shall not apply if a person with a

57 disability, an owner, or a person having custody or supervision of a service dog

- 58 commits criminal or civil trespass.
- 59 10. Nothing in this section shall be construed to preclude any other

60 remedies available at law.
