### AN ACT

To repeal section 143.1016, RSMo, and to enact in lieu thereof one new section relating to the organ donor program fund.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Section 143.1016, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 143.1016, to read as follows:

143.1016. 1. For all tax years beginning on or after January 1, 2011, each

2 individual or corporation entitled to a tax refund in an amount sufficient to make

3 a designation under this section may designate that two dollars or any amount

4 in excess of two dollars on a single return, and four dollars or any amount in

5 excess of four dollars on a combined return, of the refund due be credited to the

6 organ donor program fund established in section 194.297. The contribution

7 designation authorized by this section shall be clearly and unambiguously printed

8 on each income tax return form provided by this state. If any individual that is

9 not entitled to a tax refund in an amount sufficient to make a designation under

10 this section wishes to make a contribution to the organ donor program fund, such

11 individual may, by separate check, draft, or other negotiable instrument, send in

12 with the payment of taxes, or may send in separately, clearly designated for the

13 organ donor program fund, the amount the individual wishes to contribute. The

14 department of revenue shall deposit such amount to the organ donor program

15 fund as provided in subsection 2 of this section.

2. The director of revenue shall transfer at least monthly all contributions

  - [4. Under section 23.253 of the Missouri sunset act:
- 27 (1) The provisions of the new program authorized under this section shall 28 automatically sunset on December thirty-first six years after August 28, 2011, 29 unless reauthorized by an act of the general assembly; and
  - (2) If such program is reauthorized, the program authorized under this section shall automatically sunset on December thirty-first twelve years after the effective date of the reauthorization of this section; and
- 33 (3) This section shall terminate on September first of the calendar year 34 immediately following the calendar year in which the program authorized under 35 this section is sunset.]
