If the attorney general commences and prosecutes an action pursuant to this section, the attorney general shall exercise all authority, duties, rights, and responsibilities in the matter exclusive of any circuit attorney. No circuit attorney shall have the authority to commence, prosecute, dismiss, or otherwise effect any criminal action if the attorney general commences and prosecutes an action under this section and the circuit attorney shall, within fifteen days of the attorney general commencing prosecution under this section, transmit to the attorney general all materials collected or prepared by the circuit attorney related to the alleged criminal violation or violations.
- 5. In all such proceedings authorized under this section, the attorney general may appear in person or by appointing his or her assistant attorneys general before any court of record or grand jury and exercise all the powers and perform all the duties in respect to such actions or proceedings which a circuit attorney would otherwise be authorized or required to exercise or perform.
- 6. Upon any conviction by the attorney general pursuant to this section, he or she shall have exclusive authority to represent the state in all post-conviction relief proceedings under sections 547.360 and 547.370. The attorney general shall exercise all the powers and perform all the duties in respect to such actions and proceedings which a circuit attorney would otherwise be authorized or required to exercise or perform under
