Highlights

Food Stamps that were up for recertification in March, April, and May will be automatically extended for 6 months.

FSD has waived all **work requirements** for able-bodied adults without dependents through the end of the federal emergency COVID-19 declaration.

Pandemic-**SNAP** (P-SNAP) will be issued so that any family eligible for SNAP will receive the maximum amount allowed for their household for March/April.

DSS will offer Pandemic EBT (P-EBT) for households with children who receive **free/reduced lunches** at school. You do not have to be a current SNAP recipient to receive this benefit.

Childcare subsidy agreements/benefits have been extended by 90 days.

Mo HealthNet recipients will not lose coverage during the COVID-19 pandemic. Mo HealthNet coverage will be extended to all Missourians 19-64 who test positive and meet income/resource eligibility guidelines.

The **REAL-ID compliance** deadline has been pushed back to October 1, 2021.
