Protecting Utility Payers


I believe that large, investor-owned utility companies want to control the ratemaking process by rendering the Missouri Public Service Commission (PSC) powerless. For over 100 years, the PSC has provided checks and balances on monopoly utility companies to prevent them from unfairly raising rates without due process and without evidence of the need.

Out of a sense of responsibility to Missouri families and businesses, I spent a lot of time defending ratepayers, like yourself, by standing up to these companies and opposing legislation which, in my opinion, would have diminished the PSC's oversight.

Strengthening Families by Nurturing Children

One of the proudest accomplishments of my Senate career was passing Senate Bill 530. Now law, this legislation encouraged alcohol and drug addicted parents to get the help they needed in a timely fashion so they could provide a safe, nurturing home for their children and restore the family unit.

The bill helped to reduce the agonizing wait time that kids and prospective foster or adoptive parents had to spend in the foster care system. The intent of my legislation was to make it faster and easier to either reunite children with their recovered parents or move the children out of foster care and into loving, adoptive homes.



The lack of adequate and steady funding for our roads and bridges affects the safety of our families and friends, as well as the economic well-being of our state. Throughout my time in the Missouri Senate, my stance was to support legislation that ensured the long-term sustainability of our state's transportation infrastructure. Due to more fuel-efficient vehicles, we are basically receiving the same amount of funds, or less, for our roads as we did a decade ago.

To find work, some of Missouri's very best highway construction companies, along with their highly skilled workers, are traveling to neighboring states which are investing heavily in roads to build their state's highways and bridges.

What company would want to relocate or expand in Missouri without a reasonable assurance or expectation that our roads and bridges will be maintained and improved to meet their requirements, both now and in the future?



Innovating Education

In 2018, my top priority was sponsoring legislation to incentivize high school students to take computer science courses. Senate Bill 894 added coding and programming to computer science standards, along with guidelines for implementation in K-12 curriculum. This legislation allows computer science courses to count as credits toward the requirements needed to graduate.

Computer science drives innovation throughout our economy, and legislation like this helps to provide the necessary and skilled workforce for this growing, in-demand industry. The expansion of rural, high-speed internet is a must in order to create these jobs in our district in the 21st century.



Show-Me Raider Pride!

In January, I presented a Senate Resolution to Christy Frazier-Moore who was honored with the first Three Rivers College Alumni Star Award.

Two of our beloved coaches reached milestones this year as well. Gene Bess has been a men's basketball coach for 50 years and has achieved 1,300 college wins!

Highlights from the 2020 Legislative Session

The 2020 legislative session didn't look like any other session due to the COVID-19 pandemic. Very few people entered the Capitol during the final days of the 2020 legislative session, and those who did enter were screened for potential exposure or symptoms. The Legislature reconvened to pass the state budget for the 2021 fiscal year, the only task we are constitutionally required to do every year. It was absolutely necessary for the Legislature to come together and pass the state's FY 2021 operating budget to ensure our government remains funded, open and able to serve the citizens of Missouri.

Public Safety

During this legislative session, I was proud to sponsor legislation that I believe will increase public safety and prevent crime. My Senate Bill 538 increases the penalty from a Class D felony to a Class C felony for the unlawful possession of a firearm by a person previously convicted of a dangerous felony. The goal of this legislation is to reduce crimes and deter criminals from using deadly weapons. These provisions have been approved by the Legislature and are awaiting the governor's consideration.

Digital Licensing

Provisions from my Senate Bill 906 have also been sent to the governor's desk. This legislation permits the Department of Revenue to design and implement a secure digital driver's license program so applicants may obtain a digital driver's license in addition to a physical card. In an effort to improve customer service and streamline processes, this bill also gives the Department of Revenue the ability to create an online driver's license renewal system.
