AN ACT

To amend chapter 301, RSMo, by adding thereto one new section relating to a Negro Leagues Baseball Museum special license plate.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 301, RSMo, is amended by adding thereto
2 one new section, to be known as section 301.3179, to read as
3 follows:

**301.3179. 1. Any vehicle owner may apply for "Negro
2 Leagues Baseball Museum" license plates for any motor
3 vehicle the person owns, either solely or jointly, other
4 than an apportioned motor vehicle or a commercial motor
5 vehicle licensed in excess of twenty-four thousand pounds
6 gross weight. Upon making a ten dollar contribution to the
7 Negro Leagues Baseball Museum, the vehicle owner may apply
8 for the "Negro Leagues Baseball Museum" plate. If the
9 contribution is made directly to the Negro Leagues Baseball
10 Museum, the organization shall issue the individual making
11 the contribution a receipt, verifying the contribution, that
12 may be used to apply for the "Negro Leagues Baseball Museum"
13 license plate. The applicant for such plate shall pay a
14 fifteen dollar fee in addition to the regular registration
15 fees and present any other documentation required by law for
16 each set of "Negro Leagues Baseball Museum" plates issued
17 pursuant to this section. Notwithstanding the provisions of
18 section 301.144, no additional fee shall be charged for the**

19 personalization of license plates issued pursuant to this
20 section. The "Negro Leagues Baseball Museum" plate shall
21 bear the emblem of the Negro Leagues Baseball Museum as
22 prescribed by the director of revenue and shall have the
23 words "NEGRO LEAGUES BASEBALL MUSEUM". Such license plates
24 shall be made with fully reflective material with a common
25 color scheme and design, shall be clearly visible at night,
26 and shall be aesthetically attractive, as prescribed by
27 section 301.130.

28 2. The director of revenue may promulgate rules and
29 regulations for the administration of this section. Any
30 rule or portion of a rule, as that term is defined in
31 section 536.010, that is created under the authority
32 delegated in this section shall become effective only if it
33 complies with and is subject to all of the provisions of
34 chapter 536 and, if applicable, section 536.028. This
35 section and chapter 536 are nonseverable, and if any of the
36 powers vested with the general assembly pursuant to chapter
37 536 to review, to delay the effective date, or to disapprove
38 and annul a rule are subsequently held unconstitutional,
39 then the grant of rulemaking authority and any rule proposed
40 or adopted after August 28, 2021, shall be invalid and void.
