AN ACT

To amend chapter 33, RSMo, by adding thereto one new section relating to the establishment of a fund for emergency expenditures.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Chapter 33, RSMo, is amended by adding thereto

- 2 one new section, to be known as section 33.575, to read as
- 3 follows:
 - 33.575. 1. There is hereby created in the state
- 2 treasury the "Cash Operating Expense Fund", which shall
- 3 consist of money collected under this section. The state
- 4 treasurer shall be custodian of the fund. In accordance
- 5 with sections 30.170 and 30.180, the state treasurer may
- 6 approve disbursements. Notwithstanding the provisions of
- 7 section 33.080 to the contrary, any moneys remaining in the
- 8 fund at the end of the biennium shall not revert to the
- 9 credit of the general revenue fund. The state treasurer
- 10 shall invest moneys in the fund in the same manner as other
- 11 funds are invested. Any interest and moneys earned on such
- 12 investments shall be credited to the fund.
- 2. The following moneys shall be transferred into the
- 14 fund:
- 15 (1) Any funds appropriated to the office of the
- 16 governor for expenses incident to emergency duties performed
- 17 by the national guard when ordered out by the governor, for
- 18 matching funds for federal grants and for emergency

- 19 assistance as provided in section 44.032, and for expenses
- 20 of any state agency responding during a declared emergency
- 21 at the direction of the governor, provided the services
- 22 furnish immediate aid and relief, that were unexpended at
- 23 the end of the fiscal year; and
- 24 (2) Any funds appropriated to the fund by the general 25 assembly or otherwise credited to the fund.
- 3. In any fiscal year in which actual revenues are
- 27 less than the revenue estimates upon which appropriations
- 28 were based or in which there is a budget need due to a
- 29 natural disaster, as proclaimed by the governor to be an
- 30 emergency, the governor may transfer from the fund to the
- 31 general revenue fund such moneys as are necessary to make up
- 32 all or part of the deficit between the actual revenues and
- 33 the revenue estimates or to meet the needs of the emergency
- 34 caused by the natural disaster, as the case may be.
- 35 4. If the balance in the fund at the close of any
- 36 fiscal year exceeds two and one-half percent of net general
- 37 revenue collections for the previous fiscal year, the excess
- 38 amount shall be allocated as follows:
- 39 (1) Fifty percent of such excess shall be transferred
- 40 to the state road fund established pursuant to Article IV,
- 41 Section 30(b) of the Missouri Constitution, for the purposes
- 42 of funding the governor's transportation cost-share program;
- 43 and
- 44 (2) Fifty percent of such excess shall be expended for
- 45 debt retirement related to bonds issued by or on behalf of
- 46 the state, and for which the office of administration is
- 47 required to file annual continuing disclosure reports on the
- 48 electronic municipal market access website, or its successor.
- 5. For the purposes of this section, "net general
- 50 revenue collections" means all revenue deposited into the

- 51 general revenue fund less refunds and revenues originally
- 52 deposited into the general revenue fund but designated by
- 13 law for a specific distribution or transfer to another state
