AN ACT

To repeal sections 115.277, 115.279, 115.283, and 115.291, RSMo, and to enact in lieu thereof five new sections relating to voting in elections.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 115.277, 115.279, 115.283, and 115.291, RSMo, are repealed and five new sections enacted in lieu thereof, to be known as sections 115.274, 115.277, 115.279, 115.283, and 115.291, to read as follows:

115.274. 1. Any registered voter of this state may vote in advance of election day, without having to state an excuse, in person or by mail for any general election as follows:

(1) Early voting shall be conducted from the sixth Tuesday before the election until 7:00 p.m. on the Monday immediately before the election. The hours for conducting early voting shall be the regular business hours of each local election authority, provided that for the twenty-one days immediately before election day, the hours shall also include from 11:00 a.m. to 5:00 p.m. on Saturday and Sunday and beginning on the Tuesday immediately before election day through the Monday immediately before the election, the hours shall be from 8:00 a.m. to 7:00 p.m.;

(2) The local election authority shall establish early voting locations as follows:

EXPLANATION-Matter enclosed in bold-faced brackets [thus] in this bill is not enacted and is intended to be omitted in the law.

17 (a) There shall be one early voting location for every
18 three precincts within the jurisdiction of the local
19 election authority, provided that there shall be at least
20 one early voting location within the jurisdiction of each
21 local election authority;

22 (b) Early voting locations shall be as centrally
23 located as is practicable; and

24 (c) In choosing early voting locations, the local
25 election authority shall consider the following factors:

26 a. The geographic location and demographics of voters
27 in the previous federal general election;

28 b. Current United States census data;

29 c. The availability of suitable satellite early voting
30 locations within the local election authority; and

31 d. Any other factor deemed relevant by the local
32 election authority.

33 2. The local election authority shall provide adequate
34 public notice of the early voting locations by posting the
35 hours and locations for early voting at the local election
36 authority's office, on the local election authority's
37 website, and by other reasonable methods selected by the
38 local election authority.

39 3. The local election authority shall appoint at least
40 one election judge from each major political party to serve
41 at each early voting location. Procedures for selecting
42 election judges, designating election challengers, casting
43 ballots, and tabulating ballots shall be the same as
44 otherwise provided in this chapter.

45 4. Upon request by any person or entity, the election
46 authority or the secretary of state shall furnish media in
47 an electronic format or, if so requested, in a printed
48 format, showing the names, addresses, and voter

49 **identification numbers of voters within the jurisdiction of**
50 **a specific election authority who voted pursuant to this**
51 **section.**

115.277. 1. Except as provided in subsections 2, 3,
2 4, and 5 of this section, any registered voter of this state
3 may vote by absentee ballot for all candidates and issues
4 for which such voter [would be] **is** eligible to vote at the
5 polling place [if such voter expects to be prevented from
6 going to the polls to vote on election day due to:

7 (1) Absence on election day from the jurisdiction of
8 the election authority in which such voter is registered to
9 vote;

10 (2) Incapacity or confinement due to illness or
11 physical disability, including a person who is primarily
12 responsible for the physical care of a person who is
13 incapacitated or confined due to illness or disability;

14 (3) Religious belief or practice;

15 (4) Employment as an election authority, as a member
16 of an election authority, or by an election authority at a
17 location other than such voter's polling place;

18 (5) Incarceration, provided all qualifications for
19 voting are retained;

20 (6) Certified participation in the address
21 confidentiality program established under sections 589.660
22 to 589.681 because of safety concerns; or

23 (7) For an election that occurs during the year 2020,
24 the voter has contracted or is in an at-risk category for
25 contracting or transmitting severe acute respiratory
26 syndrome coronavirus 2. This subdivision shall expire on
27 December 31, 2020].

28 2. Any covered voter who is eligible to register and
29 vote in this state may vote in any election for federal

30 office, statewide office, state legislative office, or
31 statewide ballot initiatives by submitting a federal
32 postcard application to apply to vote by absentee ballot or
33 by submitting a federal postcard application at the polling
34 place even though the person is not registered. A federal
35 postcard application submitted by a covered voter pursuant
36 to this subsection shall also serve as a voter registration
37 application under section 115.908 and the election authority
38 shall, if satisfied that the applicant is entitled to
39 register, place the voter's name on the voter registration
40 file. Each covered voter may vote by absentee ballot or,
41 upon submitting an affidavit that the person is qualified to
42 vote in the election, may vote at the person's polling place.

43 3. Any interstate former resident may vote by absentee
44 ballot for presidential and vice presidential electors.

45 4. Any intrastate new resident may vote by absentee
46 ballot at the election for presidential and vice
47 presidential electors, United States senator, representative
48 in Congress, statewide elected officials and statewide
49 questions, propositions and amendments from such resident's
50 new jurisdiction of residence after registering to vote in
51 such resident's new jurisdiction of residence.

52 5. Any new resident may vote by absentee ballot for
53 presidential and vice presidential electors after
54 registering to vote in such resident's new jurisdiction of
55 residence.

56 [6. For purposes of this section, the voters who are
57 in an at-risk category for contracting or transmitting
58 severe acute respiratory syndrome coronavirus 2 are voters
59 who:

60 (1) Are sixty-five years of age or older;

61 (2) Live in a long-term care facility licensed under
62 chapter 198;

63 (3) Have chronic lung disease or moderate to severe
64 asthma;

65 (4) Have serious heart conditions;

66 (5) Are immunocompromised;

67 (6) Have diabetes;

68 (7) Have chronic kidney disease and are undergoing
69 dialysis; or

70 (8) Have liver disease.]

115.279. 1. Application for an absentee ballot may be
2 made by the applicant in person, or by mail, or for the
3 applicant, in person, by his or her guardian or a relative
4 within the second degree by consanguinity or affinity. The
5 election authority shall accept applications by facsimile
6 transmission and by electronic mail within the limits of its
7 telecommunications capacity.

8 2. Each application shall be made to the election
9 authority of the jurisdiction in which the person is or
10 would be registered. Each application shall be in writing
11 and shall state the applicant's name, address at which he or
12 she is or would be registered, [his or her reason for voting
13 an absentee ballot] **whether the applicant is incapacitated**
14 **or confined due to illness or physical disability or is a**
15 **person who is primarily responsible for the physical care of**
16 **a person who is incapacitated or confined due to illness or**
17 **physical disability**, the address to which the ballot is to
18 be mailed, if mailing is requested, and for absent uniformed
19 services and overseas applicants, the applicant's email
20 address if electronic transmission is requested. If the
21 [reason for the applicant voting absentee is due to the
22 reasons established under subdivision (6) of subsection 1 of

23 section 115.277] **applicant is a certified participant in the**
24 **address confidentiality program established under sections**
25 **589.660 to 589.681,** the applicant shall state the voter's
26 identification information provided by the address
27 confidentiality program in lieu of the applicant's name,
28 address at which he or she is or would be registered, and
29 address to which the ballot is to be mailed, if mailing is
30 requested. Each application to vote in a primary election
31 shall also state which ballot the applicant wishes to
32 receive. If any application fails to designate a ballot,
33 the election authority shall, within three working days
34 after receiving the application, notify the applicant by
35 mail that it will be unable to deliver an absentee ballot
36 until the applicant designates which political party ballot
37 he or she wishes to receive. If the applicant does not
38 respond to the request for political party designation, the
39 election authority is authorized to provide the voter with
40 that part of the ballot for which no political party
41 designation is required.

42 3. [Except as provided in subsection 3 of section
43 115.281,] All applications for absentee ballots received
44 prior to the sixth Tuesday before an election shall be
45 stored at the office of the election authority until such
46 time as the applications are processed in accordance with
47 section 115.281. No application for an absentee ballot
48 received in the office of the election authority by mail, by
49 facsimile transmission, by electronic mail, or by a guardian
50 or relative after 5:00 p.m. on the second Wednesday
51 immediately prior to the election shall be accepted by any
52 election authority. No application for an absentee ballot
53 submitted by the applicant in person after 5:00 p.m. on the
54 day before the election shall be accepted by any election

55 authority, except as provided in subsections 6, 8 and 9 of
56 this section.

57 4. Each application for an absentee ballot shall be
58 signed by the applicant or, if the application is made by a
59 guardian or relative pursuant to this section, the
60 application shall be signed by the guardian or relative, who
61 shall note on the application his or her relationship to the
62 applicant. If an applicant, guardian or relative is blind,
63 unable to read or write the English language or physically
64 incapable of signing the application, he or she shall sign
65 by mark, witnessed by the signature of an election official
66 or person of his or her own choosing. Any person who
67 knowingly makes, delivers or mails a fraudulent absentee
68 ballot application shall be guilty of a class one election
69 offense.

70 5. (1) Notwithstanding any law to the contrary, any
71 resident of the state of Missouri who resides outside the
72 boundaries of the United States or who is on active duty
73 with the Armed Forces of the United States or members of
74 their immediate family living with them may request an
75 absentee ballot for both the primary and subsequent general
76 election with one application.

77 (2) The election authority shall provide each absent
78 uniformed services voter and each overseas voter who submits
79 a voter registration application or an absentee ballot
80 request, if the election authority rejects the application
81 or request, with the reasons for the rejection.

82 (3) Notwithstanding any other law to the contrary, if
83 a standard oath regarding material misstatements of fact is
84 adopted for uniformed and overseas voters pursuant to the
85 Help America Vote Act of 2002, the election authority shall

86 accept such oath for voter registration, absentee ballot, or
87 other election-related materials.

88 (4) Not later than sixty days after the date of each
89 regularly scheduled general election for federal office,
90 each election authority which administered the election
91 shall submit to the secretary of state in a format
92 prescribed by the secretary a report on the combined number
93 of absentee ballots transmitted to, and returned by, absent
94 uniformed services voters and overseas voters for the
95 election. The secretary shall submit to the Election
96 Assistance Commission a combined report of such information
97 not later than ninety days after the date of each regularly
98 scheduled general election for federal office and in a
99 standardized format developed by the commission pursuant to
100 the Help America Vote Act of 2002. The secretary shall make
101 the report available to the general public.

102 (5) As used in this section, the terms "absent
103 uniformed services voter" and "overseas voter" shall have
104 the meaning prescribed in 52 U.S.C. Section 20310.

105 6. An application for an absentee ballot by a new
106 resident shall be submitted in person by the applicant in
107 the office of the election authority in the election
108 jurisdiction in which such applicant resides. The
109 application shall be received by the election authority no
110 later than 7:00 p.m. on the day of the election. Such
111 application shall be in the form of an affidavit, executed
112 in duplicate in the presence of the election authority or
113 any authorized officer of the election authority, and in
114 substantially the following form:

142 7. The election authority in whose office an
 143 application is filed pursuant to subsection 6 of this
 144 section shall immediately send a duplicate of such
 145 application to the appropriate official of the state in
 146 which the new resident applicant last resided and shall file
 147 the original of such application in its office.

148 8. An application for an absentee ballot by an
 149 intrastate new resident shall be made in person by the
 150 applicant in the office of the election authority in the
 151 election jurisdiction in which such applicant resides. The
 152 application shall be received by the election authority no
 153 later than 7:00 p.m. on the day of the election. Such
 154 application shall be in the form of an affidavit, executed
 155 in duplicate in the presence of the election authority or an
 156 authorized officer of the election authority, and in
 157 substantially the following form:

184 9. An application for an absentee ballot by an
185 interstate former resident shall be received in the office
186 of the election authority where the applicant was formerly
187 registered by 5:00 p.m. on the second Wednesday immediately
188 prior to the election, unless the application is made in
189 person by the applicant in the office of the election
190 authority, in which case such application shall be made no
191 later than 7:00 p.m. on the day of the election.

115.283. 1. Each ballot envelope shall bear a
2 statement on which the voter shall state the voter's name,
3 the voter's voting address, **and** the voter's mailing address
4 [and the voter's reason for voting an absentee ballot]. If
5 the [reason for the voter voting absentee is due to the
6 reasons established under subdivision (6) of subsection 1 of
7 section 115.277] **applicant is a certified participant in the**
8 **address confidentiality program established under sections**
9 **589.660 to 589.681**, the voter shall state the voter's
10 identification information provided by the address
11 confidentiality program in lieu of the applicant's name,
12 voting address, and mailing address. On the form, the voter
13 shall also state under penalties of perjury that the voter
14 is qualified to vote in the election, that the voter has not
15 previously voted and will not vote again in the election,
16 that the voter has personally marked the voter's ballot in
17 secret or supervised the marking of the voter's ballot if
18 the voter is unable to mark it, that the ballot has been
19 placed in the ballot envelope and sealed by the voter or
20 under the voter's supervision if the voter is unable to seal

21 it, and that all information contained in the statement is
 22 true. In addition, any person providing assistance to the
 23 absentee voter shall include a statement on the envelope
 24 identifying the person providing assistance under penalties
 25 of perjury. Persons authorized to vote only for federal and
 26 statewide officers shall also state their former Missouri
 27 residence.

217 vote, shall not be required to obtain a notary seal or

219 [8.] 7. Notwithstanding any other provision of this
220 section or section 115.291 to the contrary, the
221 subscription, signature and seal of a notary or other
222 officer authorized to administer oaths shall not be required
223 on any ballot, ballot envelope, or statement required by
224 this section if the [reason for the] voter voting absentee
225 is [due to the reasons established pursuant to subdivision
226 (2) or (7) of subsection 1 of section 115.277] **incapacitated**
227 **or confined due to illness or physical disability, including**
228 **a person who is primarily responsible for the physical care**
229 **of a person who is incapacitated or confined due to illness**
230 **or physical disability.**

231 [9.] 8. No notary shall charge or collect a fee for
232 notarizing the signature on any absentee ballot or absentee
233 voter registration.

234 [10.] 9. A notary public who charges more than the
235 maximum fee specified or who charges or collects a fee for
236 notarizing the signature on any absentee ballot or absentee
237 voter registration is guilty of official misconduct.

115.291. 1. Upon receiving an absentee ballot by
2 mail, the voter shall mark the ballot in secret, place the
3 ballot in the ballot envelope, seal the envelope and fill
4 out the statement on the ballot envelope. The affidavit of
5 each person voting an absentee ballot shall be subscribed
6 and sworn to before the election official receiving the
7 ballot, a notary public or other officer authorized by law
8 to administer oaths, unless the voter is voting absentee due
9 to incapacity or confinement due to the provisions of
10 section 115.284, illness or physical disability, [for an
11 election that occurs during the year 2020, the voter has
12 contracted or is in an at-risk category for contracting or
13 transmitting severe acute respiratory syndrome coronavirus

14 2, as defined in section 115.277,] or the voter is a covered
15 voter as defined in section 115.902. If the voter is blind,
16 unable to read or write the English language, or physically
17 incapable of voting the ballot, the voter may be assisted by
18 a person of the voter's own choosing. Any person assisting
19 a voter who is not entitled to such assistance, and any
20 person who assists a voter and in any manner coerces or
21 initiates a request or a suggestion that the voter vote for
22 or against or refrain from voting on any question, ticket or
23 candidate, shall be guilty of a class one election offense.
24 If, upon counting, challenge or election contest, it is
25 ascertained that any absentee ballot was voted with unlawful
26 assistance, the ballot shall be rejected. [For purposes of
27 this subsection, the voters who are in an at-risk category
28 for contracting or transmitting severe acute respiratory
29 syndrome coronavirus 2 are voters who:

- 30 (1) Sixty-five years of age or older;
- 31 (2) Live in a long-term care facility licensed under
32 chapter 198;
- 33 (3) Have chronic lung disease or moderate to severe
34 asthma;
- 35 (4) Have serious heart conditions;
- 36 (5) Are immunocompromised;
- 37 (6) Have diabetes;
- 38 (7) Have chronic kidney disease and are undergoing
39 dialysis; or
- 40 (8) Have liver disease.]

41 2. Except as provided in subsection 4 of this section,
42 each absentee ballot that is not cast by the voter in person
43 in the office of the election authority shall be returned to
44 the election authority in the ballot envelope and shall only
45 be returned by the voter in person, or in person by a

46 relative of the voter who is within the second degree of
47 consanguinity or affinity, by mail or registered carrier or
48 by a team of deputy election authorities; except that
49 covered voters, when sent from a location determined by the
50 secretary of state to be inaccessible on election day, shall
51 be allowed to return their absentee ballots cast by use of
52 facsimile transmission or under a program approved by the
53 Department of Defense for electronic transmission of
54 election materials.

55 3. In cases of an emergency declared by the President
56 of the United States or the governor of this state where the
57 conduct of an election may be affected, the secretary of
58 state may provide for the delivery and return of absentee
59 ballots by use of a facsimile transmission device or
60 system. Any rule promulgated pursuant to this subsection
61 shall apply to a class or classes of voters as provided for
62 by the secretary of state.

63 4. No election authority shall refuse to accept and
64 process any otherwise valid marked absentee ballot submitted
65 in any manner by a covered voter solely on the basis of
66 restrictions on envelope type.
