Amend SS/SCS/House Bill No. 1878, Page 32, Section 115.277, Lines 1-10,

2 by striking all of said lines and inserting in lieu thereof
3 the following:

4 "115.277. 1. (1) Beginning on the sixth Tuesday
5 prior to an election and ending at 5:00 p.m. on the fourth
6 Monday prior to an election, a registered voter of this
7 state may cast an absentee ballot in person at the office of
8 the election authority for all candidates and issues for
9 which such voter is eligible to vote at the polling place if
10 such voter expects to be prevented from going to the polls
11 to vote on election day due to one of the reasons listed in
12 subsection 3 of this section.

13 (2) Beginning on the fourth Tuesday prior to an
14 election, a registered voter of this state may cast an
15 absentee ballot in person at the office of the election
16 authority and, the provisions of section 115.287 to the
17 contrary notwithstanding, at no more than four additional
18 locations designated by the election authority for all
19 candidates and issues for which such voter is eligible to
20 vote at the polling place without having to state a reason.

21 (3) Any registered voter casting a ballot under the
22 provisions of this subsection shall provide a form of
23 personal photo identification that is consistent with
24 subsection 1 of section 115.427." ; and

25 Further amend line 13, by inserting after "ballot" the
 26 following: "not in person at a location designated by the
 27 election authority"; and

28 Further amend said bill, section 115.283, page 41,
 29 lines 26-27, by striking said lines and inserting in lieu
 30 thereof the following:

31 "2. The statement for persons who are registered
 32 voters and are voting absentee ballots [who are registered
 33 voters] pursuant to subdivision (1) of subsection 1 of
 34 section 115.277 or subsection 2 of section 115.277 shall be
 35 in substantially the"; and

36 Further amend said bill and section, page 43, line 87,
 37 by inserting after "3." the following: "The statement for
 38 persons who are registered voters and are voting absentee
 39 ballots pursuant to subdivision (2) of subsection 1 of
 40 section 115.277 shall be in substantially the following form:
