HOUSE BILL NO. 1738

AN ACT

To repeal sections 9.010, 9.339, 10.095, 227.785, and 227.787, RSMo, and to enact in lieu thereof fifty-one new sections relating to state designations.

Be it enacted by the General Assembly of the State of Missouri, as follows:

Section A. Sections 9.010, 9.339, 10.095, 227.785, and 227.787, RSMo, are repealed and fifty-one new sections enacted 2 3 in lieu thereof, to be known as sections 9.010, 9.170, 9.235, 9.236, 9.275, 9.288, 9.289, 9.307, 9.308, 9.317, 9.339, 9.343, 4 5 9.344, 9.345, 9.346, 9.347, 9.348, 9.349, 9.350, 9.351, 9.352, 9.357, 9.362, 10.095, 10.245, 227.475, 227.774, 227.775, 6 227.785, 227.787, 227.796, 227.807, 227.808, 227.809, 227.810, 7 8 227.811, 227.812, 227.813, 227.814, 227.815, 227.816, 227.817, 9 311.028, 1, 2, 3, 4, 5, 6, 7, and 8, to read as follows:

9.010. The first day of January, the third Monday of January, the twelfth day of February, the third Monday in 2 February, the eighth day of May, the last Monday in May, the 3 nineteenth day of June, the fourth day of July, the first 4 Monday in September, the second Monday in October, the 5 6 eleventh day of November, the fourth Thursday in November, 7 and the twenty-fifth of December, are declared and 8 established public holidays; and when any of such holidays 9 falls upon Sunday, the Monday next following shall be 10 considered the holiday. There shall be no holiday for state 11 employees on the fourth Monday of October.

9.170. The third week of September shall be known as2 "Historically Black College and University Week" in

3	Missouri. The citizens of this state are encouraged to
4	observe the week with appropriate events and activities
5	recognizing the importance of historically black colleges
6	and universities, especially Lincoln University and Harris-
7	Stowe State University, the two historically black colleges
8	and universities located in Missouri.
	9.235. The second Wednesday in May shall be designated
2	as "Celiac Awareness Day". The citizens of this state are
3	encouraged to participate in appropriate events and
4	activities that increase awareness of celiac disease.
	9.236. The third full week in September of each year
2	shall be known and designated as "Sickle Cell Awareness
3	Week". Sickle cell disease is a genetic disease in which a
4	person's body produces abnormally shaped red blood cells
5	that resemble a crescent and that do not last as long as
6	normal round red blood cells, which leads to anemia. It is
7	recommended to the people of the state that the week be
8	appropriately observed through activities that will increase
9	awareness of sickle cell disease and efforts to improve
10	treatment options for patients.
	9.275. The month of June is hereby designated as
2	"Myasthenia Gravis Awareness Month" in Missouri. The
3	citizens of this state are encouraged to celebrate the month
4	with events and activities to raise awareness about this
5	treatable, but progressive and difficult to diagnose,
6	disease.
	9.288. April eighteenth of each year shall be known
2	and designated as "Hypoplastic Left Heart Syndrome Awareness
3	Day". Hypoplastic left heart syndrome is a critical
4	congenital heart defect that forms during the pregnancy when
5	portions of the left side of the baby's heart remain
6	underdeveloped or too small. It is recommended to the
7	people of this state that the day be appropriately observed

8	through activities that will increase awareness of
9	hypoplastic left heart syndrome.
	9.289. 1. The first full week in May each year shall
2	be known and designated as "Tardive Dyskinesia Awareness
3	Week". Tardive dyskinesia is a movement disorder that is
4	characterized by random, involuntary, and uncontrolled
5	movements of different muscles in the face, trunk, and
6	extremities. The citizens of this state are encouraged to
7	observe the week with appropriate events and activities to
8	raise awareness of tardive dyskinesia.
9	2. The provisions of this section shall expire on
10	<u>August 28, 2026.</u>
	9.307. July twentieth of each year shall be designated
2	as "Farmers and Ranchers Day" in Missouri. Citizens of this
3	state are encouraged to participate in appropriate events
4	and activities to recognize the positive impact farming and
5	ranching families have on this state.
	9.308. The first full week in February is hereby
2	designated as "School Counseling Week" in the state of
3	Missouri. Citizens of this state are encouraged to
4	participate in appropriate events and activities that
5	recognize the important work of school counselors in helping
6	Missouri's students succeed in school and beyond.
	9.317. The third full week of March each year shall be
2	known as "Victims of Coronavirus Memorial Week" in
3	Missouri. The citizens of this state are encouraged to
4	participate in appropriate events and activities to
5	acknowledge our collective losses during the COVID-19
6	pandemic by honoring the sacrifices of our first responders,
7	those who died, those who lost loved ones, those who lost
8	employment or a business, and all who were negatively
9	impacted during the pandemic.

9.339. September [22, 2021,] twenty-second each year 2 is hereby designated as "Hazel Erby Day" in Missouri. 3 Citizens of this state are encouraged to participate in appropriate events and activities to recognize Hazel Erby's 4 lifelong dedication to public service and community 5 6 improvement. 9.343. May tenth of each year is hereby designated as "School Bus Drivers' Appreciation Day" in Missouri. 2 3 Citizens of this state are encouraged to recognize the day 4 with appropriate events and activities to express 5 appreciation for the dedicated bus drivers who transport 6 children to and from school safely. 9.344. September twenty-eighth is hereby designated as 2 "National Good Neighbor Day" and September twenty-eighth and 3 the six subsequent days are hereby designated as "Missouri 4 Good Neighbor Week" in Missouri. Citizens of this state are 5 encouraged to participate in appropriate events and 6 activities to establish connections with their neighbors. 7 Research shows that knowing one's neighbors reduces 8 loneliness, crime, and isolation and leads to safer and more 9 vibrant communities. Those who lived through the flood 10 survived and rebuilt after the flood waters receded. 9.345. The month of September each year is hereby 2 designated as "Polycystic Ovary Syndrome (PCOS) Awareness 3 Day" in Missouri. Citizens of this state are encouraged to 4 participate in appropriate events and activities to raise 5 awareness about PCOS, a common hormonal disorder that causes ovarian cysts, infertility, menstrual irregularity, and 6 7 obesity in women. 9.346. The month of July is hereby designated as 2 "Uterine Fibroid Awareness Month" in Missouri. Citizens of this state are encouraged to wear white on July first and 3 4 participate in appropriate events and activities to raise

5 awareness about uterine fibroids, benign tumors that grow in 6 the uterus and cause pain, heavy bleeding, and reproductive 7 problems. The month of October is hereby designated as 9.347. 2 "Substance Abuse Awareness and Prevention Month" in 3 Missouri. Citizens of this state are encouraged to 4 participate in appropriate events and activities to raise 5 awareness about the dangers of substance abuse and the need 6 to expand outreach and educational efforts. 9.348. September fifteenth each year is hereby 2 designated as "Caregiver Appreciation Day" in Missouri. 3 Citizens of this state are encouraged to participate in 4 appropriate events and activities to recognize the efforts of home health, hospice, and unpaid relative caregivers who 5 give care and dignity to the elderly and infirm. 6 9.349. September fifteenth to October fifteenth each 2 year shall be designated as "Hispanic Heritage Month" in 3 Missouri. Citizens of this state are encouraged to 4 participate in appropriate events and activities to 5 recognize the generations of Hispanic Americans who have positively influenced and enriched our state and society. 6 9.350. October first each year is hereby designated as 2 "Biliary Atresia Awareness Day" in Missouri, in memory of 3 Annistyn Kate Rackley. The citizens of this state are encouraged to participate in appropriate events and 4 5 activities to raise awareness about this rare congenital 6 liver disease that occurs when bile ducts do not develop 7 normally. 9.351. The sixteenth of April each year is hereby 2 designated as "Missouri Donate Life Day" in the state of Missouri. The citizens of this state are encouraged to 3 4 participate in appropriate activities and events to increase

5	public awareness of the need for organ donation and organ
6	donors.
	9.352. The month of May and May tenth of each year are
2	hereby designated as "Lupus Awareness Month" and "Lupus
3	Awareness Day" in Missouri. The citizens of this state are
4	encouraged to participate in appropriate events and
5	activities to raise awareness about the diagnosis and
6	treatment of lupus and the impact on the lives of
7	individuals living with lupus.
	9.357. The month of March is hereby designated as
2	"Triple Negative Breast Cancer Awareness Month" in
3	Missouri. Citizens of this state are encouraged to
4	participate in appropriate events and activities to improve
5	education and awareness in underserved communities who are
6	disproportionately impacted; ensure equitable access and
7	affordability of breast cancer screening, genetic
8	counseling, and diagnostic testing; and guarantee timely
9	patient access to clinically appropriate treatment options.
	9.362. June first of each year is hereby designated as
2	"Sexual Assault Prevention and Awareness Day" in Missouri.
3	The citizens of this state are encouraged to participate in
4	appropriate events and activities to raise awareness of the
5	many ways in which we can work together to put an end to the
6	crime of sexual assault.
	10.095. The [Hypsibema] <u>Parrosaurus</u> missouriensis
2	dinosaur is hereby selected for, and shall be known as, the
3	official dinosaur of the state of Missouri.
	10.245. Archery is selected for and shall be known as
2	the official state sport. Archery was revolutionized by
3	Missourian Holless Wilbur Allen in 1966 with his invention
4	of the compound bow. Participation in the sport can span all
5	ages, sizes, and abilities.

227.475. The portion of State Highway 17 from Broadway 2 Street continuing south to Dogwood Drive through the city of 3 Waynesville in Pulaski County shall be designated the "Chief of Police Ferman R Raines Memorial Highway". The department 4 5 of transportation shall erect and maintain appropriate signs 6 designating such highway, with the costs to be paid by 7 private donations. 227.774. The portion of State Highway 94 from State 2 Highway TT to State Highway F in St. Charles County shall be 3 designated as "George Washington Highway". The department of transportation shall erect and maintain appropriate signs 4 designating such highway, with the costs to be paid by 5 6 private donations. 227.775. The portion of State Highway F from State 2 Highway 94 continuing west to Femme Osage Creek Road in St. 3 Charles County shall be designated as "Daniel Boone 4 Highway". The department of transportation shall erect and 5 maintain appropriate signs designating such highway, with

6 the costs to be paid by private donations.

227.785. The bridge on State Highway 21 crossing over
the Current River in Ripley County shall be designated as
"<u>Ripley County</u> Veterans Memorial Bridge". The department of
transportation shall erect and maintain appropriate signs
designating such bridge, with the costs to be paid by
private donations.

227.787. The portion of Interstate 70 from Shreve Road continuing to Kingshighway Boulevard shall be designated as "Captain David Dorn Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such highway, with the costs to be paid by private donations.

227.796. The bridge on State Highway P crossing over2 Lindley Creek in Polk County shall be designated the "WWII

3	Henry Archie Black Memorial Bridge". The department of
4	transportation shall erect and maintain appropriate signs
5	designating such bridge, with the costs to be paid by
6	private donations.
	227.807. The bridge on U.S. Highway 54 crossing the
2	Missouri River at Jefferson City in Cole and Callaway
3	counties shall be designated the "Senator Roy Blunt
4	Bridge". The department of transportation shall erect and
5	maintain appropriate signs designating such bridge, with the
6	costs to be paid by private donations.
	227.808. The portion of Interstate 435 from the
2	Kansas/Missouri state line continuing to Holmes Road in
3	Jackson County shall be designated the "Police Officer
4	Richard C Fleming Memorial Highway". The department of
5	transportation shall erect and maintain appropriate signs
6	designating such highway, with the costs to be paid by
7	private donations.
	227.809. The portion of State Highway 171 from State
2	Highway Z continuing to State Highway 43 in Jasper County
3	shall be designated the "Atomic Veterans Memorial Highway".
4	The department of transportation shall erect and maintain
5	appropriate signs designating such highway, with the costs
6	to be paid by private donation.
	227.810. The portion of State Highway J from CST
2	Service Road continuing west to State Highway U in Pemiscot
3	County shall be designated the "Annistyn Kate Rackley
4	Memorial Highway". The department of transportation shall
5	erect and maintain appropriate signs designating such
6	highway, with the costs to be paid by private donations.
	227.811. The portion of State Highway 19 from Strube
2	Road continuing north to Kimmich Road in Montgomery County
3	shall be designated the "Russell Lee Burton Memorial
4	Highway". The department of transportation shall erect and

5 maintain appropriate signs designating such highway, with the costs to be paid by private donations. 6 227.812. The portion of State Highway P from State 2 Highway 30 continuing north to State Highway 366 in St. 3 Louis County shall be designated the "Firefighter Benjamin J 4 Polson Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such 5 6 highway, with the costs to be paid by private donations. 227.813. The portion of State Highway 291 from N.E. 2 Cookingham Drive continuing south to Kansas Street in Clay 3 County shall be designated the "Samuel C Houston Memorial 4 Highway". The department of transportation shall erect and 5 maintain appropriate signs designating such highway, with the costs to be paid by private donations. 6 227.814. The portion of U.S. 67 from Maple Street 2 continuing to Perrine Road through the city of Farmington in 3 St. Francois County shall be designated the "SP5 Billy J 4 Meador Memorial Highway". The department of transportation 5 shall erect and maintain appropriate signs designating such 6 highway, with the costs to be paid by private donations. 227.815. The portion of U.S. 67 from Perrine Road 2 continuing to Highway H through the city of Farmington in 3 St. Francois County shall be designated the "WO1 Reginald D 4 Cleve Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such 5 6 highway, with the costs to be paid by private donations. 227.816. The bridge on Interstate 44 crossing over 2 Hampton Avenue in St. Louis City shall be designated as 3 "Police Officer Tamarris Bohannon Memorial Bridge". The department of transportation shall erect and maintain 4 5 appropriate signs designating such bridge, with the costs to 6 be paid by private donations.

	227.817. The portion of U.S. Highway 169 from State
2	Highway VV continuing to State Highway DD in Clinton and
3	Clay Counties shall be designated the "Championship Way".
4	The department of transportation shall erect and maintain
5	appropriate signs designating such highway, with the costs
6	to be paid by private donations. This designation shall
7	expire on December 31, 2022.
	311.028. 1. (1) To qualify as "Ozark Highlands"
2	spirits, and to be labeled as such for sale in Missouri, a
3	product shall meet the following conditions:
4	(a) The product shall be mashed, fermented, distilled,
5	aged, and bottled in the Ozark Highlands region;
6	(b) The product shall be aged in barrels manufactured
7	from Missouri;
8	(c) The water source shall be untreated or natural
9	from natural springs or deep wells in the Ozark Highlands,
10	and without chlorination or added chemicals such as
11	fluoride; and
12	(d) The minimum age of a whiskey shall be four years.
13	(2) To qualify as "Ozark Highlands" spirits, and to be
14	labeled as such for sale in Missouri, an unaged product,
15	such as gin or vodka, shall meet the following conditions:
16	(a) The product shall be mashed, fermented, distilled,
17	and bottled in the Ozark Highlands region; and
18	(b) The water source shall be untreated or natural
19	from natural springs or deep wells in the Ozark Highlands,
20	and without chlorination or added chemicals such as fluoride.
21	2. To additionally qualify as "Single Malt", the final
22	product shall be distilled and bottled at a single
23	distillery.
24	3. The product shall be further certified, by seal or
25	other means, by the "Ozark Highland Distillers Guild" as a
26	qualifying "Ozark Highlands" product.

27	4. For the purposes of this section, the Missouri
28	department of natural resources shall produce, in
29	collaboration with the "Ozark Highland Distillers Guild",
30	and publish an official map of the "Ozark Highlands" region.
	Section 1. The newly constructed bridge on the CST
2	David Hoeckel Parkway that crosses over Interstate 70 in
3	Wentzville in St. Charles County shall be designated as
4	"Marine LCPL Jared Schmitz Memorial Bridge". The department
5	of transportation shall erect and maintain appropriate signs
6	designating such bridge, with the costs to be paid by
7	private donations.
	Section 2. The portion of State Highway 231 (Telegraph
2	Rd.) from PVT Tori Pines Drive continuing to Meadow Haven
3	Lane in St. Louis County shall be designated as "Mehlville
4	Fire Captain Chris Francis Memorial Highway". The
5	department of transportation shall erect and maintain
6	appropriate signs designating such highway, with the costs
7	to be paid by private donation.
	Section 3. The first week of February is hereby
2	designated as "National Girls and Women in Sports Day" in
3	Missouri. Citizens of this state are encouraged to
4	recognize the day with appropriate events and activities to
5	express appreciation for girls and women in sports.
	Section 4. May second of each year is hereby
2	designated as "Pinhook Remembrance Day" in Missouri.
3	Citizens of this state are encouraged to recognize the day
4	with appropriate events and activities to honor the
5	struggles and triumphs of the villagers of Pinhook, Missouri.
	Section 5. January fifteenth of every year is hereby
2	designated as "Alpha Kappa Alpha Sorority Day" in Missouri.
3	Founded on January 15, 1908, at the historically black
4	Howard University in Washington, D.C., Alpha Kappa Alpha is
5	the first intercollegiate historically African-American

6	sorority. Citizens of this state are encouraged to
7	participate in appropriate events and activities in
8	recognition of the contributions of Alpha Kappa Alpha.
	Section 6. February tenth of every year is hereby
2	designated as "Ethel Hedgeman Lyle Day" in Missouri. Born in
3	St. Louis, Missouri, Ethel Hedgeman Lyle founded Alpha Kappa
4	Alpha, the first intercollegiate historically African-
5	American sorority. Citizens of this state are encouraged to
6	participate in appropriate events and activities in
7	recognition of the contributions of Ethel Hedgeman Lyle.
	Section 7. April eleventh through April seventeenth of
2	each year is hereby designated as "Black Maternal Health
3	Week". The citizens of this state are encouraged to engage
4	in appropriate events and activities to commemorate black
5	maternal health.
	Section 8. The month of April of each year is hereby
2	designated as "Minority Health Month". The citizens of this
3	state are encouraged to engage in appropriate events and
4	activities to commemorate minority health month.
