13	business as (d/b/a) selected by the sports wagering operator
14	or, as applicable, the interactive sports wagering platform
15	operator. A sports wagering operator may operate the
16	interactive sports wagering platform or contract with an
17	interactive sports wagering platform operator to administer
18	the interactive sports wagering platform on the licensed
19	facility's behalf.
20	(2) Subject to the approval of the commission, a
21	licensed facility that is an excursion gambling boat may
22	offer sports wagering through an additional two individually

23 branded interactive sports wagering platforms under the brand, trade name, or another name it is doing business as 24 25 (d/b/a) selected by the sports wagering operator or, as applicable, the interactive sports wagering platform 26 operator, provided that such licensed facility shall pay to 27 the commission an annual administrative fee of one million 28 two hundred fifty thousand dollars for each additional 29 30 interactive sports wagering platform, with such administrative fee deposited in the gaming commission fund 31 32 established under section 313.835. A sports wagering operator may operate the interactive sports wagering 33 platform or contract with one or more interactive sports 34 35 wagering platform operators to administer the interactive sports wagering platforms on the licensed facility's behalf. 36 (3) Notwithstanding any provision of this section and 37 anything to the contrary set forth under sections 313.1000 38 through 313.1022, in no event shall sports wagering be 39 40 offered through more than six interactive sports wagering 41 platforms contracting with any one owner of a licensed 42 facility, directly or indirectly through any parent company, subsidiary, or affiliate of such owner."; and 43 Further amend said amendment, page 34, section 44 313.1021, lines 1086-1087, by striking "equal to the rate 45 imposed pursuant to section 313.822" and inserting in lieu 46 47 thereof the following: "of fifteen percent"; and 48 Further amend said amendment and section, page 35, line 1117, by inserting after "exceed" the following: "one 49 million two hundred"; and 50 Further amend said amendment and section, page 36, line 51 52 1133, by striking "hundred thousand" and inserting in lieu thereof the following: "million"; and further amend line 53 1136, by inserting at the end of said line the following: 54 55 "The amount required to be appropriated pursuant to this
